1. This Order may be cited as the Knitted Goods Order No. 2.

Knitted outerwear.

2. Paragraph 10(1) of the Knitted Goods Order is amended by omitting sub-paragraph (c).

Men's hosiery.

3. Paragraph 12 of the Knitted Goods Order is amended by inserting after the word "men" the words "other than football stockings or stockings of a similar kind which have been approved by the Controller in accordance with this Order".

Women's, maids' and children's hosiery.

4. Paragraph 13 of the Knitted Goods Order is amended by adding at the end thereof the words "other than circular stripes in the tops which have been approved by the Controller in accordance with this Order".

Headings or marginal notes.

5. The headings or marginal notes of paragraphs 14, 15 and 16 of the Knitted Goods Order are revoked and the following headings or marginal notes inserted in their stead respectively, namely: "Samples—fabrics", "Samples—knitted hosiery" and "Samples—knitted wear other than knitted

Samples—fabrics.

6. Paragraph 14 (2) of the Knitted Goods Order is amended by inserting after the words "knitted outerwear" wherever occurring the words "or knitted underwear".

Samples—knitted hosiery.

1. This Order may be cited as the Feminine Outerwear Order (No. 2).

General restrictions on manufacture of feminine outerwear.

- 2. Clause 7 of the Feminine Outerwear Order is amended-
 - (a) by omitting paragraph (i) of sub-clause (1.) and inserting in its stead the following paragraph:—
 - "(i) with buttons or buttonholes other than those required for the purpose of fastening:

 Provided that in the case of double-breasted garments one half of the number of buttons used need not be for the purpose of fastening;";
 - (b) by adding the following paragraph after paragraph
 (j) of sub-clause (1.):—

 "(k) with more than two fixed bows:"; and

 - (c) by omitting sub-clause (2.) and inserting in its stead the following sub-clause:—

 "(2.) A person shall not apply to any Feminine Outerwear intended for sale ornamental trimming not expressly provided for in this Order or any hand or machine embroidery of any description (including applique, beading, braiding, faggotting, quilting, embossing, lace trimming or fabric encrustations) or material bearing such trimming or embroidery except subject to the following conditions: conditions:-
 - (i) The total area of such trimming or embroidery shall not exceed 36 square inches; and
 - (ii) Not more than 12 square inches of such total area of 36 square inches of trim-ming or embroidery shall be done by hand."

Coats (other than Children's and Girls').

- 3. Clause 8 of the Feminine Outerwear Order is amended by omitting paragraph (f) and inserting in its stead the following paragraph:-
 - "(f) with more than six buttons or buttonholes."

Dresses (other than Children's or Girls').

- 4. Clause 9 of the Feminine Outerwear Order is amended by omitting paragraph (h) and inserting in its stead the following paragraphs:—
 - "(h) with any tucking or shirring except so much only as is necessary to shape the garment or pin-tucking not exceeding four yards in length in all; or
 - "(i) with more than two pleats in the bodice."

Dresses for Children and Girls.

5. Clause 12 of the Feminine Outerwear Order is amended by omitting paragraph (g) and inserting in its stead the following paragraph:-

(g) with any tucking except pin-tucking not exceeding 4 yards in length in all or with any pleating in the

Bananas.

N pursuance of the powers delegated to me by the Commonwealth Prices Commissioner pursuant to regulation 46 of the National Security (Prices) Regulations, I, Horace Eddy Bishop, Second Assistant Prices Commissioner, Prices Branch, Canberra, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 2147.

Revocation.

2. Prices Regulation Order No. 1980 as amended by Prices Regulation Order No. 2038 is hereby revoked.

Application.

3. Nothing in this Order shall apply to the sale of bananas in Western Australia.

Definitions.

- 4. In this Order, unless the contrary intention appears—
 "Cairns area" means all that area of Queensiand comprised within a radius of 3 miles from the principal post office at Cairns;
 - 'Metropolitan area of Adelaide" means all that area comprised within a radius of 15 miles from the General Post Office of Adelaide, South Australia;
 - "Metropolitan area of Brisbane" means all that area constituted under the name of "City of Brisbane" by the City of Brisbane Act 1924, of the State of Queensland;
 - "Metropolitan area of Melbourne" means all that area comprised within a radius of 20 miles from the General Post Office of Melbourne, Victoria;
 - "Metropolitan area of Sydney" means all that area comprised within a radius of 20 miles from the General Post Office of Sydney, New South Wales;
 - "prescribed area" means any area defined in this paragraph;
 - "Rockhampton area" means all that area of Queensland comprised with n a radius of 3 miles from the principal post office at Rockhampton;
 - secondary wholesaler" means, in relation to the sale of any bananas, any person who buys those bananas ripened for delivery outside the prescribed areas;
 - "Townsville area" means all that area of Queensland comprised within a radius of 3 miles from the principal post office at Townsville;
 "Newcastle area" means all that area of New South Wales comprised within a radius of 5 miles from the principal post office at Newcastle
 - principal post office at Newcastle.

Unripened bananas—Sales by wholesale.

- 5. I fix and declare the maximum prices at which unripened bananas of the varieties set out in the First Schedule to this Order may be sold by wholesale to be-
 - (a) where delivery is made in the prescribed areas therein specified—the prices specified in that Schedule;
 - (b) where delivery is made outside the prescribed areas—
 the maximum price fixed for the sale of those
 bananas in the nearest prescribed area less 10 per
 centum, less the usual cost of transport by rail
 from the grower's premises to the nearest prescribed

Ripened bananas-Sales by wholesale-Prescribed areas.

- 6. I fix and declare the maximum prices at which ripened banamas may be sold by wholesale for delivery in any prescribed area to be-
 - (a) the maximum price fixed by the provisions of sub-paragraph (a) of paragraph 5 for the sale of those bananas (when unripened) in that area or the price paid or payable for those bananas (when unripened), whichever is the lesser; and
 - (b) the margin specified in the Second Schedule to this

Ripened bananas—Sales by wholesale outside prescribed areas.

- 7. I fix and declare the maximum price at which ripened bananas may be sold by wholesale for delivery outside the prescribed areas to be-
 - (a) for sales by a secondary wholesaler—the sum of the following:
 - (i) the maximum price fixed by the provisions of paragraph 6 for the sale of ripened bananas by wholesale for delivery in the nearest prescribed area, or the price paid or payable by the secondary wholesaler for those bananas, whichever is the lesser; and
 - (ii) margin at the rate of 2s. per 1½ bushel case; and
 - (iii) cost of transport incurred and properly attributable to the transport of those bananas to the place of delivery by the secondary wholesaler;
 - (b) for sales by any person other than a secondary wholesaler-
 - (i) the price paid or payable by that person for those bananas;
 - (ii) cost of transport incurred and properly attributable to the transport of those bananas to the place of delivery by that

Provided that no amount shall be added for cost of transport under the provisions of this paragraph unless that amount is recorded on an invoice delivered by the seller.

Sales by retail.

- 8. I fix and declare the maximum price at which bananas may be sold by retail to be the sum of the following (computed to the nearest upward halfpenny):—
 - (a) the maximum price fixed by the foregoing provisions of this Order for the sale of those bananas to the retail seller, or the price paid or payable by that retail seller, whichever is the lesser;
 - (b) cost of transport actually incurred in and properly attributable to conveying those bananas from the place of delivery to the retail seller to that retail seller's premises;
 - (c) margins at the rate of-
 - (i) where those bananas were purchased on the stalk by the retail seller—2½d. per pound;
 - (ii) where not so purchased—2d, per pound:

Provided that no amount may be added under the provisions of this paragraph for cost of transport unless that amount is properly recorded on an invoice delivered to the retail seller.

Retail ceiling.

9. Notwithstanding the foregoing provisions of this Order, I fix and declare the maximum price at which banamas of the varieties set out in the Third Schedule to this Order may be sold by retail to be the price spec fied in that Schedule or the maximum price fixed by the foregoing provisions of this Order for that sale, whichever is the lesser.

General.

- 10. Notwithstanding the foregoing provisions of this Order if any bananas are sold in a case, the maximum price fixed by such foregoing provisions for the sale of those bananas shall be the maximum price for the sale of those bananas together with the case.
- 11. Notw thstanding the foregoing provisions of this Order where any bananas are sold by wholesale on the stalk, the weight of the stalk shall be included in computing the weight of those bananas:

Provided that where the stalk extends more than 6 inches from the first hand of the bananas the maximum prices fixed by such foregoing provisions shall be reduced in each case by 10 per centum thereof.

Notices in writing.

12. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any bananas specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.

Prices Regulation Order No. 2148.

Apples.

IN pursuance of the powers delegated to me by the Commonwealth Prices Commissioner, pursuant to regulation at of the National Security (Prices) Regulations, I, Horace Eddy Bishop, Second Assistant Prices Commissioner, Prices Branch, Canberra, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 2148.

Revocations.

2. Prices Regulation Order No. 1609 as amended by Prices Regulation Orders Nos. 1652, 1689, 1734 and 1787 is hereby revoked.

Definitions.

- In this Order, unless the contrary intention appears— "bushel" means, in relation to any sale of apples, any case or similar container containing not less than 40 pounds of apples;
- "cost into store" means-
 - (a) in relation to any sale of apples by retail other than in the Far Northern area, the Northern area, or the Central area as defined in this paragraph, the sum of the following:—
 - (i) for bushel lots—the purchase price paid or payable by the retail seller for those apples, or the maximum price fixed for the sale of those apples to him, whichever is the lesser, or

(ii) for cases containing less than one bushel—such price as bears the same ratio to the maximum price fixed for the sale of a bushel of those apples to the retail seller as the weight of the apples actually purchased bears to 40 pounds,

plus, in each case, cost of transport actually incurred by the retail seller in conveying the apples to his store; or

- (b) in relation to any sale of apples by retail in the Far Northern area, the Northern area or the Central area—an amount computed in accordance with sub-paragraph (a) of this definition plus the following:—
 - (i) in the case of sales in the Far Northern area—an amount calculated at 1s. 6d. per bushel;
 - (ii) in the case of sales in the Northern area—an amount calculated at 1s. per bushel; or
 - (iii) in the case of sales in the Central area—an amount calculated at 6d. per bushel:

Provided that no amount shall be added under the provisions of this paragraph unless such amount is properly recorded on an invoice delivered in relation to those

- "the metropolitan area of Adelaide" means all that area comprised within a radius of fifteen miles from the General Post Office, Adelaide;
- "the metropolitan area of Brisbane" means all that area constituted under the name of the "City of Brisbane" by the City of Brisbane Act of 1924 in the State of Queensland;
- "the metropolitan area of Hobart" means all that area comprised within a radius of five miles from the General Post Office, Hobart;
- "the metropolitan area of Perth" means all that area comprised within a radius of twelve miles from the General Post Office, Perth;
- "the metropolitan area of Melbourne" means all that area comprised within a radius of twenty miles from the General Post Office, Melbourne;
- "the metropolitan area of Sydney" means all that area comprised within a radius of twenty miles from the General Post Office, Sydney;
- "metropolitan area" means any of the metropolitan areas defined in this paragraph;
- "Far Northern area" means all that area of Queensland north of the parallel of latitude of 18° south;
 "Northern area" means all that area of Queensland north of the parallel of latitude 21° south, and south of the parallel of latitude 18° south;
- "Central area" means all that area of Queensland north of the parallel of latitude 24° south, and south of the parallel of latitude 21° south.

Sales by growers.

- 4. I fix and declare the maximum prices at which apples may be sold by a grower delivered to a metropolitan area to be the prices specified in the First Schedule to this Order.
- 5. I fix and declare the maximum prices at which apples may be sold by a grower where delivered outside the metropolitan areas to be
 - (a) delivered at the grower's premises—the prices specified in paragraph 4 of this Order for deliveries in the metropolitan area most accessible by rail to such premises, less cost of transport by rail, or if such transport is not available, then of any alternative transport from those premises to that metropolitan area; or
 - (b) delivered at any place other than the grower's premises—the price specified in sub-paragraph (a), plus cost of transport actually incurred and properly attributable to the conveying of those apples from the grower's premises to the place of delivery. delivery:

Provided that no amount shall be added for cost of transport in any price calculated under the provisions of this paragraph unless such amount is properly recorded by the grower on an invoice delivered in relation thereto.

Sales by wholesale other than by growers-Bushel lots.

- 6.-(1.) I fix and declare the maximum price at which apples may be sold by wholesale, other than by a grower, to be the sum of the following:—
 - (a) the price paid or payable for such apples by the wholesale seller or the maximum price fixed by paragraph 4 or 5 of this Order for the sale of those apples to the wholesale seller, whichever is
 - (b) cost of transport actually incurred and properly attributable to the conveying of those apples from the point of delivery by such wholesale seller to the point of delivery by such wholesale seller, and point of delivery by such wholesale seller; and
 - (c) margin at the rate of-
 - (i) if sold in original cases—ls. per bushel; or
 - (ii) if unpacked from original cases and re-packed—ls. 6d. per bushel:

Provided that for deliveries to a purchaser in any metro-politan area such maximum prices shall be subject to an upper limit as specified in the Second Schedule to this Order.

(2.) No amount shall be added for cost of transport in any price calculated under the provisions of this paragraph unless such amount is clearly recorded by such wholesale

Sales by grower or wholesaler—Cases containing less than one bushel.

7. Notwithstanding the foregoing provisions of this Order I fix and declare the maximum price at which apples may be sold by a grower or by wholesale in cases containing less than one bushel to be that price which bears the same ratio to the one bushel to be that price which hears the same ratio to the maximum price fixed for the sale of those apples by the bushel, as the weight of the apples actually sold hears to 40 pounds. Provided that, in the case of any such sale, the weight of the apples contained in the case shall be deemed to be 40 pounds, unless an invoice is delivered in relation to those apples and the weight of such apples is separately stated thereon, in which case the weight shall be deemed to be the weight so stated.

Sales by retail.

8.—(1.) I fix and declare the maximum price at which apples may be sold by retail in quantities less than a half-bushel to be the price specified in the Third Schedule to this Order according to the cost into store of the seller by retail of such apples set out in that Schedule.

(2.) I fix and declare the maximum and the seller by retail of such apples set out in that Schedule.

(2.) I fix and declare the maximum price at which apples may be sold by retail in quantities of half-bushel or more to be the cost into store of the seller by retail plus a margin at the rate of 5s. per bushel.

Retail ceiling-Metropolitan areas.

9. Notwithstanding the foregoing provisions of this Order I fix and declare the maximum price at which apples may be sold by retail in the metropolitan areas to be that specified in the Second Schedule to this Order, or if any other lower maximum price is fixed by the provisions of paragraph 8 of this Order, then such lower maximum price.

Fixation of maximum prices by notice.

10. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which apples specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

NATIONAL SECURITY (PRICES) REGULATIONS. PRICES REGULATION ORDER No. 2149.

IN pursuance of the powers delegated to me by the Commonwealth Prices Commissioner pursuant to regulation 46 of the National Security (Prices) Regulations, I, Horace Eddy Bishop, Second Assistant Prices Commissioner, Prices Branch. Canberra, hereby make the following Order:-

Citation.

1. This Order may be cited as Prices Regulation Order No. 2149.

Revocations.

2. Prices Regulation Order No. 1610, as amended by Prices Regulation Orders Nos. 1653, 1690, 1735 and 1788 is hereby revoked.

Definitions.

- 3. In this Order, unless the contrary intention appears—"Cost into store" means—
 - (a) in relation to any sale of pears by retail other than in the Far Northern area, the Northern area or the Central areas as defined in this paragraph—the purchase price paid or payable by the retail seller for those pears, or the maximum price fixed for the sale of those pears to him, whichever is the lesser; or
 - (b) in relation to any sale of pears by retail in the Far Northern area, the Northern area or the Central area—the amount computed in accordance with sub-paragraph (a) plus the following:—
 - (i) in the case of sales in the Far Northern area—an amount calculated at the rate of 1s. 6d. per bushel:

- (ii) in the case of sales in the Northern area—an amount calculated at the rate of 1s. per bushel;
- (iii) in the case of sales in the Central area—an amount calculated at the rate of 6d. per bushel,

plus, in each case, the cost of transport actually incurred by the retail seller in conveying those pears to his store, and properly recorded on an invoice delivered in relation thereto;

"the metropolitan area of Adelaide" means all that area comprised within a radius of fifteen miles from the

General Post Office, Adelaide; "the metropolitan area of Brisbane" means all that area constituted under the name of the "City of Brisbane" by the City of Brisbane Act of 1924 in the State of Queensland;

"the metropolitan area of Hobart" means all that area

comprised within a radius of five miles from the General Post Office, Hobart;
"the metropolitan area of Melbourne" means all that area comprised within a radius of twenty miles from

area comprised within a radius of twenty miles from the General Post Office, Melbourne;

"the metropolitan area of Perth" means all that area comprised within a radius of twelve miles from the General Post Office, Perth;

"the metropolitan area of Sydney" means all that area comprised within a radius of twenty miles from the General Post Office, Sydney;

"Metropolitan area" means any of the metropolitan areas defined in this paragraph;

"Far Northern area" means all that area of Queensland north of the parallel of latitude of 18° south;

"Northern area" means all that area of Queensland north of the parallel of latitude 21° south, and south of the parallel of latitude 24° south, and south of the parallel of latitude 24° south, and south of the parallel of latitude 24° south, and south of the parallel of latitude 24° south, and south of the parallel of latitude 21° south.

Sales by growers.

4. I fix and declare the maximum prices at which pears may be sold by a grower delivered to a metropolitan area to be the prices specified in the First Schedule to this Order.

5. I fix and declare the maximum price at which pears may be sold by a grower where delivered outside the metropolitan areas to have

areas to be

- (a) delivered at the grower's premises—the price specified in paragraph 4 of this Order for deliveries
 in the metropolitan area most accessible by rail
 to such premises less cost of transport by rail,
 or if such transport is not available, then of any
 alternative transport from those premises to that metropolitan area; or
- (b) delivered at any place other than the grower's premises—the price specified in sub-paragraph (a) plus cost of transport actually incurred and properly attributable to the conveying of those pears from the grower's premises to the place of delivery. delivery:

Provided that no amount shall be added for cost of transport in any price calculated under the provisions of this paragraph unless such amount is properly recorded by the grower on an invoice delivered in relation thereto.

Sales by wholesale.

- 6.—(1.) I fix and declare the maximum price at which pears may be sold by wholesale, other than by a grower, to be the sum of the following:—
 - (a) the price paid or payable for such pears by the wholesale seller or the maximum price fixed by paragraph 4 or 5 of this Order for the sale of those pears by the grower to the wholesale seller, whichever is the lesser;
 - (b) cost of transport actually incurred and properly attributable to the conveying of those pears from the point of delivery to the wholesale seller to the point of delivery by such wholesale seller; and
 - (c) margin at the rate of-
 - (i) if sold in original case—1s. per bushel case;
 - or
 (ii) if unpacked from original cases and repacked—1s. 6d. per bushel case:

Provided that for deliveries to a purchaser in any metropolitan area, such maximum price shall be subject to an upper limit as specified in the Second Schedule to this Order.

(2.) No amount shall be added for cost of transport in any price calculated under the foregoing provisions of this paragraph unless such amount is clearly recorded on an invoice delivered by such wholesale seller.

Pears transported in ice trucks.

7. Notwithstanding the provisions of paragraphs 4, 5 or 6 of this Order, I fix and declare the maximum price at which pears may be sold by a grower or by wholesale where such pears are transported to the metropolitan area of Brisbane in ice trucks to be the maximum price fixed by the provisions of this Order for the sale of those pears by a grower or by wholesale, as the case may be, plus an amount calculated at the rate of 1s. per bushel.

Sales by retail.

8.—(1.) I fix and declare the maximum price at which pears may be sold by retail in quantities less than a half bushel to be the price specified in the second column of the Third Schedule to this Order according to the cost into store of the seller by retail of such pears set out in the first column of that Schedule.

(2.) I fix and declare the maximum price at which pears may be sold by retail in quantities of half bushel or more to be the cost into store of the seller by retail plus a margin at the rate of 5s. per bushel.

Retail ceiling metropolitan areas.

9. Notwithstanding the foregoing provisions of this Order, I fix and declare the maximum price at which pears may be sold by retail in the metropolitan areas to be that specified in the Second Schedule to this Order, or if any lower maximum price is fixed by the provisions of paragraph 8 of this Order, then such lower maximum price.

Fixation of maximum prices by notice.

10. Notwithstanding the foregoing provisions of this Order I declare the maximum price at which pears specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.
