PRICES REGULATION ORDER No. 2246. Smallgoods-New South Wales.

In pursuance of the powers conferred upon me by National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Assistant Prices Commissioner, hereby make the following Order:—

Citation. 1. This Order may be cited as Prices Regulation Order No. 2246.

Definition.

2. In this Order-

"Sydney metropolitan area" means all that area of New South Wales comprised within a radius of 20 miles from the General Post Office, Sydney.

Maximum prices.

- 3. I fix and declare the maximum price at which any of the goods specified in the Schedule to this Order may be sold in New South Wales to be—
 - (a) in respect of sales by the manufacturer-
 - (i) for sales to a retailer—the price specified in the said Schedule; or

(ii) for sales to a wholesaler—the price specified in the said Schedule, less ten per centum thereof,

delivered free on rail or free on board Sydney metropolitan area, or where the purchaser's premises are situated within the Sydney metropolitan area, delivered free to those premises;

(b) in respect of sales by a wholesaler-

(i) where delivery is made in the Sydney metro politan area—the price specified in the said Schedule; or

said schedule; or

(ii) where delivery is made outside the Sydney metropolitan area—the price so specified plus any cost of transport into his premises, which is properly recorded on an invoice delivered in relation to those goods; or

(c) in respect of sales by retail-

(i) for sales in the Sydney metropolitan area— the price specified in the said Schedule; or

(ii) for sales outside the Sydney metropolitan area—the price so specified plus any cost of transport into his store, which is properly recorded on an invoice delivered in relation to those goods.

Exhibition of price list.

4. Every person who sells or has for sale by retail any of the goods specified in the Schedule to this Order shall exhibit in a prominent position in his place of business, or if he has more than one place of business, in each of his places of business, a notice or notices setting forth his selling prices of such goods in a form approved by the Commissioner. Any such notice shall be deemed to be in an approved form if it is otherwise in compliance with regulation 45 of the National Security (Prices) Regulations Security (Prices) Regulations.

Variation of maximum prices by notice.

5. Notwithstanding the foregoing provisions of this Order I declare the maximum price at which any of the goods specified in the Schedule to this Order and which are specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

Tomatoes-New South Wales.

IN pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Assistant Prices Commissioner, hereby make the following Order:—

${\it Citation.}$

1. This Order may be cited as Prices Regulation Order No. 2248.

Revocation.

2. Prices Regulation Order No. 1229 as amended by Prices Regulation Orders 1232, 1302, 1341, 1369, 1527, 1635, 1820, 1889, 1954 and 2096 is hereby revoked.

Definitions.

- In this Order, unless the contrary intention appears— "Sydney metropolitan area" means all that area of New South Wales comprised within a radius of 20 miles from the General Post Office, Sydney;
 - "No. 1 grade" means, in relation to the sale of any tomatoes, that such tomatoes have been passed by an Inspector of the Department of Agriculture as No. 1 grade tomatoes;
 - "No. 2 grade" means, in relation to the sale of any tomatoes, that such tomatoes have been passed by an Inspector of the Department of Agriculture as No. 2 grade tomatoes,

Sales by growers.

4. I fix and declare the maximum price at which tomatoes may be sold in New South Wales by a grower to be—

(a) where delivery is made in the Sydney metropolitan

area—11d. per pound; or
(b) where delivery is made outside the Sydney metropolitan area

(i) for delivery at the grower's premises-11d. per pound, less cost of transport by rail, or if such transport is not available, by any alternative transport, from those pre-

any alternative transport, from those premises to the Sydney metropolitan area; or (ii) for delivery at any place other than the grower's premises—the price specified in (i) of this sub-paragraph, plus cost of transport actually incurred in conveying the tomatoes from the grower's premises to the place of delivery.

Provided that no amount may be added for cost of transport under the provisions of this paragraph unless such amount is properly recorded by the grower.

Sales by wholesale other than by growers.

5. I fix and declare the maximum price at which tomatoes may be sold in New South Wales by wholesale other than by a grower to be the sum of the following:—

- (a) the price paid or payable for such tomatoes by the wholesale seller, or the maximum price fixed in accordance with paragraph 4 of this Order for the sale of those tomatoes by the grower, whichever is
- (b) cost of transport actually incurred in and properly attributable to the conveying of those tomatoes from the point of delivery to the wholesale seller to the point of delivery by him; and
- (c) margin at the rate of-

(i) if sold in original cases ½d. per pound; or
 (ii) if unpacked from original cases and repacked—1¾d. per pound.

Provided that no amount may be added for cost of transport under the provisions of this paragraph unless such amount is properly recorded by such wholesale seller.

6. Notwithstanding the provisions of paragraph 5 of this Order I fix and declare the maximum price at which tomatoes may be sold by wholesale, other than by growers, delivered to any place in the Sydney metropolitan area to be 11d.

per pound or if any lower maximum wholesale price is fixed by paragraph 5 of this Order, then such lower maximum price.

Sales by retail.

7. I fix and declare the maximum price at which tomatoes may be sold by retail in New South Wales to be the sum of the following:-

- (a) the maximum price fixed in accordance with the foregoing provisions of this Order for the sale of those tomatoes to the retail seller, or the price paid or payable by that retail seller for those tomatoes, whichever is the lesser;
- (b) cost of transport actually incurred in and properly attributable to the conveying of those tomatoes into the retail seller's store; and
- (c) margin at the rate of 3d. per pound.

Provided that no amount may be added for cost of transport under the provisions of this paragraph unless such amount is properly recorded by the retail seller.

8. Notwithstanding the provisions of paragraph 7 of this Order, I fix and declare the maximum price at which tomatoes may be sold by retail in the Sydney metropolitan area to be is. 2d. per pound, or if any lower maximum retail price is fixed by the provisions of paragraph 7 of this Order, then such lower maximum price.

Sales to processors.

- 9. Notwithstanding the foregoing provisions of this Order, I fix and declare the maximum price at which tomatoes may be sold by any person whose premises are situated in New South Wales to a processor to be—
 - (a) for sales of No. 1 Grade tomatoes—£16 per ton.
 (b) for sales of No. 2 Grade tomatoes—£8 per ton.
 (c) for sales of all other tomatoes—£6 per ton.

Variation of maximum prices by notice

10. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which tomatoes specified in a notice in pursuance of this paragraph may be sold in New South Wales by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.
