National Security (Timber Control) Regulations I. Stephen Lackey Kessell, the Controller of Timber of the Department of Munitions, hereby revoke the Control of Timber Order (No. 2) made by me on the twenty-third day of March, One thousand nine hundred and forty-two and published in the Commonwealth Gazette on the first day of April, One thousand nine hundred and forty-two.

NATIONAL SECURITY (TIMBER CONTROL) REGULATIONS.

TIMBER (REVOCATION AND AMENDMENT) ORDER (No. 1). STEPHEN LACKEY KESSELL, the Controller of Timber of the Department of Munitions, in pursuance of the National Security (Timber Control) Regulations hereby make the following Order:—

Citation.

1. This Order may be cited as the Timber (Revocation and Amendment) Order (No. 1).

Revocation.

2. Paragraphs 3 and 4 of the Control of Timber Order (No. 11) are revoked.

Amendment.

3. The Control of Timber Order (No. 11) is amended by omitting paragraphs 5 and 6 and substituting the following paragraphs 5 and 6 in their stead:—

" Priority.

5. A person who is served with a requirement to supply imber under the National Security (Timber Control) Regulations shall cut, supply and deliver that timber in accordance with the order of priority specified in the requirement and before any order which has not been endorsed by a delegate of the Controller of Timber with an indication that the order is to be executed in a certain order of priority.

Returns to be Furnished.

- 6. A sawmiller carrying on business in the State of New South Wales with any sawmill having a production capacity exceeding fifteen thousand (15,000) super. feet of sawn timber per month shall in respect of each such sawmill forward to the Deputy Controller of Timber in that State within three (3) days after the expiration of each calendar month a return setting out in respect of the previous calendar month. month
 - (a) the quantity in super, feet of sawn timber of the classes enumerated hereunder produced by him in each such sawmill-

(i) Hardwood boards suitable for flooring.
(ii) Hardwood building scantlings.
(iii) Hardwood sawn sleepers.
(iv) Hardwood in all other specifications but excluding hardwood case timber.
(v) Cypress pine in boards suitable for flooring or as dressed flooring.
(vi) Cypress pine building scantlings

(vi) Cypress pine huilding scantlings.
(vii) Case timbers—

(a) Hardwood. (b) Scrubwoods. (c) Pinus.

(viii) Coachwood.

(ix) Hoop pine.
(x) Scrubwoods other than for cases.

(h) The total quantity of each class of sawn timber enumerated in sub-paragraph (a) of this paragraph delivered by him from each such sawmilt together with the names and addresses of all persons or authorities to whom delivery has been made by him of two thousand five hundred (2,500) super, feet or more of any sawn timber within the classes enumerated as aforesaid."

4. This Order shall take effect on and from the first day of September, One thousand nine hundred and forty-five. Dated this thirtieth day of August, 1945.
