NATIONAL SECURITY (SHIPPING CO-ORDINATION) REGULATIONS.

SHIRTS, COLLARS AND PYJAMAS ORDER.

IN pursuance of regulation 59 of the National Security (General) Regulations, I, William Patrick Ashley, Minister of State for Supply and Shipping hereby make the following Order:-

Citation.

1. This Order may be cited as the Shirts, Collars and Pyjamas Order (No. 2).

Definitions.

- 2. Paragraph 5 of the Shirts, Collars and Pyjamas Order is amended by omitting clauses (ii) and (iii) of subparagraph (1).
- Exceptions. 3. Paragraph 6 of the Shirts, Collars and Pyjamas Order is amended by omitting the words "and pyjamas" in subparagraph (2).

Styles of shirts for men or boys.

4. Paragraph 7 of the Shirts, Collars and Pyjamas Order is amended by omitting clauses (e), (f) and (k).

Styles of men's or boys' pyjamas.

5. Paragraph 8 of the Shirts, Collars and Pyjamas Order is amended by omitting clause (k).

Styles of men's or boys' collars.

6. Paragraph 9 of the Shirts, Collars and Pyjamas Order is revoked.

- 1. This Order may be cited as Prices Regulation Order No. 2311.
  - 2. This Order shall operate as from 24th October, 1945.
- 3. Prices Regulation Order No. 1723 as amended by Prices Regulation Orders Nos. 1743, 1763, 1806, 1824, 1907, 1925, 2024, 2097, 2100, 2225, 2275 and 2298 is hereby further amended-
  - (a) by omitting from the First Schedule thereto the prices appearing opposite the classes of meat specified in the First Schedule to this Order and inserting in their stead the prices specified in relation thereto in such last mentioned Schedule;
    (b) by omitting from the Fourth Schedule thereto the
  - prices appearing opposite the items specified in the Second Schedule to this Order, and inserting in their stead the prices specified in relation thereto in such last mentioned Schedule;

    (c) by omitting the Fifth Schedule and inserting in its stead the Third Schedule to this Order.
