Eggs (Priority Sales) Order No. 2.

2. The Eggs (Priority Sales) Order is amended by omitting sub-paragraph (e) of paragraph 2 and inserting in its stead the following sub-paragraph:—

"(e) In the State of Western Australia—the City of Perth, the Municipalities of Guildford, Midland Junction, Subiaco, Claremont, Cottesloe, North Fremantle, Fremantle and East Fremantle, the Road Districts of Perth, Bayswater, Bassendean, Swan (South Ward only), Belmont Park, Peppermint Grove, Buckland Hill, Melville (excluding Country Ward), South Perth and Canning (excluding South Ward), and the Nedlands Road Board District."

National Security Act 1939-1943.

NATIONAL SECURITY (MAN POWER) REGULATIONS DELEGATION BY MINISTER OF STATE FOR LABOUR AND NATIONAL SERVICE.

W HEREAS by section 17 of the National Security Act 1939-1943 it is provided that any Minister of State may, in relation to any matter or class of matters, or in relation to any particular State or part of Australia, by writing under life hand, delegate all or any of his powers and functions under the Regulations (except this power of delegation) so that the delegated powers and functions may be exercised by the delegate with respect to the matters or class of matters, or the State or part of Australia, specified in the instrument of delegation:

Now therefore I, Edward James Holloway, Minister of State for Labour and National Service, do hereby delegate to Denis Patrick Witheriff of Sydney in the State of New South Wales, Deputy Director General of Man Power, all my powers and functions under sub-regulations (3.) and (4.) of regulation 16 of the National Security (Man Power) Regulations:

Provided that in constituting a Local Appeal Board the said Denis Patrick Witheriff shall appoint as Chairman thereof only a Stipendiary, Police or Special Magistrate whose name appears on any panel of such Magistrates previously approved by me to act as Chairman of Local Appeal Boards, and shall appoint as members to represent employers and employees respectively thereon only persons whose names appear on any panel of persons to represent employers and employees respectively on Local Appeal Boards previously approved by me, and that in appointing such members he shall as far as possible select from such panels persons engaged in the industry in which the person appealing pursuant to regulation 16 is engaged, but the person appealing pursuant to regulation 16 is engaged, but having regard always to the locality in which the Local Appeal Board is to sit.
