## COMMUNICATIONS WITH YUGOSLAVIA, LUXEMBOURG AND THE NETHERLANDS.

IT is notified for public information that, by virtue of the approval given on 14th April, 1945, the following classes of transactions in relation to the areas or territories specified hereunder in connexion therewith are exempted from the provisions of the *Trading with the Enemy Act 1939-1940* under the Licence granted by the Administrator of the Government of the Commonwealth of Australia on the twenty-second day of November, One thousand nine hundred and forty-four, and notified in the *Gazette*, No. 234, dated the twenty-third day of November, One thousand nine hundred and forty-four:—

### (a) Postal communications—

- (i) of a personal or family nature,
- (ii) of a business nature which are limited to the ascertainment of facts and the exchange of information, with Yugoslavia.

### (b) Postal communications—

- (i) of a personal or family nature,
- (ii) of a business nature which are limited to the ascertainment of facts and the exchange of information, with Luxembourg.

### (c) Postal communications—

- (i) of a personal or family nature,
- (ii) of a business nature which are limited to the ascertainment of facts and the exchange of information, with the towns of Middleburg, Flushing, Goes, Yerseke, Hansweert in the Netherlands and the immediate environs of such towns.

## NATIONAL SECURITY (AGRICULTURAL AIDS) REGULATIONS.

### OIL MEAL (RESTRICTION OF SALES) ORDER.

I, WILLIAM JAMES SCULLY, the Minister of State for Commerce and Agriculture, in pursuance of the powers conferred by the National Security (Agricultural Aids) Regulations, hereby make the following Order:—

#### *Citation.*

1. This Order may be cited as the Oil Meal (Restriction of Sales) Order.

#### *Definition.*

2. In this Order—

“authorized person” means any of the following persons—

The Under Secretary and Director, Department of Agriculture, New South Wales;  
The Director, Department of Agriculture, Victoria;  
The Under Secretary, Department of Agriculture and Stock, Queensland;  
The Director of Agriculture, South Australia;  
The Under Secretary, Department of Agriculture, Western Australia;  
The Secretary for Agriculture, Department of Agriculture, Tasmania;

“oil meal” means any material obtained as a by-product in the manufacture of vegetable oils, including linseed oil, cotton seed oil, coco-nut oil and peanut oil, which can be used for the feeding of stock or poultry, and includes any such by-product prepared in the form of meal, cake or nut, or any other form.

#### *Restriction on acquisition and disposal of oil meal.*

3. A person shall not, during any month, except under the authority of a permit granted by the Minister or the Director-General of Agriculture or an authorized person and in accordance with the terms and conditions contained in that permit, purchase or otherwise acquire, or sell or otherwise dispose of, any oil meal.

#### *Particulars to be supplied.*

4. A person making application for a permit under the last preceding paragraph shall supply such particulars as the person to whom the application is made requires.
