PROCLAMATION

Commonwealth of Australia to wit. HENRY Governor-General.

By His Royal Highness the Governor-General in and over the Common-wealth of Australia.

WHEREAS by Proclamation dated the third day of September One thousand pine September, One thousand nine hundred and thirty-nine, the Governor-General has proclaimed the existence of war:

And whereas by section 112 of the Customs Act 1901-1936 it is enacted that in time of war the Governor-General may by Proclamation prohibit the exportation of any goods:

And whereas the power of the Governor-General to prohibit, as aforesaid, the exportation of any goods extends to authorize the prohibition of the exportation of goods generally, or to any specified place, and either absolutely or so as to allow of the exportation of the goods subject to any condition or

Now therefore I, Henry William Frederick Albert, Duke of Gloucester, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby prohibit the exportation from Australia of the goods specified in the Schedule hereto unless the consent in writing of the Minister to the exportation of the goods has first been obtained.

NATIONAL SECURITY (GENERAL) REGULATIONS. OCCUPATION SURVEY ORDER.

JOSEPH BENEDICT CHIFLEY, the Treasurer of the Commonwealth, in pursuance of regulation 71A of the Cational Security (General) Regulations, hereby make the ollowing Order: following Order:-

Citation.

1. This Order may be cited as the Occupation Survey Order.

Definitions.

2. In this Order-

"card" means an Occupation Survey Card in the approved form issued by the Treasurer for the

purposes of this Order;
"incapable person" means a person who is insane or so
mentally or physically afflicted as to be incapable of
complying with the provisions of paragraph 4 of this

"ration book" means a ration book for the purposes of the National Security (Rationing) Regulations or any order made under those Regulations; "Ration Book Issue Centre" means any premises where, in accordance with arrangements made by the Ration-ing Commission, ration books are available for issue

on the second and third days of June, 1945;
"Ration Book Issuing Officer" means any person authorized to issue ration books at a Ration Book Issue Centre;

Issue Centre;
"the approved form", in relation to any person, means a
form approved by the Treasurer for use in the State
or Territory of the Commonwealth in which is
situated the Ration Book Issue Centre or office of the
Divisional Returning Officer at which that person is
required by this Order to deliver, or cause to be
delivered, a duly completed card.

Approved forms.

3. A form approved by the Treasurer for the purposes of this Order shall specify such particulars only as relate to information specified in regulation 71A of the National Security (General) Regulations.

Obligation to furnish certain particulars.

- 4. Subject to this Order, every person who is in the Commonwealth on the first day of June, 1945, and who, at that date, is of the age of fourteen years or over, shall-
 - (a) fill in on a card in the approved form, in accordance with the instructions contained on the card, all the particulars specified on the card;
 - (b) sign his name to the card; and
 - (c) deliver or cause to be delivered the card duly com-pleted and signed—
 - (i) where an application for a ration book is made by or on behalf of that person on the second or third day of June, 1945, at a Ration Book Issue Centre—to the Ration Book Issuing Officer to whom, and at the time at which, the application is made; or
 - (ii) where no such application is so made—to the Divisional Returning Officer to whom, and at the time at which, an application is first made after the commencement of this Order by or on behalf of that person for a ration book.

Incapable persons.

- 5. An incapable person shall not be bound to comply with the provisions of the last preceding paragraph, but any person who makes application for a ration book on behalf of an incapable person shall—
 - (a) fill in and deliver, or cause to be delivered, a card in respect of the incapable person in the manner in which, and at the time and place at which, the incapable person would be required to do so if he were not an incapable person; and
 - (b) before so delivering the card or causing it to be delivered, sign his own name on the card and indicate under his signature the fact that he has signed the card on behalf of the incapable person.

Exemptions.

- 6. Nothing in the two last preceding paragraphs shall apply in respect of any person who is, on the second day of June, 1945-
 - (a) a member of the Defence Force, or of a Voluntary Aid Detachment attached to the Defence Force, performing continuous service;
 - (b) a member of the Naval, Military or Air Forces of the United Kingdom or of any other part of His Majesty's Dominions (other than the Commonwealth), or of any foreign power allied or associated with His Majesty in any war in which His Majesty is engaged, or of any foreign authority recognized by His Majesty as competent to maintain Naval, Military or Air Forces;
 - (c) a person detained in an internment camp as defined in the National Security (Internment Camps) Regulations or a person detained in a prisoners of war camp as defined in the National Security (Prisoners of War) Regulations;
 - (d) a High Commissioner representing in Australia any part of His Majesty's Dominions, a diplomatic representative in Australia of any foreign country, or a member of the family or staff of any such High Commissioner or representative, if the member is a citizen of the part of His Majesty's Dominions or foreign country represented;
 - (e) a consular officer de carriere of a foreign country; or
 - (f) a Trade Commissioner or Assistant Trade Commissioner of any part of His Majesty's Dominions outside the Commonwealth or of any foreign country.

Supply and posting of cards.

7. The Treasurer may cause cards, for the purposes of this Order, to be prepared and made available at such post offices and other convenient places as he directs.

Pineapples.

N pursuance of the powers delegated to me by the Commonwealth Prices Commissioner pursuant to regulation 46 of the National Security (Prices) Regulations, I, Horace Eddy Bishop, Second Assistant Prices Commissioner, Prices Branch, Canberra, hereby make the following Order:—

1. This Order may be cited as Prices Regulation Order No. 2077.

2. Prices Regulation Order No. 1769 as amended by Prices Regulation Order No. 1999 is hereby further amended by omitting from paragraph 10 the figures "£12" and inserting in their stead the figures "£15".

NATIONAL SECURITY (PRICES) REGULATIONS. PRICES REGULATION ORDER No. 2078.

Potatoes for Stock Food.

IN pursuance of the powers delegated to me by the Commonwealth Prices Commissioner pursuant to regulation 46 of the National Security (Prices) Regulations, I, Horace Eddy Bishop, Second Assistant Prices Commissioner, Prices Branch, Canberra, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 2078.

Definitions.

2. In this Order, unless the contrary intention appears-

"Distribution Committee" means any persons or company appointed by the Australian Potato Committee as a Distribution Committee in pursuance of the National Security (Potatoes) Regulations Order No. 19; "stock agent" means any person who purchases potatoes for use as stock food from a Distribution Committee

for the purpose of resale to a user of such potatoes.

Sales by growers.

- 3. I fix and declare the maximum price at which potatoes for use as stock food may be sold by growers to be—
 - (a) for delivery at the railway siding nearest the grower's premises-£4 10s. per ton;

- (b) for delivery at the grower's premises—£4 10s, per ton, less the cost of transporting the potatoes from the grower's premises to the nearest railway siding;
- (c) for delivery at any other place—the price specified in sub-paragraph (b) plus the cost incurred in transporting the potatoes from the grower's premises to the place of delivery.

Sales by distribution committees.

4. I fix and declare the maximum price at which potatoes for stock food may be sold by Distribution Committees to be the maximum price fixed by the provisions of paragraph 3 of this Order for the sale of those potatoes by a grower, plus 5s. per ton.

Other sales.

- 5. I fix and declare the maximum price at which potatoes for use as stock food may be sold other than by growers or Distribution Committees to be—
 - (a) in respect of sales by a stock agent—the sum of the following:-
 - (i) the price paid or payable for such potatoes by the stock agent, or the maximum price fixed by the foregoing provisions of this Order for the sale of those potatoes to that stock agent, whichever is the lesser;
 - (ii) cost of transport, if any, incurred by the stock agent in delivering the potatoes to the purchaser;
 - (iii) margin at the rate of 5s. per ton, or, where payment for such potatoes is not made at the time of delivery, margin at the rate of 10s. per ton;
 - (b) in respect of any other sales—£4 10s. per ton.

Variation of maximum prices by notice.

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which potatoes for use as stock feed specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.
