## NATIONAL SECURITY (PRICES) REGULATIONS.

### PRICES REGULATION ORDER No. 2551.

#### *Ice Cream and Drinks—Cairns, Queensland.*

**I**N pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order:—

#### *Citation.*

1. This Order may be cited as Prices Regulation Order No. 2551.

#### *Revocation.*

2. Prices Regulation Order No. 1967 is hereby revoked.

#### *Application.*

3. This Order shall not apply to sales of soft drinks or aerated waters by a licensed victualler.

#### *Definitions.*

4. In this Order, and the Schedule thereto, unless the contrary intention appears—

“fruit drink” means any drink made from fruit juice, cordial, extract or syrup with the addition of water, soda water or aerated waters or any ingredient or ingredient other than ice cream;

“milk drink” means any drink of which milk is an ingredient;

“oz.” means fluid ounce or ounces as the case may be;

“Cairns” means all that area of Queensland comprised within the Petty Sessions District of Cairns.

#### *Maximum prices—Bottled aerated waters.*

5. I fix and declare the maximum prices at which bottled aerated waters may be sold by the bottle by retail in Cairns (including any deposit refundable on the bottle) to be the prices specified in the First Schedule to this Order, plus the amount of any deposit so refundable.

#### *Maximum prices—Sales other than by the bottle.*

6.—(1.) I fix and declare the maximum price at which any of the drinks specified in the Second Schedule to this Order may be sold by the glass in Cairns to be—

(a) where ice cream is not added—the price specified in that Schedule;

(b) where ice cream is added—the price specified in the said Second Schedule plus one penny.

(2.) I fix and declare the maximum prices at which ice cream, banana splits or sundaes may be sold in Cairns to be the prices specified in the Second Schedule to this Order.

#### *Fixation of maximum prices by notice.*

7. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which aerated waters, fruit drinks, milk drinks or ice cream specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

#### *Exhibition of price-list.*

8. Every person who sells or has for sale by retail aerated waters, fruit drinks, milk drinks or ice cream, shall exhibit in a prominent position in his place of business or if he has more than one place of business in each of his places of business a notice or notices setting forth his retail selling price for such goods, such notice to show separately the deposit charge, if any, included in the selling price so exhibited. Any such notice shall be exhibited in such a place or places in the trader's place of business and be prepared in such a manner as to be easily legible to any person contemplating making any purchase or conducting any business at the trader's place of business.

PRICES REGULATION ORDER No. 2553.*Photographs and Photography.*

**I**N pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order:—

1. This Order may be cited as Prices Regulation Order No. 2553.

2. Prices Regulation Order No. 2181 is hereby amended—

(a) by omitting from the Second Schedule thereto the words "Size No. 1 comprising Photographs measuring 5 inches by 3 inches and any other sizes smaller than 6½ inches by 4½ inches (passports excepted)", and inserting in their stead the words "Size No. 1 comprising photographs measuring 5 inches by 3 inches and any size smaller in area than 6½ inches by 4½ inches but not smaller in area than 5 inches by 3 inches";

(b) by omitting from the second Schedule thereto the words "Passports approximately 1 inch by 1½ inches" and inserting in their stead the words "Passports or Alien Registration photographs, and photographs measuring in area less than 5 inches by 3 inches".

**I**N pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order:—

*Citation.*

1. This Order may be cited as Prices Regulation Order No. 2554.

*Sales by retail—Maximum prices.*

2. I fix and declare the maximum price at which any kind of insecticide specified in the Schedule to this Order may be sold by retail to be the price therein specified.

*Fixation of maximum prices by notice.*

3. Notwithstanding the foregoing provisions of this Order I declare the maximum price at which insecticides specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

2. Prices Regulation Order No. 2549 is hereby amended by omitting from the Schedule the prices appearing opposite the items specified in the Schedule to this Order, and inserting in their stead the prices appearing opposite those items in such last-mentioned Schedule.

## PRICES REGULATION ORDER No. 2556.

*Footwear.*

**I**N pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order:—

1. This Order may be cited as Prices Regulation Order No. 2556.

2. Prices Regulation Order No. 1584 is hereby amended by omitting paragraph 6 and inserting in its stead the following paragraph:—

"6. I fix and declare the maximum price at which any footwear may be sold by a manufacturer to be—

(a) the prevailing price for sales of that footwear by that manufacturer, plus 2½ per centum, less 7½ per centum thereof; or

(b) where a maximum price for sales of that footwear has been fixed under the Regulations by notice in writing to that manufacturer subsequent to 12th April, 1943—that price plus 2½ per centum."

NATIONAL SECURITY (ENEMY PROPERTY)  
REGULATIONS.

## ORDER UNDER REGULATION 5A.

**I**N pursuance of regulation 5A of the National Security (Enemy Property) Regulations, I, Joseph Benedict Chifley, the Treasurer of the Commonwealth, hereby make the following Order:—

I specify the twenty-first day of May, 1946, as the date until which—

- (a) all parts of His Majesty's dominions and all territories under His Majesty's protection (including any territory in respect of which a mandate on behalf of the League of Nations has been accepted by His Majesty) which at the date of this order is required to be treated as enemy territory for the purposes of the National Security (Enemy Property) Regulations shall continue to be so treated; and
- (b) any person, firm or corporation who or which became an enemy subject by reason only of having been resident or carrying on business in any such part of His Majesty's dominions or territory, not being a national of a country with which His Majesty has been at war at any time since the 3rd day of September, 1939, or a corporation incorporated in any such country, shall be treated as though he or it had not ceased to be an enemy subject as defined in those Regulations.

REGULATIONS.

## NOTICE OF REVOCATION OF APPLICATION OF REGULATIONS.

**I**N pursuance of regulation 3 of the National Security (Emergency Control) Regulations, I, Edward John Ward, Minister of State for External Territories, acting for and on behalf of the Minister of State for the Army, do hereby declare that on and from the thirty-first day of May, 1946, the said Regulations shall no longer apply to the parts of Australia described in the Schedule hereto.

## SCHEDULE.

The District of New Britain as defined by the Administrator of the Territory of New Guinea on the twenty-fourth day of June, 1926, under the *Administrative Districts Ordinance* 1922 of the Territory of New Guinea except that part East of straight lines commencing at the intersection of the 151st Meridian of East longitude with the 4th parallel of South latitude bearing thence South-easterly to the mouth of the Korindindi River in Open Bay thence South-easterly to the mouth of the Mevelo River in Wide Bay thence South-easterly to the intersection of the Meridian 152 degrees 30 minutes 30 seconds of East longitude with the parallel 5 degrees 30 minutes of South latitude.
