NATIONAL SECURITY (ECONOMIC ORGANIZATION) REGULATIONS.

COUNTRY LANDS IN THE STATE OF QUEENSLAND.

STEVEDORING INDUSTRY COMMISSION.

ORDER No. 17 OF 1946.

Port of Sydney.

IN pursuance of the powers conferred by the National Security (Shipping Co-ordination) Regulations the Stevedoring Industry Commission hereby makes the following Order:—

1. Orders Nos. 13 and 14 made by the Stevedoring Industry Commission on the twenty-sixth day of March, 1943, as amended to date, are hereby further amended by inserting after clause 7 the following new clause:—

"7A. (a) The hours of work each day shall be:—

Day shift, Monday to Friday inclusive—8 a.m. to 5 p.m.

Saturday—8 a.m. to 12 noon.

Evening shift—5 p.m. to 11 p.m.

Night shift—12 midnight to 7 a.m.

(b) In the event of there being no labour available for the evening shift, men on day shift, except on Thursdays, shall work overtime until 9 p.m.

(c) Where at the end of a shift on any day Monday to Friday not more than two hours work remains to finish the job (which expression shall be taken to include the ship or hatch) the men working that shift shall carry on and complete the job if so instructed by the employer's representative. If at noon on Saturday not more than four hours' work remains to finish a ship which is sailing the men working that shift shall carry on and complete the job if so instructed by the employer's representative.

(d) Where in the opinion of the Chairman of the W.E.C. it is necessary for any vessel to work between midnight and 7 a.m. a shift shall be worked between those hours. In reaching a decision as to whether a vessel should work such shift the Chairman of the W.E.C. may confer with the members of that committee or with a representative of the employer and a representative of the Federation."

2. This Order shall come into operation on Monday, 1st July, 1946, or on such earlier date as may be found practicable.

NATIONAL SECURITY (GENERAL) REGULATIONS.

APPOINTMENT OF COMPENSATION BOARD UNDER
REGULATION 60L.

WHEREAS by an instrument of appointment dated the fourth day of February, 1943, the following Compensation Board was appointed in pursuance of regulation 60L of the National Security (General) Regulations for the purpose of assessing compensation payable in respect of loss or damage of the kind specified in that instrument—

And whereas it is desired to revoke the appointment of the said Compensation Board and to appoint in its stead the Compensation Board named hereunder:

Now therefore I, Francis Michael Forde, Minister of State for the Army, for myself and for and on behalf of the Minister of State for Defence, do hereby revoke the appointment of the said Compensation Board for the Tasmania Lines of Communication Area and appoint in its stead the following Compensation Board for the purpose of assessing the compensation payable in respect of any loss or damage suffered by reason of anything done by me or by my authority or direction or by the Minister of State for Defence or by his authority or direction—

- (a) in pursuance of regulations 53, 54, 55 or 56 of the National Security (General) Regulations;
- (b) in respect of any furniture or equipment requisitioned in pursuance of sub-regulation (1.) of regulation 57 of the National Security (General) Regulations or the Defence Impressment Order, being furniture or equipment contained in any building the subject of any action under the said regulation 53, 54, 55 or 56; or
- (c) in pursuance of sub-regulation (1.) or (2.) of regulation 57 of the National Security (General) Regulations or the Defence Impressment Order in relation to—
 - (i) vehicles (including motor cycles) of all kinds; or
 - (ii) tools, equipment and prime movers of all kinds required for use in connexion therewith:—

NATIONAL SECURITY (EMERGENCY CONTROL)
REGULATIONS.

NOTICE OF REVOCATION OF APPLICATION OF REGULATIONS.

IN pursuance of regulation 3 of the National Security (Emergency Control) Regulations, I, Francis Michael Forde, Minister of State for the Army, do hereby declare that on and from the twenty-fourth day of June, 1946, the said Regulations shall no longer apply to the parts of Australia described in the schedule hereto.

SCHEDULE.

That part of the District of New Britain as defined by the Administrator of the Territory of New Guinea on the twenty-fourth day of June, 1926, under the *Administrative Districts Ordinance* 1922 of the Territory of New Guinea being the part East of straight lines commencing at the intersection of the 151st Meridian of East longitude with the 4th parallel of South latitude bearing thence South-easterly to the mouth of the Korindindi River in Open Bay thence South-easterly to the mouth of the Mevelo River in Wide Bay thence South-easterly to the intersection of the Meridian 152 degrees 30 minutes 30 seconds of East longitude with the parallel 5 degrees 30 minutes of South latitude.

NATIONAL SECURITY (WAR DEATHS) REGULATIONS.

REVOCATION AND APPOINTMENT OF COMPETENT AUTHORITIES.

IN pursuance of the powers conferred upon me by the National Security (War Deaths) Regulations and of all other powers me thereunto enabling, I, Francis Michael Forde, Minister of State for the Army, hereby revoke the authority granted by me on the 6th day of December, 1945, to every person who shall at any time during the continuance of that authority be holding the office or performing the duties of the office of—

- (a) officer-in-charge of 2nd Echelon Head-quarters Australian Military Forces; or
- (b) deputy officer-in-charge of 2nd Echelon Head-quarters Australian Military Forces,

to issue certificates of death on war service for the purpose of the National Security (War Deaths) Regulations and hereby authorize every person who shall at any time during the continuance of this Authority be holding the office or performing the duties of the office of—

- (a) officer-in-charge of 2nd Echelon Army Head-quarters; or
- (b) deputy officer-in-charge of 2nd Echelon Army Head-quarters to issue certificates of death on war service for the purposes of the National Security (War Deaths) Regulations.
