PRICES REGULATION ORDER NO. 2686.

*Fish—Sales in New South Wales.*

IN pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order:—

1. This Order may be cited as Prices Regulation Order No. 2686.
2. Prices Regulation Order No. 2417 is hereby amended—
  - (a) by omitting from the Schedule thereto the prices appearing opposite the items specified in the First Schedule to this Order and inserting in their stead the prices specified in relation thereto in such last-mentioned Schedule;
  - (b) by inserting in the Schedule thereto after the item "Whiting, Trumpeter" the item specified in the Second Schedule to this Order, and in relation thereto the prices specified in such last-mentioned Schedule.

*Bean Seed—Victoria.*

IN pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order:—

*Citation.*

1. This Order may be cited as Prices Regulation Order No. 2690.

*Revocation.*

- 2.—(1.) Insofar as it applies to the sale in Victoria of Bean Seed other than Navy Bean Seed, Prices Regulation Order No. 1639 is hereby revoked.
- (2.) Insofar as it applies to the sale of Bean Seed in Victoria, Prices Regulation Order No. 1504 is revoked.

*Definitions.*

3. In this Order—

“Bushel” means 60 lb. by weight;  
“Certified Bean seed” means bean seed certified as such by the Department of Agriculture of Victoria.

*Maximum prices.*

4. I fix and declare the maximum price at which bean seed specified in the Schedule to this Order may be sold in Victoria to be—

- (a) in respect of sales by the grower—the price specified in that Schedule; or
- (b) in respect of sales other than by the grower—
  - (i) the price specified in the said Schedule for the sale of that bean seed by the grower, plus 15s. 0d. per bushel; or
  - (ii) the price paid or payable by the seller for that bean seed, plus 15s. 0d. per bushel;
 whichever is the lesser.

*Fixation of maximum prices by notice.*

5. Notwithstanding the foregoing provisions of this Order I declare the maximum price at which bean seed specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.

## NATIONAL SECURITY (PRICES) REGULATIONS.

PRICES REGULATION ORDER NO. 2691.

*Aerated Waters—New South Wales Country Areas.*

IN pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order:—

*Citation.*

1. This Order may be cited as Prices Regulation Order No. 2691.

*Application.*

2. This Order shall not apply—

- (a) to any sales by a licensed victualler;
- (b) to any sales in the Sydney metropolitan area, as defined in Prices Regulation Order No. 1598, or in the area comprised within a radius of 15 miles from the General Post Office, Newcastle.

*Definitions.*

3. In this Order and the Schedules thereto, unless the contrary intention appears—

“fruit drink” means any drink made from fruit juice, cordial, extract or syrup with the addition of water, soda water, or aerated waters or any ingredient or ingredients other than those referred to in sub-paragraph (b) of paragraph 5 (1.) of this Order;  
“ice cream soda” means any drink made from fruit juice, cordial, extract or syrup with the addition of soda water and ice cream;  
“milk drink” means any drink of which milk is an ingredient;  
“oz.” means fluid ounce or ounces as the case may be;  
“cost into store” means in relation to the sale of any bottled aerated waters, the sum of the invoice price of the goods, Sales Tax thereon, and cost of rail transport (if any) incurred in transporting the goods to the retail seller’s store, and properly recorded on the invoice delivered in relation thereto.

*Bottled aerated waters—Sales by the bottle.*

4. I fix and declare the maximum price at which any bottled aerated waters may be sold by retail by the bottle in New South Wales (including any deposit refundable on the bottle) to be the price specified in the First Schedule to this Order according to the cost into store, plus the amount of any deposit refundable on such bottle. Provided that where the quantity sold in any one sale is not less than twelve bottles, the maximum prices so specified, shall, in each case, be subject to a reduction of  $\frac{1}{4}$ d. per bottle.

*Sales other than by the bottle.*

- 5.—(1.) I fix and declare the maximum price at which any of the items specified in the Second Schedule to this Order, other than ice cream sodas, may be sold other than by the bottle in New South Wales to be—

- (a) where none of the ingredients referred to in sub-paragraph (b) of this paragraph are added—the price specified in that Schedule;
- (b) where any of the ingredients referred to hereunder are added—the price specified in the said Second Schedule, plus—
  - (i) subject to sub-paragraph (ii) hereof—one penny per serve for any ice cream added;

- (ii) threepence per serve for any serve of 2 ounces or more of ice cream added at the request of the purchaser ;
- (iii) one penny for any yeast, malted milk, vito, milo, or similar preparation, added ;
- (iv) threepence per egg for any egg or eggs added.

(2.) I fix and declare the maximum prices at which ice cream sodas may be sold in the prescribed area to be the prices specified in the Second Schedule to this Order.

*Fixation of maximum prices by notice.*

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any aerated waters, fruit drinks, or milk drinks specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

*Exhibition of price list*

7. Every person who sells or has for sale by retail aerated waters, fruit drinks, or milk drinks, shall exhibit in a prominent position in his place of business, or if he has more than one place of business, in each of his places of business, a notice or notices setting forth his retail selling price for each such kind of aerated waters, fruit drinks or milk drinks which he sells or has for sale. Such notice shall be exhibited in such a place or places in the retailer's place of business and be prepared in such a manner as to be easily legible to any person contemplating making any purchase or conducting any business at the retailer's place of business.

*Citation.*

1. This Order may be cited as Prices Regulation Order No. 2692.

*Maximum prices.*

2. I fix and declare the maximum price (including, where any container is sold therewith, the cost of such container) at which stearine may be sold to be the price specified in the Schedule to this Order.

*Fixation of maximum prices by notice.*

3. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which stearine specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

*Furniture Removalists' Charges—Queensland.*

IN pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order :—

*Citation.*

1. This Order may be cited as Prices Regulation Order No. 2694.

*Revocation.*

2. Prices Regulation Order No. 1497 is hereby revoked.

*Definitions.*

3. In this Order unless the contrary intention appears—
- "Furniture" includes all household and personal effects ;
- "Mackay area" means all that part of the State of Queensland within the following boundaries :—Commencing at the junction of the sea-coast with the 21st parallel of south latitude, thence by that parallel of latitude due west to 147 degrees of east longitude, thence by that parallel of longitude due south to 22 degrees of south latitude, thence by that parallel of latitude due east to the sea-coast ;
- "Northern area" means all that part of the State of Queensland north of a line commencing at the junction of the sea-coast with the 21st parallel of south latitude, thence by that parallel of latitude due west to 147 degrees of east longitude, thence by that parallel of longitude due south to 22 degrees 30 minutes of south latitude, thence by that parallel of latitude due west to the western border of the State ;
- "Southern area" means all that part of the State of Queensland south of a line commencing at the junction of the sea-coast with 22 degrees south latitude, thence by that parallel of latitude due west to 147 degrees of east longitude, thence by that parallel of longitude due south to 22 degrees 30 minutes of south latitude, thence by that parallel of latitude west to the western border of the State.

*Maximum rates.*

4.—(1.) I fix and declare the maximum rate at which any service of removing furniture by pantehnicon or motor vehicle may be supplied in Queensland in the areas specified in the Schedule to this Order to be an amount calculated at the rate per hour specified in that Schedule for the time occupied in such service. Provided that where the time so occupied exceeds one hour and is not an exact number of hours, half hours or quarter hours, such time shall be computed to the next upward quarter hour.

(2.) For the purpose of the last preceding sub-paragraph the time occupied shall be computed from the time of departure of the pantehnicon or motor vehicle from the point where it commenced its journey for the purpose of carrying out the said service until its return direct to its depot, or, if such vehicle does not return direct to its depot, then until such time as the loading of furniture in respect of another service of removing furniture is commenced, but in such latter case so as not to exceed the time it would have taken to return to its depot. Provided that where by reason of any mechanical defect, breakdown or accident the time occupied in any service is increased, such increased time shall not be included in the aforesaid computation.

*Additional charges.*

5. Notwithstanding the foregoing provisions of this Order there may be added to the maximum rates specified in the Schedule—

- (a) where additional men to those specified in the Schedule are employed—
- (i) for each additional man employed during the period set out at the head of the second column of the said Schedule—an amount calculated at the rate of 3s. 9d. per hour for each hour that man is so employed;
- (ii) for each additional man employed during the period set out at the head of the third column of the said Schedule—an amount calculated at the rate of 5s. 3d. per hour for each hour that man is so employed;
- (b) an amount calculated at the rate of 6d. per mile for each mile exceeding fifteen miles travelled by the vehicle in any one service of removing furniture;
- (c) an amount calculated at the rate of two pence for each case of six cubic feet capacity or more supplied for use in the removing of the furniture;
- (d) all amounts paid for bridge tolls or road tax;
- (e) an amount calculated at the rate of six shillings per hour for each hour occupied in packing furniture for transport to its destination.

*Fixation of maximum rates by notice.*

6. Notwithstanding the foregoing provisions of this Order I declare the maximum rate at which the service of removing furniture specified in a notice in pursuance of this paragraph may be supplied by any person in Queensland to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.

NATIONAL SECURITY (PRICES) REGULATIONS.

PRICES REGULATION ORDER No. 2698.

*Liqueurs and Advocaats—Victoria.*

IN pursuance of the powers conferred upon me by the National Security (Prices) Regulations, I, Mortimer Eugene McCarthy, Commonwealth Prices Commissioner, hereby make the following Order :—

*Citation.*

- 1. This Order may be cited as Prices Regulation Order No. 2698.

*Application.*

- 2. This Order shall not apply to the sale of any liqueurs or advocaats for which a maximum price is fixed by Prices Regulation Order No. 2440.

*Definitions and interpretation.*

- 3.—(1.) In this Order, unless the contrary intention appears—
  - “ oz. ” means fluid ounce or ounces as the case may be ;
  - “ bottle ” means a bottle which is reputed to contain 26 fluid ounces ;
  - “ half bottle ” means a bottle which is reputed to contain 13 fluid ounces ;
  - “ liqueur glass ” means any glass or container containing not less than one-half fluid ounce ;
  - “ nobbler ” means one fluid ounce ;
  - “ Geelong area ” means all that area of Victoria comprised within a radius of 5 miles from the principal post office, Geelong ;
  - “ Melbourne area ” means all that area of Victoria comprised within a radius of 20 miles from the General Post Office, Melbourne.
- (2.) Where any price calculated under the provisions of this Order is not an exact number of pence or half pence such price shall be computed to the nearest upward halfpenny.

*Sales by the bottle.*

4. I fix and declare the maximum price at which any liqueurs or advocaats may be sold by retail in Victoria by the bottle or half bottle to be—

- (a) in respect of liqueurs or advocaats of any brand and description specified in the Schedule to this Order—the price specified in that Schedule ; or
- (b) in respect of liqueurs or advocaats of any brand and description not specified in the said Schedule—the price paid or payable by the retail seller for those goods, plus five per centum thereof.

*Sales by the glass.*

5. I fix and declare the maximum price at which liqueurs or advocaats of any brand and description specified in the Schedule to this Order may be sold by the glass in Victoria to be—

- (a) in respect of liqueurs—1s. 0d. per liqueur glass ; or
- (b) in respect of advocaats—1s. 0d. per nobbler.

*Other sales.*

6. Notwithstanding the foregoing provisions of this Order, I fix and declare the maximum price at which liqueurs or advocaats of any brand or description specified in the Schedule to this Order may be sold in Victoria other than by the bottle or half bottle, or other than by the containers specified in paragraph 5, to be the sum which bears the same ratio to the maximum price fixed for the sale of such liqueurs or advocaats by the bottle by the foregoing provisions of this Order as the fluid measure of the liqueurs or advocaats actually sold bears to 26 oz.

*Fixation of maximum prices by notice.*

7. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any liqueurs or advocaats specified in a notice in pursuance of this paragraph may be sold in Victoria by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.

*Exhibition of maximum prices.*

8. Every person who sells or has for sale by retail in Victoria any liqueurs or advocaats shall exhibit in a prominent place in his place of business, or if he has more than one place of business in each of his places of business, and in each of the bars, dining rooms and lounges at such place or places of business, a notice or notices setting forth the maximum prices fixed by the provisions of this Order for the sale of those liqueurs or advocaats. Such notice or notices shall be exhibited in such a place or places in the trader's place of business and be prepared in such a manner as to be easily legible to persons contemplating making any purchase or conducting any business at the trader's place of business.
