NATIONAL SECURITY (ENEMY PROPERTY) REGULATIONS.

ORDER UNDER REGULATION 5A.

pursuance of regulation 5A of the National Security 1 (Enemy Property) Regulations, I, Joseph Benedict Chifley, the Treasurer of the Commonwealth, hereby make the following

I specify the 30th day of June, 1948, as the date until

- (a) the Principality of Monaco shall, for the purposes of the National Security (Enemy Property) Regulations, be treated as though it had not ceased to be enemy territory for the purposes of those regulations; and
- (b) any person, firm or corporation who or which became an enemy subject by reason only of having been resident or carrying on business in the Principality of Monaco not being a national of a country with which His Majesty has been at war at any time since the third day of September, 1939, or a corporation incorporated in any such country, shall be treated as though he or it had not ceased to be an enemy subject as defined in those regulations.

NATIONAL SECURITY (MARITIME INDUSTRY) REGULATIONS.

ORDER No. 65.

N pursuance of the powers conferred upon the Maritime Industry Commission by the National Security (Maritime Industry) Regulations, I, Stanley Thompson Edwards, Acting Chairman, by and with the authority of the Commission, hereby sign and seal the following Order made by the Com-

- 1. This Order may be cited as "Employment Order AA".
- 2. Clause 2 of Order No. 44, being Employment Order O, made by the Maritime Industry Commission on the twenty-seventh day of October, 1943, is hereby amended as follows:—
 - (i) By deleting sub-clauses (c) and (d); and
 - (ii) by inserting in lieu thereof the following:-
 - (c) Any person who has not previously served at sea and who desires to engage as Deck at sea and who desires to engage as Deta Boy in Australian merchant ships shall supply to the Superintendent, Mercantile Marine Office, at his home port or the port where he resides, his name, age, address and such other particulars as the Superintendent may require.
 - (d) Boys who have not previously served at sea shall attend for engagement at a Mercantile Marine Office and shall not be engaged elsewhere. Deck Boys who have previously served at sea shall be engaged at the picking-up place prescribed in clause 58 of the Award made by the Com-monwealth Court of Conciliation and Arbitration in the case of the Seamen's Union of Australia.
