NATIONAL SECURITY (ENEMY PROPERTY) REGULATIONS.

ORDER NO. 26 UNDER REGULATION 5A.

IN pursuance of regulation 5A of the National Security (Enemy Property) Regulations, I, Joseph Benedict Chifley, the Treasurer of the Commonwealth, hereby make the following Order:—

I specify the second day of November, 1948, as the date, until which each of the persons named in the schedule to this Order shall, for the purposes of the National Security (Enemy Property) Regulations, be treated as if he or she had not ceased to be an enemy subject as defined in those regulations.
