BANKING (FOREIGN EXCHANGE) REGULATIONS. PAYMENT FOR EXPORTS FROM AUSTRALIA.

To shereby notified for public information that, in pursuance of regulation 23 (1.) (a) of the Banking (Foreign Exchange) Regulations, the Commonwealth Bank of Australia has approved that, in respect of goods exported from Australia to Territories included in the French Franc Area, the prescribed methods of payment notified in Commonwealth of Australia Gazette No. 176 of 12th September, 1947, be amended

to read as follows:-

Territories.

Prescribed Methods of Payment.

- 15. The French Franc Area, that is to say, Me France (which Metropolitan includes Algeria). and Corsica French West Monaco, Monaco, French West Africa, French Equa-torial Africa, Madagascar and its dependencies, Reunion, French Somali Coast, French Guiana, Guadeloupe, Martinique, St. Pierre and Miquelon, French Establishments in India, Indo-China, New Caledonia, French Establishments in Oceania, the Condominium of the New Hebrides, the Protectorates of Morocco and Tunisia, the French Mandated Territories of Cameroon and Syria and the Togo.
- (i) In sterling from an account with a bank in the United Kingdom of a person resident in any of the territories comprised in the French Franc Area which has been designated by the Bank of England as a French No. 1 Account

(ii) In the currency of any of the territories comprised in the French Franc Area

(iii) In Australian currency from an account with a bank in Australia of a bank domiciled in any of the territories comprised in the French Franc Area

BANKING (FOREIGN EXCHANGE) REGULATIONS. PAYMENT FOR EXPORTS FROM AUSTRALIA.

(a) of the Banking (Foreign Exchange) Regulations the Commonwealth Bank of Australia has approved that, in respect of goods exported from Australia to Italy, the prescribed methods of payment notified in Commonwealth of Australia Gazette No. 176 of 12th September, 1947, be amended to read as follows:—

Territories.

Prescribed Methods of Payment.

- 19. Italy (that is to say, the Mainland of Italy, Sicily, Sardinia and the adjacent islands), the Republic of San Marino and the Vatican City
- (i) In sterling from an account with a Bank in the United Kingdom of a person resident in Italy, the Re-public of San Marino or the Vatican City; or
- (ii) In Australian currency from an account with a Bank in Australia of a bank domiciled in Italy, the Republic of San Marino or the Vatican City

ORDER TERMINATING ABANDONMENT OF PROPERTY IN EVACUATED AREAS.

In pursuance of the powers conferred upon me by subregulation (3) of regulation 4 of the National Security (War Damage to Property) Regulations, I, Joseph Benedict Chiffey, the Treasurer of the Commonwealth, hereby declare that on and after the twenty-ninth day of February, 1948, all property of whatsoever kind, in each and every evacuated area shall cease to be deemed to be abandoned for the purposes of the National Security (War Damage to Property) Regulations. Banking Act 1945. ORDER OF EXEMPTION.

IN pursuance of the powers conferred on me by section ten of the Banking Act 1945, I, Joseph Benedict Chifley, the Treasurer of the Commonwealth, hereby make the following

Citation.

1. This Order may be cited as the Banking (Exemption) Order No. 8.

Interpretation.

2. In this Order, any reference to a person specified in the Schedule to this Order shall be deemed to include the persons carrying on business under any name specified in that Schedule which is not the name of a body corporate.

Exemption.

3. Subject to the conditions specified in the next succeeding paragraph, I hereby exempt from compliance with section six or section seven of the Banking Act 1945 (whichever would otherwise be applicable) each of the persons specified in the Schedule to this Order.

Conditions of exemption.

4.—(1.) The exemption given by the last preceding paragraph to any person shall be subject to the conditions—

(a) that that person shall, in making advances in the course of banking business carried on by that person, follow the policy (if any) determined by the Commonwealth Bank as the policy which the Commonwealth Bank is satisfied it is necessary or expedient, in the public interest, for that person, or for a number or class of persons including that or for a number or class of persons including that person, to follow; and

person, to follow; and

(b) without limiting the generality of the last preceding condition, that that person shall give effect to any directions which may be given to that person by the Commonwealth Bank as to the classes of purposes for which advances in the course of any banking business may or may not be made by that person, or by a number or class of persons including that person.

(2.) The determinations and directions of the Commonwealth Bank referred to in the last preceding sub-paragraph shall not include any determination or direction with respect to an advance made, or proposed to be made, to any particular person.

(3.) Nothing in this paragraph shall affect the validity of any transaction entered into in relation to an advance or affect the right of any person to recover any advance or enforce any security given in respect of an advance.

Period of operation.

5. This Order shall remain in force during a period of twelve months commencing on the twenty-first day of February, 1948.

Banking Act 1945. ORDER OF EXEMPTION.

IN pursuance of the powers conferred on me by section ten of the Banking Act 1945, I, Joseph Benedict Chifley, the Treasurer of the Commonwealth, hereby make the following Order:-

Citation.

1. This Order may be cited as the Banking (Exemption) Order No. 9.

Exemption.

2. Subject to the condition specified in the next succeeding paragraph, I hereby exempt The Cairns Co-operative Weekly Penny Savings Bank Limited from compliance with section seven of the *Banking Act* 1945.

Condition of exemption.

3. The exemption given by the last preceding paragraph shall be subject to the condition that the Cairns Co-operative Weekly Penny Savings Bank Limited shall not carry on banking business in any part of Australia other than the City of Cairns.

Period of operation.

4. This Order shall remain in force during a period of twelve months commencing on the twenty-first day of February, 1948.

ORDER OF EXEMPTION.

IN pursuance of the powers conferred on me by section ten of the Banking Act 1945, I, Joseph Benedict Chifley, the Treasurer of the Commonwealth, hereby make the following Order :-

Citation.

1. This Order may be cited as the Banking (Exemption) Order No. 10.

Exemption.

2. Subject to the conditions specified in the next succeeding paragraph, I hereby exempt Thos. Cook & Son (Australasia) Pty. Ltd. (hereinafter called "the company") from compliance with section seven of the Banking Act 1945.

Conditions of exemption.

3. The exemption given by the last preceding paragraph shall be subject to the conditions that—

(a) the company shall not carry on any banking business other than banking business of a class carried on by it at the date of this Order; and

(b) in the purchase and sale of foreign currency, the company shall comply with any directions of the Commonwealth Bank.

Period of operation.

4. This Order shall remain in force during a period of twelve months commencing on the twenty-first day of February, 1948.

Banking Act 1945. ORDER OF EXEMPTION.

IN pursuance of the powers conferred on me by section ten of the Banking Act 1945, I, Joseph Benedict Chifley, the Treasurer of the Commonwealth, hereby make the following

Citation.

1. This Order may be cited as the Banking (Exemption) Order No. 11.

Exemption.

2. Subject to the conditions specified in the next succeeding paragraph, I hereby exempt American Express Company Incorporated (hereinafter called "the company") from compliance with section seven of the Banking Act 1945.

Conditions of exemption.

3.—(1.) The exemption given by the last preceding paragraph shall be subject to the conditions—

11.

- (a) that the company shall not carry on any banking business other than banking business involved in-
 - (i) the sale of foreign currency to which this paragraph applies for travel purposes to any person who is about to leave Australia, and

(ii) the purchase of foreign currency to which
this paragraph applies which has been
brought to Australia by, and is owned by,
a person who has been in Australia for a
period not exceeding six months; and
(b) that, in carrying on such banking business, the company shall comply with any directions of the
Commonwealth Bank.

(2.) The foreign currency to which this paragraph applies is notes, coin, bills of exchange, drafts, letters of credit or travellers' cheques payable or expressed otherwise than in Australian money.

Period of operation.

4. This Order shall remain in force during the period commencing on the date of publication of this Order in the Gazette and ending on the twenty-first day of February, 1949.
