PROCLAMATION.

Commonwealth of Australia to wit.
W. J. SLIM
Governor-General.

By His Excellency the Governor-General in and over the Commonwealth of Australia.

WHEREAS, in pursuance of the *Commonwealth Electoral Act 1918-1953*, the Distribution Commissioners appointed for the purpose of distributing the State of South Australia into electoral divisions, in accordance with the said Act, have forwarded to the Minister their report upon the distribution of that State into electoral divisions, and the number of electors residing in each proposed division, as nearly as could be ascertained, together with maps signed by them showing the boundaries of each proposed division; and the reports and maps have been laid before both Houses of the Parliament, as directed by the said Act; and both Houses of the Parliament have passed resolutions approving of the distribution proposed in the said reports:

And whereas, by the said Act, it is enacted that if both Houses of the Parliament pass a resolution approving of any proposed distribution, the Governor-General may, by proclamation, declare the names and boundaries of the divisions, and such divisions shall, until altered, be the electoral divisions for the State in which they are situated:

And whereas, by the said Act, it is further enacted that each division shall be divided into subdivisions, and the boundaries of each subdivision shall be as specified by proclamation:

And whereas, by the said Act, it is also enacted that new rolls for any subdivisions, divisions, or States shall be prepared whenever directed by proclamation, and that the proclamation may specify the manner in which the rolls shall be prepared:

Now therefore I, Sir William Joseph Slim, the Governor-General aforesaid, acting with the advice of the Federal Executive Council and in pursuance of the said Act do hereby declare and proclaim—

- (1) That the names and boundaries of the electoral divisions for the State of South Australia are as set out in Part I. of the Schedule to this Proclamation, and that the said divisions shall, until altered, be the electoral divisions for that State:
- (2) That the said electoral divisions shall be divided into subdivisions, as set out in Part II. of the said Schedule:
- (3) That new rolls for the State of South Australia and for all divisions and subdivisions, as set out in this Proclamation, shall forthwith be prepared by the Commonwealth Electoral Officer for that State, in accordance with this Proclamation:
- (4) That in preparing the new rolls the Commonwealth Electoral Officer for the said State shall, as regards each subdivision, to the best of his means of information place on the roll for that subdivision the name of every person whose name is, at the date of the publication of this Proclamation in the *Gazette*, on the existing roll for the State, and whose place of living is within the limits of that subdivision:

- (5) That the Commonwealth Electoral Officer for the said State shall also place on the new roll for any subdivision the name of each person, not on the existing roll for the State, who has sent in a claim to be enrolled, and who he is satisfied is entitled to be enrolled for that subdivision:

- (6) That where in consequence of this Proclamation or action thereunder (other than action by any elector), the enrolment of any electors is changed to a subdivision or division which differs in name from the subdivision or division for which they were enrolled prior to this Proclamation, the Commonwealth Electoral Officer for the said State shall give notice of the change as follows:—

- (a) Where in the opinion of the Commonwealth Electoral Officer, a reasonable effective notice, generally applicable to all electors in a subdivision whose enrolments have been changed can be given—by notice in the *Gazette*, and in some newspaper or newspapers circulating in the locality affected; and

- (b) In other cases—by notice sent by post to each elector concerned:

- (7) That the Commonwealth Electoral Officer for the said State shall, forthwith after the preparation of the new rolls is complete, notify, by notice in the *Gazette*, that new rolls have been prepared, as directed by this Proclamation, and thereupon the new rolls shall be the rolls prepared for the purposes of the said Act.

NAMES AND BOUNDARIES OF ELECTORAL DIVISIONS.

STATE OF SOUTH AUSTRALIA.

ELECTORAL DIVISION OF ADELAIDE.

Commencing at the south-eastern corner of the City of Adelaide; thence westerly and northerly along its southern and western boundaries; north-westerly along the north-eastern side of Port-road to the western corner of preliminary section 376, hundred of Yatala, north-easterly to its northern corner; south-easterly along Torrens-road; northerly along Days-road, west of sections 395 and 394; easterly along the northern boundaries of sections 394 and 377; northerly along Churchill-road, west of sections 368 and 367; easterly along the northern boundaries of sections 367 and 354; southerly along the Main North-road; easterly along Third-avenue, Sefton Park and McInnes-avenue; southerly along Hampstead-road; north-easterly along Main North East-road; south-easterly along

Landsdowne-terrace, Walkerville; generally south-westerly following River Torrens to the eastern boundary of the City of Adelaide; and generally southerly along latter boundary to the point of commencement.

ELECTORAL DIVISION OF ANGAS.

Commencing at the north-east corner of county Hamley; thence south along the eastern boundary of the State to intersect the production easterly of the southern boundary of hundred of Day; westerly along said production and the southern boundaries of hundreds of Day, Allenby, Price and Peake; northerly and westerly along the eastern and northern boundaries of hundred of Roby; northerly along the eastern boundary of hundred of Seymour; westerly along the southern boundaries of hundreds of Ettrick, Monarto and Kamantoo to the road intersecting section 2201; thence south-westerly in hundred of Strathalbyn along said road through sections 2201, 2202 and south-east of sections 1378 and 1396; north-westerly along road south-west of sections 1396 and 1401 and through sections 2872 and 2873; westerly along road south of sections 2878, 2877 and sections 2876 and 2880, hundred of Macclesfield; north-westerly along the south-western boundary of section 2884; westerly along road south of sections 2212, 3008, 3006, 4 and 8; north-easterly along the eastern boundary of hundred of Kuitpo; westerly along road north of section 181 of latter hundred; north-westerly and south-westerly along road north-east and north-west of part section 3883; westerly along road south of section 709 and 3888; south-westerly between sections 174 and 156; westerly along road north of sections 370 and 372; south-westerly along road north-west of sections 372, 357, part 332, 817 and 321; westerly along road through section 22 to the north-eastern corner of section 4164; northerly by a straight line to the southern corner of section 223, hundred of Noarlunga; generally northerly along road east of sections 107 and 1426, road opened 4th November, 1897 and road south-east of sections 354 and 412; north-westerly along road south-west of section 420, and northerly along the western boundaries of sections 419, 381 and 385; north-easterly along the south-eastern boundary of the hundred of Adelaide to the main South-Eastern Road; generally north-westerly along said main road and the southern and western boundaries of section 1286, hundred of Adelaide; north-easterly and north-westerly along the south-eastern and north-eastern boundaries of section 1284; northerly, easterly and southerly following the boundaries of section 1001; easterly along the southern boundaries of sections 1053 and 1054; northerly along the eastern boundaries of sections 1054, 1056 and 1057; easterly along the southern boundaries of sections 906 and 919; northerly and easterly along the western and northern boundaries of section 1180; northerly along the western boundaries of sections 1107 and 484; easterly and northerly along the southern and eastern boundaries of section 1104; south-easterly, north-easterly and westerly following the boundaries of section 855; north-easterly along the north-western boundary of section 991; northerly along the western boundaries of sections 826 and 827; westerly and north-easterly along the southern and north-western boundaries of section 997; generally northerly along the eastern boundary of the hundred of Adelaide to the River Torrens; generally easterly and north-easterly following said river to the eastern boundary of section 6074, hundred of Talunga; northerly along the eastern boundaries of sections 6074 and 6073 to the north-western boundary of the hundred; generally north-easterly and south-easterly following the boundaries of the hundred to Williamstown and Birdwood Main-road; northerly and north-westerly along the main road to the southern boundary of the hundred of Barossa; generally north-easterly and westerly following the boundaries of said hundred to the south-western corner of section 934, hundred of Moorooroo; north-westerly along road south-west of section 934 to the eastern boundary of the hundred of Barossa; generally north-westerly along latter boundary to road east of section 455, hundred of Barossa; generally north-easterly in the hundred of Nuriootpa, along the eastern boundary of section 37, the southern and eastern boundaries of sections 804, 1697, 1680, and 626, the south-eastern boundaries of sections 561, 516, part 84 and 289, the eastern boundaries of sections 283 and 79, the southern boundaries of sections 200 and 125, the western boundaries of sections 196, 197, 175 and 139, the southern and eastern boundaries of section 757, the western and northern boundaries of sections 158 and 48, and along the south-eastern boundary of the hundred of Belvidere; northerly and easterly along the western and northern boundaries of the hundred of Jellicoe; northerly along the eastern boundaries of the hundreds of Dutton and Neales; westerly and northerly along the southern and western boundaries of the hundred of Bower; easterly and northerly along the southern and eastern boundaries of hundred of Bunday; easterly along the northern boundary of hundred of Maude; easterly and southerly along the northern and eastern boundaries of hundred of Lindley; easterly and southerly along the northern and eastern boundaries of hundred of Stuart to the south-western corner of section 26, hundred of Markaranka; easterly along the southern boundaries of sections 26 and 79;

northerly along the eastern boundary of latter section; south-easterly along the north-eastern boundaries of sections 81, 11 and 14; easterly along the northern boundaries of sections 17 and 4 and sections 13, 7, 10 and 12, hundred of Pooginook and sections 30 and 31, hundred of Parcoola, and said boundary produced to the western boundary of county Hamley; northerly and easterly along the western and northern boundaries of said county to the point of commencement.

ELECTORAL DIVISION OF BARKER.

Commencing at the south-eastern corner of the State, thence north along its eastern boundary to intersect the production easterly of the southern boundary of hundred of Day; westerly along said production and the southern boundaries of hundreds of Day, Allenby, Price and Peake; northerly and westerly along the eastern and northern boundaries of hundred of Roby; northerly along the eastern boundary of hundred of Seymour; westerly along the southern boundaries of hundreds of Ettrick, Monarto and Kamantoo to the road intersecting section 2201; thence south-westerly in hundred of Strathalbyn along said road through sections 2201, 2202 and south-east of sections 1378 and 1396; north-westerly along road south-west of sections 1396 and 1401 and through sections 2872 and 2873; westerly along road south of sections 2878, 2877 and sections 2876 and 2880, hundred of Macclesfield; north-westerly along the south-western boundary of section 2884; westerly along road south of sections 2212, 3008, 3006, 4 and 8; north-easterly along the eastern boundary of hundred of Kuitpo; westerly along road north of section 181 of latter hundred; north-westerly and south-westerly along road north-east and north-west of part section 3883; westerly along road south of sections 709 and 3888; south-westerly between sections 174 and 156; westerly along road north of sections 370 and 372; south-westerly along road north-west of sections 372, 357, part 332, 817 and 321; westerly along road through section 22 to the north-eastern corner of section 4164; northerly by a straight line to the southern corner of section 223, hundred of Noarlunga; generally northerly along road east of sections 107 and 1426, road opened 4th November, 1897 and road south-east of sections 354 and 412; north-westerly along road south-west of section 420, and northerly along the western boundaries of sections 419 and 381, to the southern boundary of the hundred of Adelaide; generally westerly following said boundary to the Main South-road; generally south-westerly along said main road to the southern boundary of section 510, hundred of Noarlunga; westerly along the southern boundaries of sections 510, 506 and 569 to the sea coast; south-westerly and generally south-easterly following said sea coast to the point of commencement and including Kangaroo Island, adjacent islands, and jetties along the sea coast.

ELECTORAL DIVISION OF BONYTHON.

Commencing at the north-western corner of section 367, hundred of Yatala; southerly along Churchill-road; westerly along the northern boundaries of sections 377 and 394; southerly along Days-road west of sections 394 and 395; north-westerly along Torrens-road; northerly along Goodall-avenue and Hassell-street; westerly along First-avenue; northerly along Hanson-road, west of sections 410 and 405; easterly along Grand Junction-road; north-westerly along North Arm-road; north-easterly and northerly following the south-eastern and eastern sides of Creek east of Garden and Torrens Islands and the eastern shore of Gulf St. Vincent to intersect the production westerly of the northern boundary of section P, hundred of Port Adelaide; easterly along the northern boundaries of sections P and 5031; north-easterly in the hundred of Munno Para, along road north-west of sections 4251 and 3054, to the eastern corner of section 3883; easterly along road to the north-west corner of section 3888; northerly along road to the southern boundary of hundred of Mudla Wirra; thence generally easterly along said boundary to the road intersecting section 8, hundred of Mudla Wirra; northerly along said road, and north-easterly along Gawler Station Main-road to the Gawler and Roseworthy Railway; north-westerly along said railway; north-easterly along road south-east of sections 453 and 458; northerly along road east of section 459; north-easterly along road south-east of sections 427 and 436; south-easterly along road south-west of sections 438 and 439; southerly along the eastern boundary of the hundred to the North Para River; generally southerly, northerly and easterly along said River; southerly along the western boundary of section 12, hundred of Nuriootpa; easterly along the northern boundary of section 3076; hundred of Barossa; southerly along the eastern boundaries of sections 3076 and 3073 and the eastern boundaries of sections 5 and 3, hundred of Nuriootpa; thence generally southerly and westerly following the boundaries of hundred of Munno Para to the north-eastern corner of section 2136, hundred of Yatala; south-westerly along road south-east of sections 2136 and 521 to the southern corner of latter section; southerly by a straight line to the north-eastern corner of section 3002 and along the eastern boundaries of

sections 3002, 1572 and part 1566 to centre of Dry Creek; generally south-westerly following said creek to intersect the eastern boundary of section 313; southerly along the eastern boundaries of section 313 and part preliminary section 504; easterly and southerly along the northern and eastern boundaries of part preliminary section 508 and production of latter boundary to the southern boundary of the hundred of Yatala (River Torrens); easterly following said River; south-westerly along the Lower North-Eastern Main-road; southerly along Glynde-road; westerly along Magill-road; northerly along Wellington-road; south-westerly along Payneham-road; north-westerly along Battams-road; north-westerly along Lansdowne-terrace (Walkerville); south-westerly along the Main North-East-road; northerly along Hampstead-road; westerly along McInnes and Third avenues; northerly along the Main North-road; westerly along the northern boundaries of sections 354 and 367 to the point of commencement, together with jetties along the sea coast.

ELECTORAL DIVISION OF BOOTHBY.

Commencing at the south-western corner of the City of Adelaide; thence easterly along its southern boundary; south-easterly along Glen Osmond-road; southerly along Fullarton-road; easterly along Fisher-street; south-easterly and easterly along Main South-Eastern-road; southerly and easterly along the western and southern boundaries of section 1286, hundred of Adelaide; generally south-easterly along said Main South-Eastern-road; generally south-easterly and south-westerly along the southern boundary of hundred of Adelaide to the eastern boundary of section 22, hundreds of Adelaide and Noarlunga; northerly in hundred of Adelaide along the eastern boundaries of sections 22 and 18; along the Adelaide and Nairne Railway, the eastern boundaries of sections 14 and 12 and along Goodwood-road; westerly along the southern boundaries of sections 2 and 47; northerly along Main South-road; and north-easterly along Anzac-highway to the point of commencement.

ELECTORAL DIVISION OF GREY.

Commencing at the north-western corner of the State; thence south along its western boundary to the sea coast; generally easterly, south-easterly, north-easterly and southerly along the sea coast to the south-western corner of the hundred of Pirie; easterly along the southern boundaries of the hundreds of Pirie, Booyoolie, and Whyte; northerly in the hundred of Whyte, along road west of sections 2, 16, 23, 34, 124, 489 and 477; westerly along the southern boundary of the hundred of Yongala; northerly along the western boundaries of the hundreds of Yongala and Morgan; easterly along the northern boundary of the latter hundred; northerly along the western boundary of county Herbert; easterly along the northern boundary of said county to the south-western corner of pastoral block 928; northerly and westerly following the boundaries of said block to the south-eastern corner of pastoral block 1073; westerly, northerly and north-easterly following the boundaries of said block; westerly and northerly along the southern and western boundaries of pastoral block 923; north-easterly and northerly along the south-eastern and eastern boundaries of pastoral block 847; northerly along the western boundaries of pastoral blocks 927 and 945; north-easterly following the boundaries of latter block; northerly along the western boundary of pastoral block 292, and easterly following its northern boundary to the eastern edge of Lake Frome; northerly along said lake; easterly along the northern boundary of pastoral block 476 and by a straight line to the eastern boundary of the State; north and west following the eastern and northern boundaries of the State to the point of commencement, and including Gambier Islands, Neptune Islands, and adjacent islands, together with jetties along the sea coast.

ELECTORAL DIVISION OF HINDMARSH.

Commencing at south-western corner of the City of Adelaide; thence south-westerly along Anzac-highway; southerly along Main South-road; south-westerly along Adelaide-Glenelg tramway; north-westerly along River Sturt; easterly and north-easterly along Anzac-highway; northerly along Morphett-road; westerly and south-westerly along road opened 16th September, 1948, through section 169 and part preliminary sections 187 and 186, hundred of Adelaide and westerly along Warren-avenue to Tapleys Hill-road; south-westerly along said road; westerly along Military-road and production to the eastern shore of Gulf St. Vincent; northerly along said shore to a point opposite the north-western corner of section 1006, hundred of Yatala; easterly along the northern boundary of section 1006; northerly along the western boundary of section 452; easterly along road south of part sections 902 and 424; southerly along Findon-road; south-easterly along the north-eastern boundary of preliminary section 410; northerly along the western boundary of preliminary section 396 and production to the north-eastern side of Port-road; south-easterly along said side of road and southerly along the western boundary of the City of Adelaide, to the point of commencement, together with the jetties along the sea coast.

ELECTORAL DIVISION OF KINGSTON.

Commencing at the intersection of Main South-road with the Adelaide and Glenelg Tramway; thence south-westerly along said tramway; north-westerly along River Sturt; easterly and north-easterly along Anzac-highway; northerly along Morphett-road; westerly and south-westerly along road opened 16th September 1948, through section 169 and part preliminary sections 187 and 186, hundred of Adelaide; and westerly along Warren-avenue to Tapleys Hill-road; south-westerly along said road; westerly along Military-road and production to the eastern shore of Gulf St. Vincent; southerly along said shore to a point opposite the south-western corner of section 569, hundred of Noarlunga; easterly along the southern boundaries of sections 569, 506 and 510 to Main South-road; generally north-easterly along said road to the south-western boundary of hundred of Adelaide (River Sturt); south-easterly along said boundary to the eastern boundary of section 22, hundreds of Adelaide and Noarlunga; northerly in the hundred of Adelaide, along the eastern boundaries of sections 22 and 18, along the Adelaide and Nairne Railway, the eastern boundaries of sections 14 and 12, and along Goodwood-road; westerly along the southern boundaries of sections 2 and 47; and northerly along Main South-road to the point of commencement.

ELECTORAL DIVISION OF PORT ADELAIDE.

Commencing at the western corner of preliminary section 376, hundred of Yatala; north-easterly along its north-western boundary; north-westerly along Torrens-road; northerly along Goodall-avenue and Hassell-street; westerly along First-avenue; northerly along Hanson-road west of section 410 and 405; easterly along Grand Junction-road; north-westerly along North Arm-road; north-easterly and northerly following the south-eastern and eastern sides of creek east of Garden and Torrens Islands to a point west of the north-western corner of section 328, hundred of Port Adelaide; west to the eastern side of Torrens Island; north-westerly and westerly along the north-eastern and northern sides of said island to Point Grey; south to Snapper Point; westerly along the northern shore of Le Fevre Peninsula; southerly following the eastern shore of Gulf St. Vincent (including block 30), to a point opposite the north-western corner of section 1006, hundred of Yatala; easterly along the northern boundary of section 1006; northerly along the western boundary of section 452; easterly along road south of part sections 902 and 424; southerly along Findon-road; south-easterly along the north-eastern boundary of preliminary section 410; northerly along the western boundary of preliminary section 396 and production to the north-eastern side of Port-road; south-easterly along said side of road to the point of commencement, together with jetties along the sea coast.

ELECTORAL DIVISION OF STURT.

Commencing at the south-eastern corner of the City of Adelaide; thence northerly along its eastern boundary, generally north-easterly along River Torrens; south-easterly along Battams-road; north-easterly along Payneham-road; southerly along Wellington-road; easterly along Magill-road; northerly along Glynde-road; north-easterly along Lower North-Eastern Main-road to the northern boundary of hundred of Adelaide (River Torrens); easterly and southerly following the boundaries of said hundred; south-westerly and easterly along the north-western and southern boundaries of section 997, hundred of Adelaide; southerly along the western boundaries of sections 827 and 826; south-westerly along the north-western boundary of section 991; easterly, south-westerly and north-westerly following the boundaries of section 855; southerly and westerly along the eastern and southern boundaries of section 1104; southerly along the western boundaries of sections 484 and 1107; westerly and southerly along the northern and western boundaries of section 1180; westerly along the southern boundaries of sections 919 and 906; southerly along the eastern boundaries of sections 1057, 1056 and 1054; westerly along the southern boundaries of sections 1054 and 1053; northerly, westerly and southerly following the boundaries of section 1001; south-easterly and south-westerly along the north-eastern and south-eastern boundaries of section 1284; generally westerly and north-westerly along Main South-Eastern-road; westerly along Fisher-street; northerly along Fullarton-road; north-westerly along Glen Osmond-road, and easterly along Park Terrace to the point of commencement.

ELECTORAL DIVISION OF WAKEFIELD.

Commencing at the north-western corner of hundred of Wandearah, thence generally south-south-westerly following the sea coast to Cape Spencer; generally easterly to Sultana Point; generally north-north-easterly and south-easterly following the shores of Gulf St. Vincent to intersect the production westerly of the northern boundary of section P, hundred of Port Adelaide; easterly along the northern boundaries of sections P and 5031; north-easterly in the hundred of Munno Para along road north-west of sections 4251 and 3054 to the eastern corner of section 3883; easterly along road to the north-west corner of section 3888, northerly along road to the

southern boundary of hundred of Mudla Wirra; thence generally easterly along said boundary to the road intersecting section 8, hundred of Mudla Wirra; northerly along said road and north-easterly along Gawler Railway Station Main-road to the Gawler and Roseworthy Railway; north-westerly along said railway; north-easterly along road south-east of sections 453 and 458; northerly along road east of section 459; north-easterly along road south-east of sections 427 and 436; south-easterly along road south-west of sections 438 and 439; southerly along the eastern boundary of the hundred to the North Para River; generally southerly northerly and easterly along said river; southerly along the western boundary of section 12, hundred of Nuriootpa; easterly along the northern boundary of section 3076, hundred of Barossa; southerly along the eastern boundaries of sections 3076 and 3073 and the eastern boundaries of sections 5 and 3, hundred of Nuriootpa; thence generally southerly and westerly following the boundaries of hundred of Munno Para to the north-eastern corner of section 2136, hundred of Yatala; south-westerly along road south-east of sections 2136 and 521 to the southern corner of latter section; southerly by a straight line to the north-eastern corner of section 3002 and along the eastern boundaries of sections 3002, 1572 and part 1566 to centre of Dry Creek; generally south-westerly following said creek to intersect the eastern boundary of section 313; southerly along the eastern boundaries of section 313 and part preliminary section 504; easterly and southerly along the northern and eastern boundaries of part preliminary section 508 and production of latter boundary to the southern boundary of Yatala, hundred of (River Torrens); generally easterly and north-easterly following said River Torrens to the eastern boundary of section 6074, hundred of Talunga; northerly along the eastern boundaries of sections 6074 and 6073 to the north-western boundary of the hundred; generally north-easterly and south-easterly along latter boundary to Williamstown and Birdwood Main-road; northerly and north-westerly along the main road to the southern boundary of the hundred of Barossa; generally north-easterly and westerly following the boundaries of said hundred to the south-western corner of section 934, hundred of Moorooroo; north-westerly along road south-west of section 934 to the eastern boundary of the hundred of Barossa; generally north-westerly along latter boundary to road east of section 455, hundred of Barossa; generally north-easterly in the hundred of Nuriootpa, along the eastern boundary of section 37, the southern and eastern boundaries of sections 804, 1697, 1680 and 626, the south-eastern boundaries of sections 561, 516, part 84 and 289, the eastern boundaries of sections 283 and 79, the southern boundaries of sections 200 and 125, the western boundaries of sections 196, 197, 175 and 139, the southern and eastern boundaries of section 757, the western and northern boundaries of sections 158 and 48, and along the south-eastern boundary of the hundred of Belvidere; northerly and easterly along the western and northern boundaries of the hundred of Jellicoe; northerly along the eastern boundaries of the hundreds of Dutton and Neales; westerly and northerly along the southern and western boundaries of the hundred of Bower; Subdivision of Saddleworth.

Comprising the whole of the hundred of Saddleworth, together with that portion of the hundred of Waterloo, north of the following boundary:—Commencing at the north-eastern corner of the hundred of Gilbert; thence easterly by the northern boundaries of sections 1090, 1091, and 1092, hundred of Waterloo, to the north-eastern corner of latter section; thence southerly by the eastern boundary of said section and its production across the road to the north-western boundary of section 1093; thence north-easterly by the north-western boundaries of sections 1093, 267, 266, 215, and by the southern side of road running north-easterly through section 1076 to intersect the eastern boundary of said section; thence north to the south-eastern corner of section 1077, and thence easterly by the south boundaries of sections 1078, 187, 240, 241, 246, 247, and 250 to the south-eastern corner of latter section.

Subdivision of Snowtown.

Comprising the hundreds of Barunga, Cameron, Redhill, Mundoora, and Wokurna.

Subdivision of Spalding.

Comprising the whole of the hundreds of Reynolds and Andrews.

Subdivision of Terowie.

Commencing at the south-west corner of section 2, hundred of Whyte; thence generally in a northerly direction along road west of sections 2, 16, 23, 34, 124, 493, and 477 to the north boundary of said hundred; thence east along the south boundaries of the hundreds of Yongala, Gumbowie, Parnaroo, and Hardy, and a line being the production of said boundary to the latter hundred to the east boundary

of county Kimberly; thence south along said boundary to the south-eastern corner of said county; thence westerly along its southern boundary and the southern boundary of the hundred of Whyte, to the point of commencement.

Subdivision of Two Wells.

Commencing at the north-west corner of the hundred of Mudla Wirra; thence south along western boundary of said hundred to its south-west corner, and southerly along road to the north-west corner of section 3888, hundred of Munno Para; thence westerly along road to the east corner of section 3883; thence south-westerly along road south-east of sections 3883, 3067, 3053, and 4260, and westerly along road south of sections 5032 and 181, hundred of Port Adelaide, to the eastern shore of Gulf St. Vincent; thence north-westerly and northerly along said shore to the south-western corner of the hundred of Inkerman; thence east along the southern boundaries of the hundreds of Inkerman, Balaklava, and Dalkey; thence south-easterly along the north-eastern boundary of the hundred of Grace to the point of commencement.

Subdivision of Wallaroo.

Comprising the whole of the hundred of Wallaroo and the lighthouse on the Tiparra Reef, also including the jetties along the sea coast.

Subdivision of Yorketown.

Commencing at the south-west corner of the hundred of Minlacowie; thence east along its south boundary and north along the east boundary of said hundred to the north-east corner of section 208; thence easterly along road north of sections 167 and 171, hundred of Ramsay, and south-easterly along road north-east of sections 163 and 177 to the north-west corner of section 19; thence north-easterly and easterly along road north-west of sections 20 and 46, and road north of sections 45 and 43 to the north corner of section 42; thence south-easterly along road north-east of section 39 to the sea coast; thence southerly, westerly, northerly, and easterly following the sea coast to the point of commencement, together with Althorpe Islands and Troubridge Lighthouse.
