CUSTOMS (INTERMEDIATE TARIFF) ORDER No. 10.

I NORMAN HENRY DENHAM HENTY, Minister of State for Customs and Excise, in pursuance of section nine A of the Customs Tariff 1933-1959, do hereby declare that, as from nine o'clock in the forenoon, reckoned according to standard time in the Australian Capital Territory, on the fourteenth day of May, One thousand nine hundred and fifty-nine, the rate of duty set out in the column headed "Intermediate Tariff" in the Schedule to the Customs Tariff 1933-1959 (being that Schedule as proposed to be amended by Customs Tariff Proposals No. 4 introduced into the House of Representatives on the thirteenth day of May, One thousand nine hundred and fifty-nine) in relation to an item in that Schedule the number of which is specified in the Schedule to this Order shall apply to goods included in that item that are the produce or manufacture of a country specified in the Second Schedule to the Customs (Intermediate Tariff) Order No. 2 made, and published in the Gazette, on the twenty-sixth day of June, One thousand nine hundred and fifty-eight.

Customs Act 1901-1957.

CUSTOMS BY-LAWS Nos. 1348-1350.

I NORMAN HENRY DENHAM HENTY, Minister of State for Customs and Excise, in pursuance of section 271 of the Customs Act 1901-1957, hereby make the By-laws set out in the Schedule hereto.

THE SCHEDULE.

By-law No. 1348.

Item 120 (C) (1).

1. This by-law may be cited as Customs By-law No. 1348.
2. Where in this by-law security is imposed as a condition subject to which Tariff Item 120 (C) (1) applies to goods or to goods included in that class or kind of goods such condition may be waived in circumstances and subject to conditions approved by the Collector.
3. Item 120 (C) (1) of the Customs Tariff 1933-1959 as proposed to be altered applies to Towelling, in the piece, cotton or linen or cotton and linen, not defined for cutting up, provided suitably equivalent goods the manufacture of Australia are not reasonably available, for use in the manufacture of art needlework, under security.
4. By-law No. 41, published in Gazette No. 10, dated 25th February, 1955, is revoked.

By-law No. 1349.

Item 120 (C) (2).

1. This by-law may be cited as Customs By-law No. 1349.
2. Item 120 (C) (2) of the Customs Tariff 1933-1959 as proposed to be altered applies to Towelling, other than terry towelling, in the piece, not defined for cutting up, as follows:—
Crash
Dowls
Forfar
Glass cloth
Honeycomb, provided the Minister is satisfied that suitably equivalent goods the manufacture of Australia are not reasonably available
Huckaback
Kitchen towelling
Tea towelling.
3. By-law No. 40, published in Gazette No. 10, dated 25th February, 1955, is revoked.

By-law No. 1350.

Item 120 (c) (3).

1. This by-law may be cited as Customs By-law No. 1350.
2. Item 120 (c) (3) of the Customs Tariff 1933-1959 as proposed to be altered applies to Towelling, other than terry towelling, in the piece, defined for cutting up for the manufacture of hemmed or hemstitched towels, as follows:—
 - Crash
 - Dowlas
 - Forfar
 - Glass cloth
 - Honeycomb, provided the Minister is satisfied that suitably equivalent goods the manufacture of Australia are not reasonably available.
 - Huckaback
 - Kitchen towelling
 - Tea towelling.
3. By-law No. 39, published in Gazette No. 10, dated 25th February, 1955, is revoked.

Customs Act 1901-1957.

SUBSTITUTE NOTICE No. 10.

I NORMAN HENRY DENHAM HENTY, Minister of State for Customs and Excise, in pursuance of section 139 of the Customs Act 1901-1957, hereby amend Substitute Notice No. 1, published in Gazette No. 10, dated 25th February, 1955, as amended by Substitute Notice No. 5, published in Gazette No. 52, dated 12th September, 1958, by deleting from the first column of the Schedule the reference to "Piece goods of a composition indicated &c." and by deleting from the second column of the Schedule the reference to "Piece goods of wool or containing &c.".

This notice may be cited as Substitute Notice No. 10 and shall take effect from the fourteenth day of May, 1959.
