#### **PROCLAMATION**

Commonwealth of Australia to wit. DUNROSSIL Governor-General. By His Excellency the Governor-General in and over the Commonwealth of Australia.

WHEREAS it is provided by sub-section (1) of section (2) of the Navigation Act 1958 that the sections of that Act, other than sections one and two, shall come into operation on such dates as are respectively fixed by Proclamation:

Now therefore I, William Shepherd, Viscount Dunrossil, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, hereby fix the thirtieth day of August, One thousand nine hundred and sixty, as the date on which the sections of that Act specified in the Schedule to this Proclamation shall come into operation.

### PROCLAMATION

Commonwealth of Australia to wit. DUNROSSIL Governor-General. By His Excellency the Governor-General in and over the Commonwealth of Australia.

WHEREAS it is provided by sub-section (2.) of section two of the Customs Act 1959, that sections, three, four, nine, ten, eleven, thirteen, fifteen, twenty, twenty-one, twenty-two, twenty-three, twenty-four and twenty-nine of that Act shall come into operation on a date to be fixed by Proclamation:

Now therefore I, William Shepherd, Viscount Dunrossil, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, hereby fix the first day of September, 1960, as the date on which the sections specified in sub-section (2.) of section two of the Customs Act 1959 shall come into operation.
