DETERMINATION UNDER SECTION 151A.

Determination No. 84.

PURSUANT to the powers conferred upon me by section 151A 1, of the Customs Act 1901-1960, I, Norman Henry Denham Henry, Minister of State for Customs and Excise, do hereby determine, for the purposes of paragraph (c) of sub-section (1.) of that section in its application in relation to goods which are imported from any country in respect of which a Customs Tariff within the meaning of sub-section (1.) of that section applies, that the goods specified in the schedule to this determination are of a class or kind not commercially produced or manufactured in Australia.

For the purposes of this determination "Tariff item" means an item in the Schedule to the Customs Tariff 1933-1960 as amended from time to time or as proposed to be amended from time to time by a Customs Tariff alteration proposed in the Parliament.

This determination is made in lieu of the following determination, viz.:-

No. 83, dated 8th September, 1960, and notified in the Commonwealth of Australia Gazette, No. 63, of 9th September,

THE SCHEDULE.
