PROCLAMATION

Commonwealth of Australia to wit. DUNROSSIL Governor-General.

Excellency the Governor-His Ву General in and over the Commonwealth of Australia.

WHEREAS, by section three of the National Health Act 1959, it is provided that, in relation to medical expenses incurred after the commencement of that section and before the first day of January, One thousand nine hundred and sixty-one, or such later date as is, before that day, fixed by Proclamation as the date on which that section shall cease to have effect, the reference in paragraph (b) of the definition of "contributor" in sub-section (1.) of section thirteen of the National Health Act 1953-1959 to "the First Schedule to this Act" shall be read as a reference to the First Schedule to the National Health Act 1953-1958: Now therefore I, William Shepherd, Viscount Dunrossil, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, hereby fix the thirtieth day of June, One thousand nine hundred and sixty-one, as the date on which section three of the National Health Act 1959 shall cease to have effect.

Given under my Hand and the Great Seal of the Commonwealth this sixteenth day of December, in the year of our Lord, One thousand nine hundred and sixty, and in the ninth year of Her Majesty's reign.

NOTICE OF TARIFF PROPOSALS (No. 1).

N pursuance of section 273EA of the Customs Act 1901-1960, I, Hugh Stevenson Roberton, Minister of State for Social Services, acting for and on behalf of the Minister of State for Customs and Excise, hereby give notice that I intend, within seven sitting days of the House of Representatives after the date of the publication of this notice in the Gazette, to propose in the Parliament—

(a) that the Schedule to the Customs Tariff 1933-1960 be amended as set out in the Schedule to this notice; and

(b) that the proposed Customs Tariff alteration referred to in this notice operate as from the twenty-third day of December,

One thousand nine hundred and sixty.
