By-law No. 1581.

Item 359 (E) (2).

- 1. This by-law may be cited as Customs By-law No. 1581.
- 2. This by-law shall take effect from 12th June, 1964.
- 3. By-law No. 1145, published in Gazette No. 21, dated 7th March, 1963, as amended, is further amended by-
 - (a) deleting from the list of goods in paragraph 3 to which Tariff Item 359 (E)(2) applies, the words, letter and figures "Other parts when otherwise classifiable under Tariff Item 359 (F), as follows:—" and inserting in their stead the words, letter and figures-

(b) deleting from the list of goods in the "TABLE" to paragraph 3, excluded from admission under Tariff Item 359 (E)(2), under the heading "when imported separately or otherwise—" the reference to—

"coils, high tension ignition, 6 volt, &c."
