PROCLAMATION

By His Excellency the Administrator of

WHEREAS Her Majesty Queen Elizabeth the Second was graciously pleased, by Commission under Her Sign Manual and the Royal Seal of the Commonwealth of Australia bearing date at Buckingham Palace the twenty-eighth day of May, One thousand nine hundred and sixty-four, to constitute and appoint me, General Sir Eric Winslow Woodward, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Commander of the Most Excellent Order of the British Empire, Companion of the Distinguished Service Order, Knight of the Most Venerable Order of Saint John of Jerusalem, to administer the Government of the Commonwealth of Australia in the event of the death, incapacity, removal, or absence out of the said Commonwealth of the Governor-General and Commander-in-Chief for the time being, I do hereby proclaim and

DELEGATION TO PRESIDE OVER MEETINGS OF THE FEDERAL EXECUTIVE COUNCIL.

IN pursuance of the provisions of sections 4 and 126 of the Constitution of the Commonwealth of Australia, and of clause 6 of the Letters Patent constituting the Office of Governor-General, I hereby appoint the Honourable William McMahon, M.P., Vice-President of the Executive Council, to be my Deputy to summon Meetings of the Executive Council, and, in the event of my inability to be present, to preside over Meetings of the Executive Council and signify approval of the proceedings at such Meetings.

If, for any reason, the Vice-President of the Executive Council is unable to attend, the Senior Member of the Executive Council who is present is hereby authorized to exercise the authority herein vested in the Vice-President.
