APPOINTMENT OF HAROLD CLIVE NEWMAN, ESQ., C.B.E., TO ENQUIRE INTO CERTAIN MATTERS RELATING TO THE PRICE OF BREAD IN THE AUSTRALIAN CAPITAL TERRITORY.

JOHN DOUGLAS ANTHONY, Minister of State for the Interior, in pursuance of section three of the Enquiry Ordinances 1938 of the Australian Capital Territory, hereby appoint Harold Clive Newman, Esq., C.B.E., to enquire into the following matters in relation to the Australian Capital Territory, namely:—

- (a) the costs of production, treatment and distribution of bread in the Australian Capital Territory and whether those costs are reasonable;
- (b) the retail prices at which all types of bread are sold in the Australian Capital Territory, including the differences in prices for comparable types of bread sold elsewhere;
- (c) whether justification exists for any variation in the retail prices of bread sold within the Australian Capital Territory:
- (d) any matters incidental to the abovementioned matters.

And I require you with as little delay as possible to report to me the result of your enquiries into the above matters.
