QUARANTINE PROCLAMATION No. 73A.

Commonwealth of Australia to wit DE L'ISLE Governor-General. By His Excellency the Governor-General in and Commonwealth of Australia.

WHEREAS by section thirteen of the Quarantine Act 1908-1961 W it is enacted, amongst other things, that the Governor-General may, by proclamation, prohibit the importation into Australia—

- (a) of any articles likely, in his opinion, to introduce any infectious or contagious disease, or disease or pest affecting persons, animals or plants; or
 (b) of any animals or any parts of animals;

AND WHEREAS by that section it is also enacted that the power of prohibition under that section shall extend to authorize prohibition generally or with limitations as to place and subject matter, and either absolutely or subject to any specified conditions or restrictions:

AND WHEREAS, by Proclamation No. 70A published in the Gazette on twentieth day of July, One thousand nine hundred and sixty-one, the importation into Australia of certain articles (including cooked meats and cooked edible parts of animals contained in hermetically sealed cans or tins) was prohibited subject to specified conditions or restrictions:

AND WHEREAS it is desirable to revoke Quarantine Proclamation No. 70a in so far as it prohibits the importation into Australia of cooked meats and cooked edible parts of animals contained in hermetically sealed cans or tins subject to the conditions or restrictions specified in that proclamation, and to make other provision in its stead:

NOW THEREFORE I, William Philip, Viscount De L'Isle, the Governor-General aforesaid acting with the advice of the Federal Executive Council-

(a) revoke Quarantine Proclamation No. 70A in so far as it prohibits the importation of cooked meats and cooked edible parts of animals contained in hermetically sealed cans or tins:

- (b) prohibit the importation into Australia of cooked meats (other than cooked meat of pigs), and cooked edible parts of animals (other than pigs), contained in hermetically sealed cans or tins unless the certificates and declarations referred to in sub-regulation (1A.) or (1B.) of regulation 82 of the Quarantine (Animals) Regulations have been produced in accordance with that sub-regulation;
- (c) prohibit the importation into Australia of cooked meat of pigs, and cooked edible parts of pigs, contained in hermetically sealed cans or tins from a country other than the United Kingdom of Great Britain and Northern Ireland, Canada, Ireland, New Zealand or the United States of America; and
- (d) prohibit the importation into Australia of the cooked meat of pigs, and cooked edible parts of pigs, contained meat of pigs, and cooked educe parts of pigs, contained in hermetically sealed cans or tins from the United Kingdom of Great Britain and Northern Ireland, Canada, Ireland, New Zealand and the United States of America unless the certificates and declarations referred to in sub-regulation (1A.) of regulation 82 of the Quarantine (Animals) Regulations have been produced in accordance with that sub-regulation.

NOTICE (No. 84) OF TARIFF PROPOSALS.

In pursuance of section 273EA of the Customs Act 1901-1963, I, Kenneth McColl Anderson, Minister of State for Customs and Excise, hereby give notice that it is intended, within seven sitting days of the House of Representatives after the date of the publication of this notice in the Gazette, to propose in the Parliament—

- (a) that the Schedule to the Customs Tariff 1933-1964 be amended as set out in the Schedule to this notice; and
- (b) that the proposed Customs Tariff alteration referred to in this notice operate on and from the twenty-third day of April, One thousand nine hundred and sixty-five.
