QUARANTINE PROCLAMATION No. 70G.

Commonwealth of Australia to wit
HENRY ABEL SMITH
Administrator.

By His Excellency the Administrator
of the Government of the Commonwealth of Australia.

WHEREAS it is provided by sub-section (1.) of section thirteen of the Quarantine Act 1908-1961 that the Governor-General may, amongst other things, by proclamation, prohibit the importation into Australia of any articles likely, in his opinion, to introduce any infectious or contagious disease, or disease or pest affecting persons, animals or plants:

AND WHEREAS it is provided by sub-section (2.) of that section that the power of prohibition under that section shall extend to authorize prohibition generally or with limitations as to place and subject-matter, and either absolutely or subject to any specified conditions or restrictions:

AND WHEREAS by Quarantine Proclamation No. 7G, published in the Gazette on the twelfth day of September, One thousand nine hundred and thirty-five, the importation into Australia of certain articles was prohibited:

AND WHEREAS it is desirable that that proclamation be revoked and that other provision be made in its stead:

AND WHEREAS it is provided by section 16A of the Acts Interpretation Act 1901-1964 that where, in an Act, the Governor-General is referred to, the reference shall, unless the contrary intention appears, be deemed to include the person for the time being administering the Government of the Commonwealth and shall, unless the contrary intention appears, be read as referring to a person so deemed to be included in the reference, acting with the advice of the Federal Executive Council:

NOW THEREFORE I, Sir Henry Abel Smith, the Administrator aforesaid, acting with the advice of the Federal Executive Council, revoke Quarantine Proclamation No. 7G, and prohibit the importation into Australia of—

- (a) rags, other than rags consisting of clean material that, in the opinion of a Quarantine Officer, has never been used;
- (b) used or second-hand bedding, other than bedding that is for the use of a passenger travelling to Australia on a ship or aircraft and is included among the baggage and personal effects of the passenger, whether on the ship or aircraft on which the passenger is travelling or travelled to Australia or on another ship or aircraft;
- (c) second-hand clothing (not being clothing imported by a person for use as his own clothing or as the clothing of a member of his family) unless the permission in writing of the Chief Quarantine Officer to import the clothing is produced to the Collector of Customs;
- (d) flock, whether made from rag or any other material, other than flock made from new clean waste derived from cotton, wool or jute;
- (e) bedding and other goods containing flock, other than bedding or goods containing flock the importation of which, as flock, is not prohibited under the last preceding paragraph;

(f) human bones and other human tissue, unless the permission in writing of the Director of Quarantine to import the bones or tissue is produced to the Collector of Customs;

(g) the body of a deceased person, unless—

(i) the permission in writing of the Director of Quarantine to import the body is produced to the Collector of Customs; and

(ii) the body is accompanied by an official copy of an official certificate of death, or an official extract of an entry in an official register, in respect of the person, showing the date, place and cause of death;

(h) shaving-brushes and tooth-brushes made from or containing the hair of animals and manufactured at a place situated in the area described in the Schedule to this Proclamation, other than a place in Japan or New Zealand; and

(j) the following goods, namely, brushes (other than shaving-brushes and tooth-brushes) and toilet articles made from or containing the hair of animals and manufactured at a place situated in the area described in the Schedule to this Proclamation, other than a place in Japan or New Zealand, unless—

(i) the goods are accompanied by an official certificate of an officer of the Health Department or other corresponding Department in the country in which the goods were manufactured stating the method by which the hair used in the manufacture of the goods was cleansed and disinfected before or during the manufacture of the goods; and

(ii) that method is a method approved by the Chief Quarantine Officer as a satisfactory method for cleansing and disinfecting hair for use in the manufacture of goods of a class in which the goods are included.

THE SCHEDULE.

Restricted Area.

The area bounded on the west by the meridian 60 degrees east longitude and on the east by the meridian 169 degrees west longitude.

Given under my Hand and the Great Seal of the Commonwealth this eighteenth day of June in the year of Our (L.S.) Lord, One thousand nine hundred and sixty-five, and in the fourteenth year of Her Majesty's reign.
