PROCLAMATION

Commonwealth of
Australia to wit
HENRY ABEL SMITH
Administrator.

By His Excellency the Administrator
of the Government of the Com-
monwealth of Australia.

WHEREAS it is provided by sub-section 2 of the Customs Act 1963 that section 5, subsection (1.) of section 14 and sections 15, 16, 20, 22, 31 and 32 of that Act shall come into operation on such dates as are respectively fixed by Proclamation:

AND WHEREAS by Proclamation published in the Gazette on the twenty-fifth day of June, One thousand nine hundred and sixty-four, the first day of July, One thousand nine hundred and sixty-four, was fixed as the date on which sections 5, 20, 22, 31 and 32 of the Customs Act would come into operation:

NOW THEREFORE I, Sir Henry Abel Smith, the Administrator aforesaid, acting with the advice of the Federal Executive Council, hereby fix the first day of September, One thousand nine hundred and sixty-five, as the date on which sub-section (1.) of section 14 and sections 15 and 16 of the Customs Act 1963 shall come into operation.

GIVEN under my Hand and the Great Seal of the Commonwealth this twenty-sixth day of August, in the year of Our (L.S.) Lord, One thousand nine hundred and sixty-five, and in the fourteenth year of Her Majesty's reign.

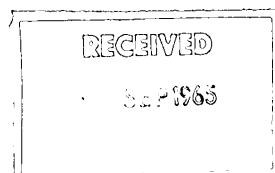
