PROCLAMATION

Commonwealth of
Australia to wit
CASEY
Governor-General.

By His Excellency the Governor-
General in and over the
Commonwealth of Australia.

WHEREAS it is provided by section 2 of the Narcotic Drugs Act 1967 that that Act shall come into operation on a date to be fixed by Proclamation which shall not be a date earlier than the date on which the Single Convention on Narcotic Drugs, 1961, comes into force in respect of the Commonwealth:

AND WHEREAS that Convention came into force on the thirteenth day of December, One thousand nine hundred and sixty-four, the fortieth instrument of ratification or accession having been deposited in accordance with Article 40 of that Convention on the thirteenth day of November, One thousand nine hundred and sixty-four:

AND WHEREAS that Convention will come into force in respect of the Commonwealth on the thirty-first day of December, One thousand nine hundred and sixty-seven, the Commonwealth

having deposited its instrument of ratification in accordance with Article 40 of that Convention on the first day of December, One thousand nine hundred and sixty-seven:

NOW THEREFORE I, Richard Gardiner, Baron Casey, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, hereby fix the first day of January, One thousand nine hundred and sixty-eight, as the date on which the Narcotic Drugs Act 1967 shall come into operation.

GIVEN under my Hand and the Great Seal of the Commonwealth this twenty-seventh day of December in the year of (L.S.) Our Lord, One thousand nine hundred and sixty-seven, and in the sixteenth year of Her Majesty's reign.
