I, KENNETH McCOLL ANDERSON, Minister of State for Customs and Excise, in pursuance of the powers conferred on me by Part XVI. of the Customs Act 1901-1967, and all other enabling powers, hereby make the by-laws set out in the Schedule hereto.

By-law No. S596

Item No. 20
Second Schedule

1. This by-law may be cited as Customs By-law No. S596.
2. This by-law shall be deemed to have taken effect on and from 1 July 1967.
3. Item 20 in Part I. of the Second Schedule to the Customs Tariff 1966-1967, applies to goods described in the second column of the Table hereunder that are goods to which the item in Part II. of the First Schedule to the Customs Tariff 1966-1967, listed in the first column of that Table opposite those goods, applies.

3. Item 19 in Part I. of the Second Schedule to the Customs Tariff 1966-1967, applies to goods described in the second column of the Table hereunder that are goods to which the item in Part II. of the First Schedule to the Customs Tariff 1966-1967, listed in the first column of that Table opposite those goods, applies.

Item No. 12
Second Schedule

1. This by-law may be cited as Customs By-law No. S600.

Registered at the General Post Office, Melbourne, for transmission by post as a newspaper

2. Item 12 in Part I. of the Second Schedule to the Customs Tariff 1966-1967, applies to:

Cylinders, imported containing industrial gases, subject to security that the cylinders when emptied will be exported without being put to any other commercial use

3. In this by-law 'security' means that security shall be given to and to the satisfaction of the Collector and that the giving of such security is a condition subject to which this item applies to the goods or the class or kind of goods so conditioned.

By-law No. S601

Item No. 34 Second Schedule

1. This by-law may be cited as Customs By-law No. S601.

2. Item 34 of Part I. of the Second Schedule to the Customs Tariff 1966-1967, applies to:

(1) Goods imported for repair or alteration (but not for industrial processing) and intended to be exported, under security

(2) Containers, imported empty, for industrial processing, under security, as follows:

(a) Collapsible, for the purpose of being filled with flour and to be exported forthwith

(b) Cylinders, for the purpose of being filled with liquid chlorine and to be exported forthwith

(c) For the purpose of being filled with butane gas and to be exported forthwith

(d) For the purpose of being filled with radio active isotopes, and to be exported forthwith

(e) Inner, specially designed for the transport of fourdrinier wires, for loading therewith and to be exported forthwith

(3) Other goods as follows:

(a) Aircraft, imported unassembled, for the purpose of being assembled and to be exported forthwith, under security

(b) Ink for use in stamping eggs beings eggs that are to be exported forthwith, under security

(c) Lenses, ophthalmic prescription, imported for high vacuum metallic film coating and to be exported forthwith, under security

(d) Sensitised paper paperboard and cloth exposed but not developed, and sensitised plates and film exposed but not developed, negative or positive, being goods:

(i) that fall within item 37.03 or 37.04 in Part II. of the First Schedule to the Customs Tariff 1966-1967;

(ii) have been imported for industrial processing, that is to say, developing, whether or not the developed goods are used in further industrial processes; and

(iii) that are, unless the Minister otherwise approves, to be exported on completion of the industrial processing.

3. In this by-law 'security' means that security shall be given to and to the satisfaction of the Collector and that the giving of such security is a condition subject to which this item applies to the goods or the class or kind of goods so conditioned.

4. Customs By-laws Nos S19, published in Gazette No. 17 dated 18 February 1966; S47, published in Gazette No. 28 dated 31 March 1966; S523, published in Gazette No. 70 dated 10 August 1967; are revoked.

By-law No. S602

Item No. 19 Second Schedule

1. This by-law may be cited as Customs By-law No. S602.

2. Customs By-law No. S8 published in Gazette No. 17 dated 18 February 1966, is amended as follows:

Omit:

"Item 82.04 Stocks, chaser pattern".

By-law No. S603

Item No. 19 Second Schedule

1. This by-law may be cited as Customs By-law No. S603.

2. Item 19 in Part I. of the Second Schedule to the Customs Tariff 1966-67, applies to goods that:

(a) are described in the second column of the Table hereunder and to which the item in Part II. of the First Schedule to the Customs Tariff 1966-1967, listed in the first column of that Table opposite those goods, applies; and

(b) are:

(i) in direct transit to Australia on 19 October 1967, and are entered for home consumption within 21 days after importation; or

(ii) in bond in Australia on 19 October 1967, and are entered for home consumption on or before 10 November 1967

2. Item 19 in Part I. of the Second Schedule to the Customs Tariff 1966-1967, applies to goods described in the second column of the Table hereunder that are goods to which the item in Part II. of the First Schedule to the Customs Tariff 1966-1967, listed in the first column of that Table opposite those goods, applies.
