#### NOTICE OF INTENTION TO PROPOSE CUSTOMS TARIFF ALTERATION

NOTICE No. 15 (1969)

IN pursuance of section 273EA of the Customs Act 1901–1968, I, DONALD LESLIE CHIPP, Minister of State for Customs and Excise, hereby give notice that it is intended, within seven sitting days of the House of Representatives after the date of the publication of this notice in the Gazette, to propose in the Parliament a Customs Tariff alteration in accordance with the particulars specified in the Schedule to this notice and operating on and from the thirtieth day of December, One thousand nine hundred and sixty-nine.

#### THE SCHEDULE

#### AMENDMENTS OF PART II. OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF 1966-1969

- 1. After note 7 to Chapter 15 insert the following note:-
  - "8. The following goods are specified for the purposes of paragraphs 15.07.93 and 15.07.99, sub-item 15.08.1 and paragraphs 15.08.91 and 15.08.92, that is to say, goods that—
    - (a) were in transit to Australia on 12 November 1969; and
    - (b) are entered for home consumption within 21 days after importation.".
