## PROCLAMATION

Commonwealth of  
Australia to wit  
CASEY  
Governor-General.

By His Excellency the Governor-General  
in and over the Commonwealth of  
Australia.

WHEREAS, by the Commonwealth Electoral Act 1918-1966, it is enacted that each Division shall be divided into Subdivisions, and the boundaries of each Subdivision shall be as specified by proclamation:

And whereas, by the said Act, it is also enacted that new Rolls for any Subdivisions, Divisions, or States shall be prepared whenever directed by proclamation, and that the proclamation may specify the manner in which the Rolls shall be prepared:

And whereas by a Proclamation published in the Gazette of the twenty-fifth day of November, 1968, it was proclaimed that the Electoral Divisions of the States of New South Wales and Victoria shall be divided into Subdivisions as set out in the Schedule to the said Proclamation:

And whereas it is desirable that the Electoral Divisions of the said States specified in the Schedule to this Proclamation shall be divided into Subdivisions differing from those set out in the Schedule to the aforesaid Proclamation:

Now therefore I, Richard Gardiner, Baron Casey, the Governor-General aforesaid, acting with the advice of the Federal Executive Council and in pursuance of the said Act do hereby declare and proclaim:

- (1) That the Electoral Divisions of the States of New South Wales and Victoria specified in the Schedule to this Proclamation shall be divided into Subdivisions as set out in the Schedule to this Proclamation in lieu, to the extent they differ, of the Subdivisions as set out in the Schedule to the Proclamation published in the Gazette of the twenty-fifth day of November, 1968:
- (2) That new Rolls for the Subdivisions in New South Wales and Victoria specified in the Schedule to this Proclamation (other than those Subdivisions which as indicated in such Schedule are to remain as set out in the Schedule to the Proclamation published in the Gazette of 25 November 1968) shall forthwith be prepared by the Commonwealth Electoral Officers for those States, in accordance with this Proclamation:
- (3) That in preparing the new Rolls the Commonwealth Electoral Officer for each said State shall, as regards each Subdivision concerned, to the best of his means of information place on the Roll for that Subdivision the name of every person whose name is, at the date of the publication of this Proclamation in the Gazette, on the existing Roll for the State, and whose place of living is within the limits of that Subdivision:

- (4) That the Commonwealth Electoral Officer for each said State shall also place on the new Roll for any Subdivision concerned the name of each person, not on the existing Roll for the State, who has sent in a claim to be enrolled, and who he is satisfied is entitled to be enrolled for that Subdivision:
- (5) That where in consequence of this Proclamation or action thereunder (other than action by any elector), the enrolment of any elector is changed to a Subdivision which differs in name from the Subdivision for which he was enrolled prior to this Proclamation, the Commonwealth Electoral Officer for each said State shall give notice of the change as follows:
  - (a) where in the opinion of the Commonwealth Electoral Officer, a reasonably effective notice, generally applicable to all electors in a Subdivision whose enrolments have been changed can be given—by notice in the Gazette, and in some newspaper or newspapers circulating in the locality affected; and
  - (b) in other cases—by notice sent by post to each elector concerned:
- (6) That the Commonwealth Electoral Officer for each said State shall, forthwith after the preparation of the new Rolls is complete, notify, by notice in the Gazette, that new Rolls have been prepared, as directed by this Proclamation, and thereupon the new Rolls shall be the Rolls prepared for the purposes of the said Act.

## SCHEDULE

### STATE OF NEW SOUTH WALES

#### Subdivisions of Electoral Divisions

#### ELECTORAL DIVISION OF BANKS

##### Subdivision of Padstow

Commencing at the confluence of the middle of Georges River and Little Salt Pan Creek; and bounded thence by that creek and Reillys Creek upwards to Mars Street; by that street easterly, Virginius Street northerly, Uranus Road westerly, McGirr Street generally north-easterly and Baddeley Street northerly to the East Hills Railway; by that railway generally easterly to Salt Pan Creek and by that creek downwards and the middle of Georges River aforesaid upwards to the point of commencement.

##### Subdivision of Panania North

Commencing at the junction of Milperra Road and Queen Street; and bounded thence by that street southerly, Bransgrove Road westerly, and Carson Street generally south-easterly to the East Hills Railway; by that railway south-westerly to the northerly prolongation of Lucas Road; by that prolongation and road generally southerly, and Henry Lawson Drive north-westerly to a south-eastern boundary of a Recreation Reserve being Lot 4 of D.P.

203,348; by the south-eastern boundaries of that reserve and their south-westerly prolongation generally south-westerly to the middle of Georges River; by that river upwards to Milperra Bridge and by that bridge and Milperra Road aforesaid generally easterly to the point of commencement.

#### Subdivision of Panania South

Commencing at the junction of Virginius Street and Uranus Road; and bounded thence by that street southerly and Mars Street westerly to Reillys Creek; by that creek and Little Salt Pan Creek downwards and the middle of Georges River upwards to the south-westerly prolongation of a south-eastern boundary of a Recreation Reserve being Lot 4 of D.P. 203,348; by that prolongation and the south-eastern boundaries of that reserve generally north-easterly to Henry Lawson Drive; by that drive south-easterly and Lucas Road and its prolongation generally northerly to the East Hills Railway; by that railway north-easterly to Carson Street; by that street southerly and Weston Street and Uranus Road aforesaid easterly to the point of commencement.

#### Subdivision of Revesby

Commencing at the junction of Queen Street and Milperra Road; and bounded thence by that road generally easterly and Canterbury Road generally north-easterly to Salt Pan Creek; by that creek downwards to the East Hills Railway; by that railway generally westerly to Baddeley Street; by that street southerly, McGirr Street generally south-westerly, Uranus Road and Weston Street westerly, Carson Street generally north-westerly, Bransgrove Road easterly and Queen Street aforesaid northerly to the point of commencement.

And the Subdivisions of Hurstville West, Peakhurst, Peakhurst East and Riverwood as set out in the Schedule of the Proclamation published in the Gazette of 25 November 1968.

### ELECTORAL DIVISION OF BARTON

#### Subdivision of Kogarah

Commencing at the intersection of the Illawarra Railway and Harrow Road; and bounded thence by that road south-easterly, Princes Highway southerly, Rocky Point Road south-easterly, and Ramsgate Road and The Causeway westerly to a stormwater channel on the western boundary of Claydon Reserve; by that channel southerly to the western shore of Kogarah or Townsons Bay; by that shore south-westerly to Kogarah Bay Creek; by that creek upwards to Princes Highway aforesaid; by that highway north-easterly, Francis Street north-westerly, Tanner Avenue north-easterly and Andover Street and its prolongation north-westerly to the Illawarra Railway aforesaid, and by that railway generally north-easterly to the point of commencement.

#### Subdivision of Langlea

Commencing at the intersection of Hillcrest Avenue and King Georges Road; and bounded thence by that road and Princes Highway south-easterly and Bunyala Street northerly to the watercourse and channel partly forming the south-western boundary of Carss Park; by that watercourse and channel south-easterly to the western shore of Kogarah or Townsons Bay; by that shore north-easterly to Kogarah Bay Creek; by that creek upwards to Princes Highway aforesaid; by that highway north-easterly, Francis Street north-westerly, Tanner Avenue north-easterly and Andover Street and its prolongation north-westerly to the Illawarra Railway; by that railway generally westerly to the overhead bridge between Treacy Street and Railway Parade; by that bridge south-westerly to Railway Parade aforesaid; by that parade south-westerly, Woniora Road north-westerly and Hillcrest Avenue aforesaid south-westerly to the point of commencement.

And the Subdivisions of Arrowsmith Park, Brighton-le-Sands, Connells Point, Mortdale, Oatley, Ramsgate, and Sans Souci as set out in the Schedule of the Proclamation published in the Gazette of 25 November 1968.

### ELECTORAL DIVISION OF BENNELONG

#### Subdivision of Gladesville

Commencing on the northern shore of Parramatta River at Mount Street at the mouth of Tarban Creek; and bounded thence by a line southerly to Tarban (Huntley's) Point; by the northern shore of Parramatta River generally westerly to the south-western prolongation of Charles Street; by that prolongation and street north-easterly, Victoria Road westerly, Providence Road north-easterly, Buffalo Road south-easterly, and Cressy Road north-easterly to Buffalo Creek; by that creek and the right bank of Lane Cove River down-

wards to the north-easterly prolongation of Park Road; by that prolongation and road and Augustine Street south-westerly to a stormwater channel running into Tarban Creek; by that channel south-easterly and the left bank of Tarban Creek downwards to the point of commencement.

#### Subdivision of Mowbray

Commencing at the intersection of Boundary Street and the Hornsby-Wynyard Railway; and bounded thence by that railway south-easterly to Mowbray Road; by that road south-westerly, and Mowbray Road West and its western prolongation, generally westerly to the left bank of Lane Cove River; by that bank, Blue Gum Creek and a northern branch of that creek upwards to the south-westerly prolongation of Corona Avenue; by that prolongation and avenue north-easterly, Pacific Highway south-easterly and Boundary Street aforesaid north-easterly to the point of commencement.

#### Subdivision of North Ryde

Commencing at the intersection of Vittoria Road and Balaclava Road; and bounded thence by the latter road and its prolongation north-easterly to the left bank of Lane Cove River; by that bank downwards to Lane Cove Road at De Burghs Bridge; by that road and Pittwater Road generally southerly, Wicks Road south-westerly, Twin Road north-westerly, Goulding Road and Lane Cove Road aforesaid south-westerly, Quarry Road and North Road generally north-westerly, Watts Road north-easterly, Bridge Road north-westerly, Herring Road north-easterly and Vittoria Road aforesaid north-westerly to the point of commencement.

#### Subdivision of Ryde East

Commencing at the junction of Cressy Road and Quarry Road; and bounded thence by the latter road north-westerly, Lane Cove Road and Goulding Road north-easterly, Twin Road south-easterly, Wicks Road north-easterly, Pittwater Road and Lane Cove Road aforesaid generally northerly to the left bank of Lane Cove River at De Burghs Bridge; by that bank downwards to the north-easterly prolongation of Park Road; by that prolongation south-westerly to the right bank of Lane Cove River; by that bank and Buffalo Creek upwards to Cressy Road aforesaid and by that road north-easterly to the point of commencement.

And the Subdivisions of Gore Hill, Greenwich, Hunters Hill, Lane Cove, Ryde Central, Wollstonecraft and Wollstonecraft East as set out in the Schedule of the Proclamation published in the Gazette of 25 November 1968.

### ELECTORAL DIVISION OF BEROWRA

#### Subdivision of Beecroft

Commencing at the junction of New Line Road and Boundary Road; and bounded thence by New Line Road, Castle Hill Road and Pennant Hills Road generally south-easterly, North Rocks Road and Plympton Road north-easterly and Midson Road north-westerly and north-easterly to Devlins Creek; by that creek downwards to Boundary Road aforesaid; by that road, a line crossing the Main Northern Railway and again that road generally north-westerly to the point of commencement.

#### Subdivision of Cheltenham East

Commencing at the intersection of Devlins Creek and the western prolongation of Somerset Road; and bounded thence by that prolongation and road generally easterly to Terrys Creek; by that creek downwards, and the left bank of Lane Cove River and Devlins Creek aforesaid upwards to the point of commencement.

And the Subdivisions of Berowra, Galston, Hornsby, Normanhurst, Pennant Hills, Pymble West and Turramurra South as set out in the Schedule of the Proclamation published in the Gazette of 25 November 1968.

### ELECTORAL DIVISION OF BLAXLAND

#### Subdivision of Bass Hill

Commencing at the intersection of the Hume Highway and Prospect Creek; and bounded thence by that creek and Georges River downwards to the western prolongation of Rabaul Road; by that prolongation and road easterly to the western boundary of Bankstown Aerodrome; by that boundary generally northerly and a northern boundary generally easterly to Marion Street; by that street generally easterly, Saltash Street northerly and Hume Highway aforesaid generally north-westerly to the point of commencement.

**Subdivision of Chester Hill**

Commencing at the intersection of Miller Road and Gurney Road; and bounded thence by the latter road generally north-easterly and Campbell Hill Road northerly to the Sydney Water Supply Pipe Line; by that pipe line south-easterly to Hector Street; by that street southerly, Spencer Street easterly, Rose Street southerly, Hume Highway generally north-westerly and Miller Road aforesaid northerly to the point of commencement.

**Subdivision of Condell Park**

Commencing at the intersection of the western prolongation of Rabaul Road and Georges River; and bounded thence by that river downwards to Milperra Bridge; by that bridge and Milperra Road generally easterly, Canterbury Road and Chapel Road South north-easterly, Shenton Avenue north-westerly, Oxford Avenue northerly, Marion Street generally westerly to a northern boundary of Bankstown Aerodrome; by that boundary generally westerly and the western boundary generally southerly to Rabaul Road and by that road and its prolongation westerly to the point of commencement.

**Subdivision of Villawood East**

Commencing at the junction of Miller Road and Hume Highway; and bounded thence by that highway generally north-westerly and Woodville Road northerly to the Regents Park-Liverpool Railway; by that railway easterly to Miller Road aforesaid; and by that road southerly to the point of commencement.

And the Subdivisions of Bankstown North, Bankstown South, Carramar, Chullora, Enfield West, Greenacre, Potts Hill, Sefton and Yagoona as set out in the Schedule of the Proclamation published in the Gazette of 25 November 1968.

**ELECTORAL DIVISION OF CALARE****Subdivision of Canowindra**

Commencing at the junction of Reedy Creek and the southern boundary of the Parish of Mandagery, County of Ashburnham; and bounded thence by that boundary easterly to Mandagery Creek; by that creek upwards and the southern boundary of Parish of Gregra easterly to Boree Creek; by that creek downwards to a southern boundary of portion 224, Parish of Boree Cabonne; by that boundary, a western boundary and another southern boundary easterly, southerly and again easterly to a road forming the eastern boundary of portion 234; by that road and its continuation forming the eastern boundaries of portions 183, 184, 165, 156 and the eastern boundary of portion 115 generally southerly to Oaky or Bourimbla Creek; by that creek downwards to the western boundary of portion 169, Parish of Bowan, by that boundary, the western and part of a southern boundary of portion 215 and the eastern boundary of portion 173 generally southerly, the southern boundaries of the lastmentioned portion and portions 17, 7 and 6 and their prolongation westerly to a public road (R. 13,884-1,603) within portion 299; by that road and its continuation forming the western boundaries of portions 288, 176 and 177 through portions 177, 251, 166 and 298, Parish of Bowan, and portions 154, 189, 77, 203, 120 and 121, Parish of Toogong, forming the south-eastern boundary of portion 261 and the western boundary of portion 175 generally south-westerly to the southern boundary of that portion; by that boundary easterly and the road forming the western boundary of portion 105 southerly to the northern boundary of the Parish of Nyrang; by that boundary and the eastern boundary of that parish easterly and southerly to the northern boundary of the Parish of Collett; by that boundary generally easterly to Canomodine Creek; by that creek downwards, Belubula River and Limestone Creek upwards to the Mid-western Highway; by that highway generally south-westerly to a road from Woodstock to Canowindra; by that road north-westerly and Sheet of Bark Creek downwards to the southern boundary of the Parish of Walli, County of Bathurst; by that boundary and the southern boundaries of the Parishes of Tenandra and Billimari generally westerly to Lachlan River; by that river upwards to Merriganowry Lagoon; by that lagoon northerly and the northern boundary of portion 32, Parish of Merriganowry, County of Forbes westerly to the Lachlan Valley Way (Trunk Road No. 56); by that road generally north-westerly to the northern boundary of the Parish of Merriganowry; by that boundary generally westerly to Pipe Clay Creek; by that creek upwards to the northern boundary of portion 134, Parish of Gooloogong; by that boundary, part of an eastern and the southern boundary of portion 109 westerly, southerly and again westerly to Kangaroo Creek; by that creek and Warrumba or Back Creek upwards to a point south-west of the confluence of Native-Dog and Warraderry Creeks; by a line north-westerly to that confluence of these creeks; by Goonigaldoorigang Creek and Lachlan River aforesaid downwards to a northern boundary of the Parish of Waugan, County of

Ashburnham; by that boundary easterly, the western boundaries of that parish and the Parish of Wise generally northerly, the northern boundary of the latter parish generally easterly and the western and northern boundaries of the Parish of Wanera northerly and generally easterly to Moura or Waterhole Creek; by that creek upwards and Croker's Range generally north-easterly to the railway from Parkes to Molong near Bumberby Platform; by that railway north-easterly and the western boundary of the Parish of Dulladerry, southerly to Dulladerry Creek; by that creek downwards and the western boundary of the Parish of Mandagery generally southerly to Reedy Creek aforesaid and by that creek downwards to the point of commencement.

**Subdivision of Parkes**

Commencing at the north-western corner of the Parish of Yarragong, County of Ashburnham; and bounded thence by the boundary between the Counties of Ashburnham and Cunningham (partly formed by the Gunning Range), and the boundary between the Counties of Cunningham and Kennedy, generally northerly; the eastern and part of the northern boundaries of the Parish of Coradgery West, County of Kennedy and the eastern boundary of the Parish of Tanilago generally northerly to Back or Genaren Creek; by that creek downwards to the south-eastern boundary of the Parish of Graddle; by that boundary generally north-easterly to the Bogan River; by that river downwards and Tomingley Creek upwards to a road from Tomingley to Dubbo; by that road generally north-easterly to Tanners Creek; by that creek upwards to Herveys Range; by that range, Curumbenya Range and Crokers Range generally south-easterly to Moura or Waterhole Creek; by that creek downwards to the northern boundary of the Parish of Wanera, County of Ashburnham; by that boundary generally westerly, its western boundary southerly, the northern boundary of the Parish of Wise, part of the eastern boundary of the Parish of Dowling, the northern boundaries of that parish and the Parish of Mumidgle, and part of the eastern and the northern boundary of the Parish of Yarragong aforesaid generally westerly to the point of commencement.

And the Subdivisions of Bogan Gate, Cumnock, Forbes, Gulgong, Milthorpe, Molong, Mudgee, Orange, Orange East, Stuart Town, Trundle, and Wellington as set out in the Schedule of the Proclamation published in the Gazette of 25 November 1968.

**ELECTORAL DIVISION OF CHIFLEY****Subdivision of Lalor Park**

Commencing at the junction of Meurants Land and Old Windsor Road; and bounded thence by that road south-easterly to Toongabbie Creek; by that creek downwards to the Blacktown-Carltingford Electricity Transmission Line; by that transmission line westerly to the Main Western Railway; by that railway generally westerly to the southern prolongation of Stephen Street; by that prolongation and street northerly and north-westerly, Sunny Holt Road northerly and Meurants Lane aforesaid easterly to the point of commencement.

**Subdivision of Seven Hills**

Commencing at the junction of Seven Hills Road South and Blacktown Road; and bounded thence by the latter road generally north-westerly to a road through portion 112, Parish of Prospect, County of Cumberland; by that road generally north-easterly to the Main Western Railway; by that railway generally easterly to the Blacktown-Carltingford Transmission Line; by that transmission line south-westerly to Best Road; by that road south-easterly and Cornelia Road and Seven Hills Road South aforesaid south-westerly to the point of commencement.

**Subdivision of Toongabbie**

Commencing at the intersection of Old Windsor Road and Toongabbie Creek; and bounded thence by that road south-easterly, Reynolds Street southerly, Fitzwilliam Road westerly and Ballandella Road southerly to the north-eastern prolongation of Mia Mia Street; by that prolongation and street south-westerly, Targo Road generally southerly, Gilba Road north-westerly, Girraween Road south-westerly, Great Western Highway westerly, Blacktown Road generally north-westerly, Seven Hills Road South and Cornelia Road north-easterly and Best Road north-westerly to Blacktown-Carltingford Electricity Transmission Line; by that transmission line north-easterly and easterly to Toongabbie Creek aforesaid and by that creek upwards to the point of commencement.

And the Subdivisions of Blacktown, Blacktown North, Cambridge Park, Mount Druitt, Mount Druitt South, and Rooty Hill as set out in the Schedule of the Proclamation published in the Gazette of 25 November 1968.

## ELECTORAL DIVISION OF COWPER

## Subdivision of Grafton South

Commencing at the confluence of Mole Creek and Little Nymboida River; and bounded thence by that river and Nymboida River downwards, Cloud's Creek and Horton's Creek upwards to the southern boundary of portion 4, Parish of Jardine, County of Fitzroy; by that boundary westerly to the boundary between the Counties of Fitzroy and Gresham; by that boundary generally north-westerly to the southern boundary of Parish of Duckan Duckan, County of Fitzroy; by that boundary and the southern boundary of Parish of Turville generally easterly, Orara River and the right bank of Clarence River downwards, the northern boundary of Parish of Clarence, County of Clarence, formed in part by Swan Creek, generally easterly, and the northern boundaries of the Parishes of Lavadia, Maryvale and Scope generally easterly to the shore of the South Pacific Ocean; by that shore generally southerly to Redbank River; by that river and Dirty Creek upwards to Pacific Highway at the south-east corner of portion 127, Parish of Corindi, County of Fitzroy; by that highway generally north-westerly to Halfway Creek at the north-eastern corner of portion 28, Parish of Dundoo, County of Clarence; by that creek, Dundoo Creek and Sherwood or Wongabi Creek downwards to Orara River; by that river upwards to the north-east corner of portion 7, Parish of Kremnos, County of Fitzroy; by the northern and western boundaries of that portion, western boundaries of portions 10, 8, 9, eastern and southern boundaries of portion 74, Parish of Tallawudjah, and the northern boundary of portion 71 southerly and westerly to the western boundary of the Parish of Tallawudjah; by that boundary and the western boundary of the Parish of Bagawa generally southerly to the north-western boundary of portion 15, Parish of Gundar; by that boundary south-westerly to Mole Creek; and by that creek downwards to the point of commencement.

## Subdivision of Kempsey

Commencing at the source of the Serpentine River in the Snowy Mountains and bounded thence by that river and Styx, Chandler and Macleay Rivers downwards and Kunderang Brook upwards to its source in the range forming the boundary between the County of Macquarie and the Counties of Vernon and Dudley; by that range generally north-easterly to the eastern boundary of portion 111, Parish of Kalateenee, County of Dudley; by that boundary generally north-easterly, the southern and eastern boundaries of portion 108 easterly and northerly to Euroka Creek; by that creek downwards to the southern boundary of portion 26; by that boundary and South Street, West Kempsey, easterly and East Street, northerly to the northern boundary of the unsectarian portion of a cemetery dedicated 8th June, 1895; by that boundary easterly, Craig Street, East Kempsey, north-easterly and Gill Street south-easterly to Macleay Street; by a line east 10 chains, lines parallel to Macleay Street and Washington Street north-easterly to Pola Creek; by that creek downwards and the boundary of Municipality of Kempsey north-easterly and westerly to the right bank of Macleay River; by that bank downwards to a point in the easterly prolongation of a southern boundary of portion 16, Parish of Cooroobongatti; by that prolongation and boundary westerly, the western boundaries of that portion and portion 70 northerly to the road on the northern boundary of portion 102; by that road and its continuation along the northern boundaries of portions 105, 168, 230 and 113, Parish of Cooroobongatti, and portions 119, 120, through 176 and 174, and along the northern boundaries of portions 147, 148, Parish of Yarrabandini, generally westerly to the eastern boundary of the Parish of Tanban; by that boundary and the northern boundary of that parish generally northerly and westerly to the range forming the boundary between the Counties of Dudley and Raleigh; and by that range and The Snowy Mountains Range aforesaid generally north-westerly to the point of commencement.

## Subdivision of Smithtown

Commencing on the shore of South Pacific Ocean at the range forming the boundary between the Counties of Dudley and Raleigh; and bounded thence by that range generally south-westerly to the northern boundary of the Parish of Tanban, County of Dudley; by that boundary easterly and the eastern boundary of that parish generally southerly to the northern boundary of portion 148, Parish of Yarrabandini; by that boundary and the northern boundary of portion 147 through 174 and 176 and along the northern boundaries of portions 120, 119, Parish of Yarrabandini, and portions 113, 230, 168, 105 and 102, Parish of Cooroobongatti, generally easterly to the western boundary of portion 70; by that boundary and the western boundary of portion 16, southerly and the southern boundary of the latter portion and its prolongation easterly to the right bank of the Macleay River; by that bank downwards and Kinchela Creek upwards to the southern boundary of the Parish of Arakoon,

County of Macquarie; by that boundary generally easterly to the shore of the South Pacific Ocean aforesaid; and by that shore generally northerly to the point of commencement.

## Subdivision of Ulmarra
