## NOTICE OF THE ACQUISITION OF LAND BY THE COMMONWEALTH

IT is hereby notified that His Excellency the Governor-General acting with the advice of the Federal Executive Council has authorised, pursuant to provisions of the Lands Acquisition Act 1955-1966, the acquisition by compulsory process of the land described in the attached Schedule for the following public purposes approved by the Governor-General, namely: For the purposes of road, water supply and electricity supply.

### THE SCHEDULE

- Part 1. All that piece or parcel of land in the Hundred of Bagot County of Palmerston Northern Territory of Australia containing an area of 3 acres 2 roods 20 perches more or less being part of Section 77 (Certificate of Title Volume 4 Folio 188) and being more particularly delineated as 'C' on Plan A hereunder.
- Part 2. All that piece or parcel of land in the Hundred of Bagot County of Palmerston Northern Territory of Australia containing an area of 6 acres 1 rood 23 perches more or less being Lot 6 of subdivision of Section 77 (Certificate of Title Volume 4 Folio 125) and being more particularly delineated as 'H' on Plan A hereunder.
