PROCLAMATION

Commonwealth of
Australia to wit
PAUL HASLUCK
Governor-General.

By His Excellency the Governor-
General in and over the Common-
wealth of Australia.

WHEREAS by sub-section (1.) of section 76 of the Public Service Act 1922-1968 it is provided that certain specified days or any days prescribed under the law of any State to be observed in lieu thereof in that State, shall be observed as public holidays in the Commonwealth Service:

AND WHEREAS by that sub-section it is further provided that the Governor-General may proclaim any day to be observed in lieu of any of the said days.

AND WHEREAS it is desired to make uniform provision for a holiday in the Commonwealth Service for the day following Christmas Day and the day to be observed in lieu thereof for 1970:

NOW THEREFORE I, Sir Paul Meernaa Caedwalla Hasluck, The Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby proclaim that the twenty-

eight day of December 1970 is to be observed as a holiday in the public offices of the Commonwealth in the States of South Australia and Western Australia and in the Territories of the Commonwealth, including the Australian Capital Territory, the Northern Territory of Australia, the Territory of Papua and the Territory of New Guinea, Norfolk Island and the Territory of Cocos (Keeling) Islands in lieu of the twenty-sixth day of December 1970 being the day following Christmas day.

GIVEN under my Hand and the Great Seal of the Commonwealth this fourteenth day of December in the year of (L.S.) Our Lord, One thousand nine hundred and seventy and in the nineteenth year of Her Majesty's reign.
