NOTICE OF INTENTION TO PROPOSE CUSTOMS TARIFF ALTERATION

NOTICE No. 2 (1970)

IN pursuance of section 273EA of the Customs Act 1901–1968, I, DONALD LESLIE CHIPP, Minister of State for Customs and Excise, hereby give notice that it is intended, within seven sitting days of the House of Representatives after the date of the publication of this notice in the Gazette, to propose in the Parliament a Customs Tariff alteration in accordance with the particulars specified in the Schedule to this notice and operating on and from the seventh day of April, One thousand nine hundred and seventy.

Customs Act 1901-1968 CUSTOMS TARIFF 1966-1969 SECOND SCHEDULE By-laws Nos S1189 and S1192

I, DONALD LESLIE CHIPP, Minister of State for Customs and Excise, in pursuance of the powers conferred on me by Part XVI. of the Customs Act 1901-1968, and all other enabling powers, hereby make the by-laws set out in the Schedule hereto.

THE SCHEDULE

By-law No. S1189

Item No. 19 Second Schedule

- 1. This by-law may be cited as Customs By-law No. S1189.
- 2. This by-law shall take effect on and from 7 April 1970.
- 3. Customs By-law No. S8, published in Gazette No. 17 dated 18 February 1966, is amended as follows:

Omit:

'Item 56.05 Yarns, composed of a mixture of man-made fibres and goathair, in which at least 40 per centum by weight is goathair, for use in the manufacture of interlinings for apparel, under security'.

4. Customs By-law No. S319, published in Gazette No. 104 dated 15 December 1966, is revoked.

By-law No. S1192

Item No. 20 Second Schedule

- 1. This by-law may be cited as Customs By-law No. S1192.
- 2. This by-law shall take effect on and from 7 April 1970.
- 3. Customs By-law No. S9, published in Gazette No. 17 dated 18 February 1966, is amended as follows:
 - (a) Omit:
 - 'Item 51.01 Yarn, cuprammonium rayon'.
 - (b) Omit: 'Item 56.04

Fibres, cuprammonium rayon, in short lengths suitable for spinning purposes, including such fibres in the form of sliver or tops'.

 - 'Item 56.05 Yarn, cuprammonium rayon'.

CUSTOMS TARIFF 1966-1969

SECTION 23

Substitutes and Imitations Notice No. 1 (1970)

I, DONALD LESLIE CHIPP, Minister of State for Customs and Excise, in pursuance of the powers conferred on me by Section 23 of the Customs Tariff 1966-1969 and all other enabling powers:

- (a) declare that I am of the opinion that goods of a kind specified in the first column of the table hereunder:
 - (i) are a substitute for goods of another kind specified in the second column of that table opposite those goods;
 - (ii) are intended to be or can be used as a substitute for goods of another kind specified in the second column of that table opposite those goods;
 - (iii) can be used for any purpose for which goods of another kind specified in the second column of that table opposite those goods can be used; or
 - (iv) are an imitation of goods of another kind specified in the second column of that table opposite those goods;
 and

- (b) direct that the duty in respect of goods specified in the first column of the table hereunder is the duty that would be applicable in respect of them, if they were goods of the kind specified in the second column of that table opposite those goods.
- 2. In this notice 'First Schedule' means the First Schedule to the Customs Tariff 1966-1969.
- 3. Unless the context otherwise requires in this notice in ascertaining whether goods fall within the terms of a reference or whether a reference applies to goods, regard shall be had to:
 - (a) the Rules for the Interpretation of the First Schedule set out in Part I. of the First Schedule to the Customs Tariff 1966-1969; and
 - (b) the notes to a Division of Part II. of the First Schedule to the Customs Tariff 1966-1969 or to a Chapter of such a Division that has application to the goods under their Tariff classification in Part II. of that First Schedule to the Customs Tariff 1966-1969.
- 4. This notice may be cited as Substitutes and Imitations Notice No. 1 (1970) and shall take effect on and after the seventh day of April 1970.
- 5. Substitutes and Imitations Notice No. 1, published in Gazette No. 15 dated 14 February 1966, is revoked.

The Table

First column

Embroidery, falling within subitem 58.10.9 in the First Schedule, being goods that—

> have embroidered designs occurring solely or principally at or near one or both selvedges; and

have a visible background composed of a woven textile fabric containing not less than 20 per centum by weight of man-made fibres calculated by reference to the weight of fibres in the visible background

Woven textile fabrics composed of not less than 20 per centum by weight of man-made fibres, being fabrics impregnated or coated with preparations of cellulose derivatives or of other artificial plastic materials amounting to not more than ½ ounce per square yard of fabric

Second column

Woven textile fabrics that have a composition, weight and weave identical to those of the visible background of the goods referred to in the column opposite

Woven textile fabrics of the same kind containing the same percentage by weight of man-made fibres, being fabrics not impregnated or coated with preparations of cellulose derivatives or of other artificial plastic materials

Customs Tariff (Dumping and Subsidies) Act 1961-1965 NOTICE UNDER SECTION 7

IN pursuance of Section 7 of the Customs Tariff (Dumping and Subsidies) Act 1961-1965, I, Donald Leslie Chipp, Minister of State for Customs and Excise, hereby notify that, after inquiry and report by the Tariff Board, I am satisfied that the undermentioned goods have been sold to an importer in Australia at an export price which is less than the normal value of the goods at the date of exportation and that injury has thereby been caused to an Australian industry:

Continuous filament polyamide (nylon) raw yarn falling within sub-paragraph 51.01.993 or 51.01.994 in the First Schedule to the Customs Tariff 1966-1969.

This Notice may be cited as 'Dumping and Subsidies Act Notice No. 95', and shall have effect in relation to all such goods exported on and after 2 November 1967.
