Continental Shelf (Living Natural Resources) Act

CONTROLLED AREA (AUSTRALIAN CONTINENTAL SHELF) NOTICE No. 1

IN pursuance of section 11 of the Continental Shelf (Living Natural Resources) Act 1968, I, John Douglas Anthony, the Minister of State for Primary Industry, hereby declare the area of the Australian continental shelf the short description of which is the "Queensland Division" to be a controlled area for the purposes of that Act in relation to any sedentary organisms included in a class of sedentary organisms to which that Act applies specified in the Schedule to this Notice.

THE SCHEDULE

Classes of Sedentary Organisms

1. Corals, of any kind, included in the Phylum *Coelenterata*, Class *Anthozoa* or Class *Hydrozoa*
2. Lace corals, of any kind, included in the Phylum *Ectoprocta*, Order *Cheilostomata* or Order *Cyclostomata*
3. Sea urchins included in the Phylum *Echinodermata*, Class *Echinoidea*
4. Bêche-de-mer
5. Bivalve molluscs (except scallops), including oysters, mother-of-pearl, pearl shell, mussels, clams, pipis, venus shells, cockles and razor fish
6. Gastropods (except sea hares, sea butterflies, sea slugs of the Order *Opisthobranchiata*, violet snails of the Family *Ianthinidae* and organisms of the Family *Heteropoda*), including abalone, green snail, trochus, triton shells, helmet shells, cone shells, bailer shells, winkles and cowries
