NOTICE OF INTENTION TO PROPOSE CUSTOMS TARIFF ALTERATION NOTICE No. 8 (1971)

IN pursuance of section 273EA, of the Customs Act 1901-1971, I, DONALD LESLIE CHIPP, Minister of State for Customs and Excise, hereby give notice that it is intended, within seven sitting days of the House of Representatives after the date of the publication of this Notice in the Gazette, to propose in the Parliament a Customs Tariff alteration in accordance with the particulars specified in the Schedule to this Notice and operating on and from the twenty-sixth day of July, One thousand nine hundred and seventy-one.

THE SCHEDULE

AMENDMENTS OF PART II. OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF 1966-1971

- 1. After note 13 to Chapter 84 insert the following notes:—
 - "14. The following goods are specified for the purposes of sub-item 84.52.1, that is to say—
 - - (i) were in transit to Australia on 9 June 1971; and
 - (ii) are entered for home consumption within 21 days after importation; or
 - (b) goods that-
 - (i) the Collector is satisfied were on firm order overseas on or before 1 January 1971; and
 - (ii) are entered for home consumption on or before 30 June 1972.
 - 15. The following goods are specified for the purposes of sub-item 84.55.2, that is to say, goods that—
 - (a) were in transit to Australia on 9 June 1971; and
 - (b) are entered for home consumption within 21 days after importation.".
- 2. Omit item 84.52, insert the following item:-

" 84.52	*Calculating machines; accounting machines, cash registers, postage-franking machines, ticket-issuing machines and similar machines, incorporating a calculating device:
