QUARANTINE PROCLAMATION No. 97G

Commonwealth of
Australia to wit
PAUL HASLICK
Governor-General.

By His Excellency the Governor-
General in and over the Com-
monwealth of Australia.

WHEREAS it is provided by section 12 of the Quarantine Act 1908-1969 that the Governor-General may, by proclamation, declare that any place beyond or in Australia is infected with a quarantinable disease, or that a quarantinable disease may be brought or carried from or through that place, and thereupon, and so long as the proclamation remains in force, that place shall be a proclaimed place within the meaning of that Act:

And whereas it is provided by section 5 of that Act, amongst other things, that, in that Act, unless the contrary intention

appears, 'quarantinable disease' means, amongst other diseases, cholera:

Now therefore I, Sir Paul Meernaa Caedwalla Hasluck, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, declare that cholera may be brought or carried from or through the territory of the Kingdom of Morocco.

Given under my Hand and the Great Seal of the Commonwealth this nineteenth day of August in the year of Our (L.S.) Lord One thousand nine hundred and seventy-one, and in the twentieth year of Her Majesty's reign.
