Banking Act 1959-1967

#### AUTHORITY TO CARRY ON BANKING BUSINESS

IN PURSUANCE of sub-section (3.) of section nine of the Banking Act 1959-1967, I, Sir Paul Meernaa Caedwalla Hasluck, the Governor-General in and over the Commonwealth of Australia, acting with the advice of the Federal Executive Council, hereby grant to Bank of New Zealand Savings Bank Limited an authority to carry on banking business in Australia subject to the following condition:

Except with the consent, in writing, of the Treasurer, Bank of New Zealand Savings Bank Limited shall not establish an office, branch or agency of the bank at any places in Australia other than—

- (a) the premises known as 333-339 George Street, Sydney, New South Wales; and
- (b) the premises known as 347 Collins Street, Melbourne, Victoria.

AND I DECLARE that Bank of New Zealand Savings Bank Limited shall be deemed to be a bank specified in Part II. of the First Schedule to the Banking Act 1959-1967.
