Honey Industry Act 1962-72

HONEY INDUSTRY (ELECTION OF BOARD) REGULATIONS

IN pursuance of regulation 5 of the Honey Industry (Election of Board) Regulations, I, Ian McCahon Sinclair, the Minister of State for Primary Industry, hereby direct that a poll shall be held to elect one industry member of the Australian Honey Board from each of the States of New South Wales, Victoria, Queensland, South Australia and Western Australia to represent honey producers in each of these States to hold office for the period commencing the first day of November 1972 and ceasing on the thirtieth day of June 1975.

I also give notice, pursuant to regulations 7 (3), 12 (2) and 19 (2) of the Honey Industry (Election of Board) Regulations, that for the purpose of the aforesaid election:

- (a) the date on or before which applications for enrolment are to be lodged with the Deputy Returning Officer shall be twelve o'clock noon on the eighth day of September 1972
- (b) the date on or before which nominations are to be lodged with the Deputy Returning Officer shall be twelve o'clock noon on the eighth day of September 1972
- (c) the addresses at which applications for enrolment and nominations are to be lodged shall be, respectively—
 - (i) in the case of the election of the member from the State of New South Wales—the Deputy Returning Officer, Commonwealth Electoral Office, 162-166 Goulburn Street, Sydney, N.S.W., 2000;

- (ii) in the case of the election of the member from the State of Victoria—the Deputy Returning Officer, Commonwealth Electoral Office, Commonwealth Centre, Cnr. Spring & Latrobe Streets, Melbourne, Vic., 3000;

- (iii) in the case of the election of the member from the State of Queensland—the Deputy Returning Officer, Commonwealth Electoral Office, Coronation House, 109-117 Edward Street, Brisbane, Qld, 4000;

- (iv) in the case of the election of the member from the State of South Australia—the Deputy Returning Officer, Commonwealth Electoral Office, South British Insurance Building, 83-89 Currie Street, Adelaide, S.A., 5000;

- (v) in the case of the election of the member from the State of Western Australia—the Deputy Returning Officer, Commonwealth Electoral Office, Commonwealth Centre, 1-3 St George's Terrace, Perth, W.A., 6000

(d) the date on which the poll shall close shall be twelve o'clock noon on the eighteenth day of October 1972.
