Australian Government Gazette is published sectionally in accordance with the arrangements set out below:

Public Service issues contain notices concerning administrative matters, including examinations, vacancies, transfers and promotions within the Australian Public Service. These issues are published weekly at 10.30 a.m. on Thursday, and are sold at 95c each plus postage or on subscription of \$58.00 (50 issues), \$32.00 (25 issues), or \$16.00 (12 issues).

General issues contain notices under the following headings: *Special information* (i.e. notices in connection with the Office of the Governor-General; the Federal Executive Council; the Parliament; the Judiciary; the Executive Government; and honours, decorations and awards); *Proclamations*; *Legislation* (Acts of Parliament assented to; Statutory Rules; Ordinances; Regulations); *Customs*; *Government departments* (i.e. notices not placed in other categories, alphabetically listed under departments administering particular legislation or functions); *Defence Force appointments, promotions, etc.*; *Teaching Service vacancies, promotions, etc.*; *Bankruptcy Act*; *Private advertisements*; *Tenders invited*; *Contracts arranged*; *Late notices*. Copies of each week's Special issues are also attached. General issues are published weekly at 10.30 a.m. on Tuesday and are sold at 65c each plus postage or on subscription of \$46.00 (50 issues), \$26.00 (25 issues), or \$13.00 (12 issues). Annual subscription includes quarterly index issues.

Special issues are made on urgent matters as required. Single copies are available on the day of issue at various prices according to size, and they are also provided at no extra charge with weekly General issues. Special issues are not available on separate subscription.

Periodic issues contain lengthy notices of a non-urgent nature, including the following: Certificates of Australian Citizenship; Registered Tax Agents; Authorised Celebrities; Australian Capital Territory Health Registers; Unclaimed moneys; Consolidated Customs by-laws, etc.; Consolidated notices of Australian Public Service appointment, recruitment and examination conditions; Appointments to the Australian Public Service. Issues are made at irregular intervals as required, at individual prices according to size. Advice of availability is given in the contents list of the General and Public Service issues immediately following the day of publication. Periodic issues are not available on subscription, but standing orders are accepted for all or selected issues.

Index issues contain an index of a limited number of entries in certain sections of Public Service issues, and all entries in the General issues except names in the Bankruptcy Act section. Index issues are published quarterly and are sold at 20c each plus postage. They are supplied without charge to annual subscribers to the General issues, but are not otherwise available on subscription.

SUBSCRIPTIONS are payable in advance. Rates include surface postage in Australia and overseas. Other carriage rates are available on application.

QUARANTINE PROCLAMATION No. 72 P

WHEREAS it is provided by sub-section 13 (1) of the *Quarantine Act* 1908, amongst other things, that the Governor-General may, by proclamation, prohibit the importation into Australia of any plants or any parts of plants:

AND WHEREAS it is provided by sub-section 13 (2) of that Act that the power of prohibition under section 13 of that Act shall extend to authorize prohibition generally or with limitations as to place and subject matter, and either absolutely or subject to any specified conditions or restrictions:

AND WHEREAS it is desirable that the importation into Australia of the seed of a plant of the species *Cyamopsis tetragonolobus* (L.) and the seed of a plant of the species *Cicer arietinum* L. be prohibited subject to a specified condition or restriction:

NOW THEREFORE I, Sir John Robert Kerr, the Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, hereby prohibit the importation into Australia of the following parts of plants:—

- (a) seed of a plant of the species *Cyamopsis tetragonolobus* (L.) (guar); and
- (b) seed of a plant of the species *Cicer arietinum* L. (chick-pea),

unless the Director of Quarantine or an officer authorized by him has, by instrument in writing, consented to the importation of the parts of plants and the instrument is produced to a quarantine officer or a Collector within the meaning of the *Customs Act* 1901.

*Student Assistance Act 1973***DIRECTION UNDER SUB-SECTION 17(4)**

I, JOHN LESLIE CARRICK, the Minister of State for Education, in pursuance of sub-section 17(4) of the *Student Assistance Act 1973* hereby:

- (1) revoke the direction under sub-section 17(4) of that Act made by the Minister of State for Education by instrument dated 24 May 1976 and published in *Gazette* No. G 24 on 15 June 1976, and

- (2) direct that—

- (a) the decision of an authorized person who—
(i) dies; or
(ii) otherwise ceases to be an authorized person,

being a person who was an authorized person by virtue of his having performed the duties of an office in the Department of Education specified in column 1 in the table in the Schedule, shall, for the purposes of Part V of that Act, be deemed to be the decision of the authorized person (if any) for the time being performing the duties of that office or, if no person is performing the duties of that office, the authorized person for the time being performing the duties of the office in the Department of Education specified in column 2 opposite the first-mentioned office.

Foreign Proceedings (Prohibition of Certain Evidence) Act 1976

ORDER BY THE ATTORNEY-GENERAL

WHEREAS a foreign Tribunal, namely, the District Court for the Eastern District of Virginia in the United States of America has issued a Letter of Request dated 21st day of October 1976 directed to the Chief Justice and Judges of the Supreme Court of New South Wales in proceedings described as *In Re Westinghouse Electric Corporation Uranium Contract Litigation—M.D.L. Docket No. 235*;

AND WHEREAS the said Letter of Request requests the Chief Justice and Judges of the Supreme Court of New South Wales to summon the persons named in the Schedule to this Order to attend before a person appointed for that purpose to give evidence relating to the matters in dispute in the said proceedings and to produce to the person so appointed the documents described in Schedule C to the Letter of Request (hereinafter referred to as 'the said Schedule');

AND WHEREAS I, ROBERT JAMES ELLICOTT, Attorney-General for the Commonwealth of Australia, am satisfied that the imposition of the restrictions provided for in this Order is desirable for the purpose of protecting the national interest in relation to matters to which the laws and executive powers of the Commonwealth relate;

NOW I, ROBERT JAMES ELLICOTT, aforesaid, DO HEREBY, pursuant to section 5 of the *Foreign Proceedings (Prohibition of Certain Evidence) Act 1976* PROHIBIT any person, except with the consent of the Attorney-General in writing, from—

1. producing any document described in the said Schedule before the said Supreme Court of New South Wales or any other Tribunal in Australia for the purposes of the said proceedings in the said foreign Tribunal,
2. giving evidence, whether in relation to the contents of any document described in the said Schedule or otherwise, before the said Supreme Court of New South Wales or any other Tribunal in Australia for the purposes of the said proceedings in the said foreign Tribunal,
3. producing in or for the purposes of the said foreign Tribunal any document described in the said Schedule which, at the time of the making of this Order, or at any time while the Order remains in force, is in Australia,
4. doing any act in Australia in relation to any document described in the said Schedule which, at the time of the making of this Order, or at any time while the Order remains in force, is in Australia, with the intention that the Act will result in the said document being produced, or evidence of its contents being given, in or for the purposes of the said foreign Tribunal,
5. doing any act in Australia in relation to any document described in the said Schedule which, at the time of the making of this Order, or at any time while this Order remains in force, is in Australia, where there is reason to believe that the act will, or is likely to, result in the said document being produced, or evidence of its contents being given, in or for the purposes of the said foreign Tribunal,
6. giving, at a time when the person is an Australian citizen or is a resident of Australia, evidence before the said foreign Tribunal in relation to, or to the contents of, any document described in the said Schedule which, at the time of the making of this Order or at any time while the Order remains in force, is in Australia.

AND WHEREAS four of the defendants, namely Conzinc Rio Tinto of Australia Limited, Mary Kathleen Uranium Limited, Pancontinental Mining Limited and Queensland Mines Limited are companies incorporated in Australia;

AND WHEREAS another foreign tribunal, namely a grand jury has been empanelled in the District of Columbia of the United States of America to investigate possible violations of the anti-trust laws of the United States of America;

- (4) the giving by any person, at a time when he is an Australian citizen or is a resident of Australia, of evidence before any foreign tribunal in relation to, or to the contents of, a document in the said class of documents which at the time of the making of this Order or at any time while the Order remains in force is in Australia,
- (5) the production by any person of a document in the said class of documents before any tribunal in Australia for the purposes of proceedings in any foreign tribunal,

- (6) the giving of evidence by any person, whether in relation to the contents of a document in the said class of documents or otherwise, before any tribunal in Australia for the purposes of proceedings in any foreign tribunal.

SCHEDULE 2

By-law No. S2462

I, JOHN WINSTON HOWARD, Minister of State for Business and Consumer Affairs, in pursuance of the powers conferred on me by Part XVI of the *Customs Act 1901*, and all other enabling powers, hereby make the by-law set out in the Schedule hereto.

In a by-law set out in the Schedule hereto a reference to:

- (a) an item;
- (b) a sub-item;

shall be read as a reference to that item, sub-item, paragraph or sub-paragraph as the case may be in Part II of Schedule 1 to the *Customs Tariff Act 1966*, as proposed to be altered.

Unless the context otherwise requires, where a description of goods is specified in a by-law set out in the Schedule hereto, the goods that fall within that by-law by virtue of that description are such goods as would fall within that description if it were specified in the tariff classification in Part II of Schedule 1 to the *Customs Tariff Act 1966*, as proposed to be altered, that applies to those goods.

Unless the context otherwise requires, any word or phrase used in a reference in a by-law set out in the Schedule hereto has the same meaning as if it were used in the tariff classification in Part II of Schedule 1 to the *Customs Tariff Act 1966*, as proposed to be altered, that applies to those goods to which that reference in the by-law applies.

THE SCHEDULE

1. This by-law may be cited as Customs By-law No. S2462.

2. This by-law shall take effect on and from 3 December 1976.
