An index to the Commonwealth of Australia Gazette was published annually 1901-73, and quarterly without annual cumulation 1974-81. From 1982 it has been published quarterly with annual cumulations.

Since 1985, the coverage of the index has been restricted. This index covers the special information, legislation and government departments sections only of the General (G) issues of the Gazette (which ceased after no. 16, 28 April 1987); and the full contents of the superseding Government Notices (GN) issues, as well as Special and Period issues of the Gazette. All other sections of the General Gazette and all other Gazette series, namely Business, Public Service, Purchasing and Disposals, and Tariff Concessions, are not indexed.

G and GN issues of the Gazette are paged continuously throughout the year and are indexed to the page number. S and P issues are indexed to the issue number.

The index allows access to notices by both subject and directly by names of individuals and organisations. Notices about the making and coming into force of legislation are indexed directly under the name of the legislation. Australian Capital Territory notices are treated in the same way. Notices about other Territories are indexed both directly in the manner described and under the name of the Territory.

The index is arranged alphabetically word by word. Each letter in an abbreviation that is spelt out when spoken has been treated as a single word ('BP', for example, precedes 'Ballarat'). Acronyms pronounced as words are treated as such and contractions are filed as if spelt in full 'St' ('Saint'), for example. Hyphenated expressions have been treated as two words. Prepositions etc. at the beginning of subheadings have been ignored in determining the order of subheadings.
