### OTHER ISSUES OF THE GAZETTE

DECLARATION UNDER REGULATION 3

DETERMINATION PURSUANT TO SUBREGULATION 4(2)

I, WILLIAM GEORGE HAYDEN, Governor-General of the Commonwealth of Australia, on the recommendation of the Minister of State for Defence Science and Personnel, hereby:


- (a) under regulation 3 of the Australian Service Medal Regulations which are set out in the Schedule to Letters Patent dated 13 September 1988, declare the Royal Australian Air Force assistance to the United Nations International Children's Emergency Fund in Vietnam during the period that commenced on 29 March 1975 and ended on 28 April 1975 to be a prescribed operation for the purposes of those Regulations; and
- (b) under subregulation 4(2) of those Regulations, determine that the conditions for the award of the Australian Service Medal in respect of that prescribed operation are:
  - (i) the Medal may be awarded to a member of the Royal Australian Air Force who rendered military service as such a member while posted to or serving with Transport Support Flight Butterworth or Headquarters Richmond Detachment S for a minimum of seven days during the period referred to in paragraph (a) for the purpose of assisting the United Nations International Children's Emergency Fund and who actually performed duty in Vietnam for all or part of that seven days; and
  - (ii) the Medal shall be awarded to members qualifying under subparagraph (b)(i) with the clasp "Vietnam 1975".

NOTICE OF INQUIRY INTOCANNED HAM FROM DENMARK,  
THE REPUBLIC OF IRELAND AND THE NETHERLANDS

The Australian Customs Service (ACS) has made a preliminary finding that there are sufficient grounds for the publication of dumping duty notices sought in respect of canned ham from Denmark, the Republic of Ireland and the Netherlands.

The ACS, acting under paragraph 269TD(2)(b) of the Customs Act 1901, has now referred the question of whether the publication of the dumping duty notices is so justified to the Authority. The commencement date for the inquiry is 20 September 1990 and the Authority will report to the Minister no later than 9 January 1991.

Interested parties are invited to make submissions to the Authority as soon as possible, but certainly no later than 29 October 1990. Preferably, submissions should address specific matters raised in the ACS report on its preliminary finding. Copies of that report can be obtained from the Office Manager, Dumping Control, ACS, Canberra, by telephoning (06) 275 6060.

Following receipt of submissions, it is possible that a meeting of parties will be arranged to explore issues raised. After that meeting, a further opportunity will be afforded parties to make submissions to the Authority on those issues.

The Authority has adopted the "public file" system used by the ACS and explained in Australian Customs Notice 87/169. Briefly, this means that a submission containing confidential material should be accompanied by another version, omitting the confidential material but containing the non-confidential summary, which can be made available to other parties to the inquiry. Three copies of each version are required.

  - (e) the operative Export Charge on cattle be increased by 115 cents per head of cattle slaughtered;
  - (f) the operative Export Charge on buffaloes be increased by 115 cents per head of buffaloes slaughtered;
- (B) That the date of implementation of the proposed increases be 1 May 1991.
- (C) That in the event of the introduction of a Transaction Levy/Beef Production Levy and revised Cattle Export Charge arrangements before the above recommendation becomes operative, the recommendations concerning cattle, calves and bobby calves shall be read as recommending increases in these levies and charges to raise the same total levy/charge as would be raised by the amended Live-stock Slaughter Levy and Live-stock Export Charge.

Sydney-Melbourne/Darwin Common Rating

As provided for in para 2.15 of the March 1987 CAR Report, the Committee determined that the common rating of fares on the Sydney-Melbourne/Darwin routes will continue to be based on a distance of 3400 kms."

In January 1990 the Committee determined a 5% fare increase for the trunk route (Jet) services operated by AAA and Australian (refer Gazette No. GN6 dated 14/2/90). The underlying reason for the fare increase was to partly offset the significant additional abnormal costs which AAA and Australian had incurred in their endeavours to maximise air services, and meet their obligations under the Airlines Agreement Act, during the period of disruption from August 1989 caused by the dispute between the airlines and the Australian Federation of Air Pilots (AFAP).

The Committee announced at the time that it would review the January determination but, under the provisions of the IAFC Act, the Committee had to wait until 23 July 1990 before commencing a review, during which both AAA and Australian formally requested a further increase in fares.

As part of its assessment, the Committee reviewed AAA's and Australian's latest available figures for the 1989-90 financial year, the operating results for which were adversely affected in a significant way by the impact of the dispute with the AFAP and by the downturn in the economy generally. In respect of the 1990/91 financial year, because the IAFC will cease operations on 30 October the Committee's review and determination were restricted to the four months ending 30 October 1990.

From a detailed examination of the extensive data submitted by the airlines, the Committee concluded that the 5% fare increase from January had achieved its stated objective. The Committee noted that although the circumstances had now changed, passenger traffic levels had not yet returned to those of previous years, and whilst there had been recent increases in aviation fuel and other costs, these were partly offset by a favourable exchange rate and productivity improvements in particular with flight crews.

However, on balance, the Committee concluded that the net effect of cost increases and other factors, including the substantial losses incurred by AAA and Australian as a result of the pilots' dispute, were sufficient to warrant the continuation of the 5% January fare increase, but that no further increase beyond this level was justified at this stage.

In making the determination, the Committee recognised that with the deregulation of interstate air services and air fares from 31 October 1990, AAA and Australian will be free to adjust fares at their discretion subject only to Government commercial regulation applicable to industry generally.

The approved one-way economy fares for Jet services on the main trunk routes remain as set out in Gazette No.GN6 dated 14/2/90.




