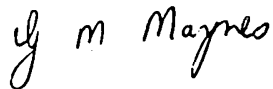

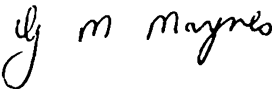

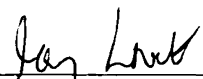

NATIONAL HEALTH ACT 1953

GUIDELINES UNDER SECTION 82F

I, BRIAN LESLIE HOWE, Minister of State for Health, Housing and Community Services, pursuant to section 82F of the National Health Act 1953 (the Act), hereby revoke the guidelines made on 20 January 1992 relating to the appointment of the Commissioner, and other members and deputies, to the Private Health Insurance Administration Council (the Council) established under section 82B of the Act and make the following guidelines:

a) Appointment of the Commissioner, other Members and Deputies

- 1) In view of the responsibilities of the Council as set out in section 82G of the Act, the Council should, as far as is possible, include persons who have training or experience in one or more of the accounting, auditing and actuarial fields;
- 2) As provided for by subsection 82C of the Act, the Commissioner shall be appointed on a part-time basis. Subsection 82E(3) of the Act provides that other members shall hold office on a part-time basis;
- 3) The Commissioner shall not be employed by, or associated in any official capacity with, a registered health benefits organisation;
- 4) For the purposes of section 82D of the Act, the following organisations as representatives of the large majority of registered health benefits organisations, shall each be asked to propose nominees for appointment as a member and deputy member on the Council:
 - . Australian Health Insurance Association Limited;
 - . Health Insurance Restricted Membership Association of Australia; and
 - . Medibank Private
- 5) The "other member" and deputy thereof for the purposes of section 82D of the Act shall be independent actuaries who are not employed by, or associated in an official capacity with, a registered health benefits organisation;

- 6) For the purposes of section 82PD of the Act, the appointment of deputies of members shall be made in accordance with the provisions of (4) and (5) above; and
- 7) Appointments will as far as possible have regard to the Commonwealth Government's objective of equal representation of women on industry bodies, boards and authorities.

b) Terms and Conditions of the Offices

- 1) As provided by section 82PE of the Act, the remuneration to be paid to the Commissioner and other members (including deputies of members) shall be as determined from time to time by the Remuneration Tribunal and any allowances payable shall be as prescribed.

c) Periods of Appointment

- 1) Appointments shall be made by the Minister. The Minister may for reasons of misbehaviour, physical or mental incapacity, bankruptcy or imprisonment remove an appointee from office at any time. Appointments shall however be deemed to expire after three years. Any appointee shall be eligible for reappointment.

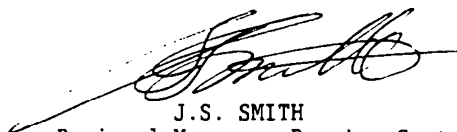

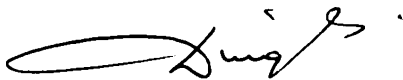

ANTI-DUMPING AUTHORITY**FINAL FINDING ON DRIED EGG WHITE FROM
THE NETHERLANDS AND SWEDEN**

The Anti-Dumping Authority has completed its inquiry following a complaint that dried egg white has been exported to Australia at dumped and subsidised prices and that the dumping and subsidisation had caused material injury to the Australian industry producing dried egg white.

In its report, the Authority concluded that:

- dried egg white has been imported from the Netherlands at subsidised prices and from Sweden at dumped prices;
- the Australian industry has suffered material injury;
- imports of DEW at subsidised prices from the Netherlands have caused material injury to the local industry producing DEW; and
- imports of DEW at dumped prices from Sweden have not caused material injury to the local industry producing DEW.

In the light of these conclusions the Authority recommended to the Minister for Small Business, Construction and Customs that countervailing action be taken against exports of dried egg white from the Netherlands but that no action be taken against exports from Sweden.

The Minister has accepted the Authority's recommendation.

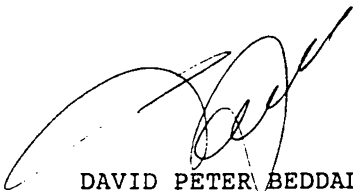

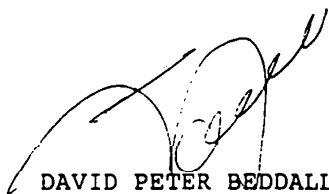

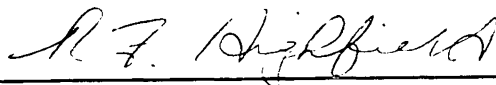

HISTORIC SHIPWRECKS ACT 1976

VARIATION TO DECLARATIONS OF HISTORIC SHIPWRECKS AND HISTORIC RELICS UNDER SECTION 5 AND DECLARATION OF PROTECTED ZONE UNDER SECTION 7

I, **WENDY FATIN**, Minister of State for the Arts and Territories, am of the opinion that the remains of the *HMS Porpoise* and *Cato* described in the Schedule, published in the Gazette of 12 April 1989, and the *Gothenburg* published in the Gazette of 22 October 1981 continue to be of historic significance.

Following a resurvey of the location of the *HMS Porpoise*, *Cato* and *Gothenburg* I hereby:

- (1) vary, under subsection 31(3) of the *Historic Shipwrecks Act 1976* the notice of declaration published in the Gazettes on 12 April 1989 and 22 October 1981, by deleting all reference to *HMS Porpoise*, *Cato* and the *Gothenburg* published in Columns 1, 2, 3 and 4 in the Schedule contained therein, and,
- (2) declare, under subsections 5(1) and 5(2) of the *Historic Shipwrecks Act 1976*, the remains of the ships described in the schedule below to be historic shipwrecks and all articles associated with them to be historic relics.

Further, under subsection 7(1) of the *Historic Shipwrecks Act 1976*, I hereby declare an area of 200 hectares as a protected zone, being the area of a circle of 797 metres radius, being an area of land and sea having as its centre the centre of the remains of *HMS Porpoise* and an area of 200 metres centred on the *Gothenburg* described in the schedule.

ANTI-DUMPING AUTHORITY

**FINAL FINDING: CANNED TOMATOES FROM
ITALY, SPAIN, THAILAND AND
THE PEOPLE'S REPUBLIC OF CHINA**

The Anti-Dumping Authority has completed its inquiry into canned tomatoes from Italy, Spain, Thailand and The People's Republic of China.

In its report, the Authority concluded that:

- . canned tomatoes exported to Australia from Italy, Spain and Thailand have been subsidised;
- . canned tomatoes have been exported to Australia from Italy, Spain, Thailand and China at dumped prices;
- . subsidised canned tomatoes from Italy, Spain and Thailand have caused material injury to the Australian canned tomato industry;
- . dumped canned tomatoes from Italy and China have caused material injury to the Australian canned tomato industry;
- . if countervailing and anti-dumping action is not taken the industry will continue to suffer material injury; and
- . dumped exports of canned tomatoes to Australia from Spain and Thailand have not caused material injury to the Australian canned tomato industry and there is not a threat of material injury from dumped exports from these countries.

The Authority recommended to the Minister for Small Business, Construction and Customs that he take countervailing action against exports of canned tomatoes from Italy, Spain and Thailand and that he take anti-dumping action against exports from Italy and China.

The Minister has accepted the Authority's recommendations.
