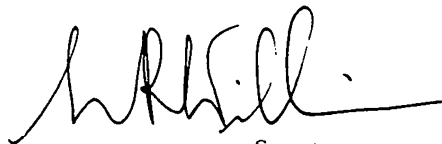

Notice pursuant to section 16 of the National Food Authority Act 1991

The National Food Authority has before it an application dated 27 March 1990 from Mr H W Rilk to amend the Food Standards Code to vary Standard P1 - Beer and Beer Products - to permit a beverage with 'not more than 0.5% alcohol' to be called 'beer'.

- The application was submitted prior to the commencement of the National Food Authority Act 1991 and continues in force by virtue of section 71 of the Act.

Having regard to what has been done by the National Health and Medical Research Council in consideration of this application, the Authority has decided, pursuant to sub-section 71(2), to omit to invite public submissions in relation to a full assessment of the application.

The Authority has now completed a full assessment of the application and has prepared a draft variation to Standard P1 - Beer and Beer Products - and will now conduct an inquiry to consider the draft variation.

To assist in this process, the Authority invites written submissions on matters relevant to the purposes of the inquiry.

**Notice Pursuant to section 17 of the
National Food Authority Act 1991**

The National Food Authority received an application from Queen Fine Foods Pty Ltd on 6 July 1992 requesting amendment to the the Australian Food Standards Code by varying Standard A6 - Flavourings and Flavour Enhancers - to :

- . exempt flavourings, including vanilla, from the requirement for prescribed names or appropriate designations to be in characters of uniform size, style and colour; and
- . permit some flexibility in the choice of the name for vanilla essence.

The Authority has made a full assessment of this application and has decided to reject the application for the following reasons:

- . The general requirement in Standard A1 - Labelling and Advertising - for the prescribed name or appropriate designation to be in characters of the same size, style and colour is intended to prevent misleading representation of the true nature of a product, and there is no justification for exempting flavourings or vanilla essence from this general requirement; and
- . The terms "vanilla essence" and "vanilla flavouring" are not interchangeable as "vanilla essence" and "vanilla flavouring" are standardised separately.

The National Food Authority has completed an inquiry into the application by the Council of Werribee and has recommended that the National Food Standards Council adopt a draft variation to:

Standard A2 - Date Marking of Packed Foods.

The recommendation, if approved by the Council, will require foods which have been frozen to have a minimum durable life of more than 90 days to include in the label:

The National Food Authority has before it a proposal to reduce the maximum limits for Dioctyl sodium sulphosuccinate (DSS), where it is presently allowed in the Food Standards Code.

Pursuant to section 23 of the Act, the Authority has made a full assessment and has decided to abandon this proposal for the following reasons:

- . This proposal arose from concern as to the reasons why the Ministry of Agriculture, Fisheries and Food (U.K) has deleted DSS from its list of permitted emulsifiers and stabilisers. Inquiry indicated that the reason for this ban in the U.K. was the non-supply of data by industry, rather than evidence that DSS posed a health risk.
- . There are no Public health and Safety concerns regarding DSS, given the present consumption levels.
- . DSS is permitted in Australia in the preparation of fruit-flavoured cordials, syrups and toppings, fruit-flavoured soft drinks, and fruit juice drink. This is consistent with Codex Alimentarius, and New Zealand and United States food regulations.

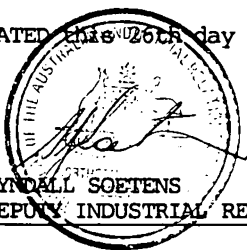

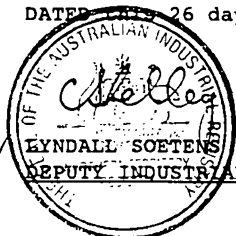

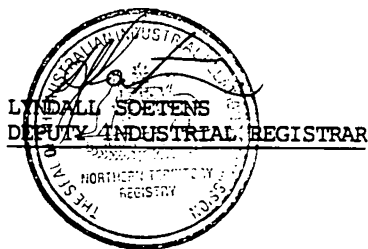

ANTI-DUMPING AUTHORITY

REVOCATION INQUIRY: **CANNED TOMATOES FROM THAILAND**

The Minister for Small Business Construction and Customs has accepted a recommendation from the Anti-Dumping Authority that the measures in place against subsidised exports of canned tomatoes from Thailand be continued.

Countervailing duties were imposed on the goods in April 1992.

The decision to continue these measures follows an inquiry by the Authority into whether the countervailing duty notice applying to canned tomatoes exported from Thailand should be revoked. The inquiry was initiated after a request by Jewel Food Stores, an importer of the goods, that the notice be revoked.

The Authority concluded that:

- . canned tomatoes exported from Thailand have been subsidised;
- . the Australian industry suffered material injury in 1991 and the first six months of 1992;
- . the subsidisation of exports of canned tomatoes from Thailand caused material injury to the Australian industry in 1991;
- . the scheme providing the subsidy is still in place and the amount of assistance available could increase significantly if interest rates in Thailand increase; and
- . there is a threat of material injury to the Australian industry if the amount of assistance available from the subsidy increases significantly.

The Anti-Dumping Authority has confirmed the finding by the Australian Customs Service that grounds do not exist for anti-dumping action against exports of certain cast iron manhole covers, grates and frames from India and the People's Republic of China.

In October 1992 the Authority was asked by Gatic (Australia) Pty Ltd to review Customs' negative preliminary finding.

The Authority has now completed its review and has found that:

- . there has been dumping of the goods under review from India and China;
- . there is insufficient information to conclude that the Australian industry producing like goods has suffered material injury; and
- . the Australian industry producing like goods does not face a threat of material injury from dumping.

I am satisfied that the Land Trust should hold another part of the area of land to which the recommendation referred to in recital B relates (that other part being described as Northern Territory Portions 4114, 3787 and 1754 the boundaries of which are set out in Survey Plans S92/27, S89/338 and S91/56A to B lodged with the Registrar-General of the Northern Territory), for the benefit of Aboriginals who are relevant Aboriginals, as defined in sub-section 11(4) of the Act, in relation to that other part of that area of land.

NOW THEREFORE I, ROBERT EDWARD TICKNER, Minister of State for Aboriginal and Torres Strait Islander Affairs, pursuant to paragraph 11(1AB)(c) of the Act HEREBY DECLARE that the Land Trust is to be treated, for all purposes of the Act and any other law of the Commonwealth, of a State or of a Territory, as if it had also been established under section 4 of the Act to hold title to Northern Territory Portions 4114, 3787 and 1754 for the benefit of Aboriginals who are relevant Aboriginals in relation to that area of land.
