This index covers the Government Notices (GN) and related Special (S) and Periodic (P) issues of the *Gazette* for 1995. Note that there are some entries for S issues with business dated 1994 although not gazetted until 1995. In these cases the S and issue number are followed by (1994) to avoid confusion with the same 1995 S numbers.

GN issues are published weekly and contain legislation, proclamations, special information and notices of government departments. S and P issues are published as required. S *Gazettes* contain urgent matters and P *Gazettes* contain lengthy notices of a non-urgent nature.

GN issues of the *Gazette* are paged continuously throughout the year and are indexed to the page number. S and P issues are indexed to the issue number only prefixed by the letters S or P.

GN issues are indexed by subject and also by names of organisations. Notices about the making and date of operation of legislation are indexed directly under the title of the legislation. Matters concerning the states and territories are indexed under the name of the state or territory.

The index is arranged in ASCII (American Standard Code for Information Interchange) order.

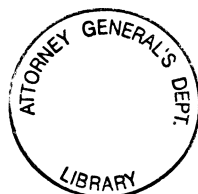
