





**BROADCASTING SERVICES ACT
NOTICE OF APPLICATION FOR RENEWAL OF LICENCE**

In accordance with sections 46(2)(commercial licences) and 90(2)(community licences) of the *Broadcasting Services Act 1992*(the Act), the Australian Broadcasting Authority (ABA) hereby notifies that the companies listed below have lodged applications for the renewal of the following broadcasting licences:

The ABA is required to renew these licences unless it decides that an applicant is no longer a suitable licensee. A company is a suitable licensee if the ABA does not decide that sub-section 41(2) (for commercial) or 83(2) (for community) of the Act applies to the company.

The ABA may decide that either section 41(2) or 83(2) of the Act applies to a licensee if it is satisfied that allowing the licensee to provide or continue to provide either a commercial or a community broadcasting service under a licence would lead to a significant risk of:

- (a) an offence against the Act or the regulations being committed; or
- (b) a breach of the conditions of the licence occurring.

In deciding whether these sub-sections apply, the ABA is required by sections 41(3) (commercial) and 83(3) (community) of the Act, to take into account:

- (a) the business record of the company; and
- (b) the company's record in situations requiring trust and candour; and
- (c) (commercial) the business record of each person who is, or would be, if a licence were allocated to the applicant, in a position to control the licence; or (community) the business record of the chief executive and each director and secretary of the applicant; and
- (d) the record in situations requiring trust and candour of each such person; and
- (e) whether the company, or a person referred to in paragraph (c) or (d), has been convicted of an offence against this Act or the regulations.

Nothing in the provisions of the Act requires the ABA to hold an investigation or a hearing into whether a licence should be renewed.

TELECOMMUNICATIONS ACT 1991

NOTICE UNDER SECTIONS 267 AND 280

EXEMPTION OF
BROADCASTER EQUIPMENT AND BROADCASTER CABLING
FROM TECHNICAL REGULATION

AUSTEL declares that sections 253, 254 and 255 of Division 6 (Permits for customer equipment) and section 268 of Division 7 (Licensing of cabling providers) of Part 12 (Technical Regulation) of the *Telecommunications Act 1991* do not apply in relation to broadcaster equipment and broadcaster cabling of the kind specified in the Schedule to this Notice.

Interpretation

In this Notice:

"Act" means the *Telecommunications Act 1991*;

"broadcaster" means

- (a) the Australian Broadcasting Corporation; or
- (b) the Special Broadcasting Service; or
- (c) the body known as the National Transmission Agency; or
- (d) a person holding a licence under the *Broadcasting Act 1942*;
or
- (e) a person holding a licence under parts 4, 6 or 7 of the
Broadcasting Services Act 1992.

"broadcaster cabling" means customer cabling used by a broadcaster in producing or supplying a radio broadcast service or a television broadcast service;

"broadcaster equipment" means customer equipment used principally as specialist facilities by a broadcaster, but does not include everyday telecommunications equipment such as:

- (a) telephones; or
- (b) facsimile machines; or
- (c) telex machines.

"broadcaster interface standard" means AUSTEL's Technical Standard TS 024: "Broadcaster Interface Standard".

(NOTES:

1. **"Customer cabling"** is defined in section 5 of the Act as a line that
 - (a) is, or is intended to be, connected to telecommunications network operated by a carrier; and
 - (b) is used, or intended for use, beyond the boundaries of any such network.

By way of example only, the expression includes a line that is used for or in relation to the supply of radio or television services and that is used in accordance with the definition.

2. **"Customer equipment"** is defined in section 5 of the Act as equipment that is, or is intended to be, connected to a telecommunications network operated by a carrier, other than equipment that is used, or intended for use, within the boundaries of such a network. By way of example only, the expression includes equipment that is used for or in relation to the supply of radio or television services and that is used in accordance with the definition.
3. **"Carrier", "equipment" and 'line'** are also defined in section 5 of the Act.)

Schedule

Broadcaster equipment:

- (a) if it is connected to a carrier's telecommunications network by customer equipment:
 - (i) that is the first item of customer equipment on the broadcaster's side of the interface; and
 - (ii) for which AUSTEL has issued a permit under section 258 of the Act because the customer equipment complies with the Broadcaster Interface Standard TS 024; or
- (b) if it is connected to a carrier's telecommunications network by customer equipment:
 - (i) that is the first item of customer equipment on the broadcaster's side of the interface; and
 - (ii) that complies with TS 024 to the satisfaction of the carrier, and
 - (iii) the carrier agrees in writing to the connection of the equipment, or equipment of that kind.

Broadcaster cabling:

- (a) if it is connected to a carrier's telecommunications network by customer equipment:
 - (i) that is the first item of customer equipment on the broadcaster's side of the interface; and
 - (ii) for which AUSTEL has issued a permit under section 258 of the Act; or
- (b) if it is connected to a carrier's telecommunications network by customer equipment:
 - (i) that is the first item of customer equipment on the broadcaster's side of the interface; and
 - (ii) that complies with TS 024 to the satisfaction of the carrier; and

- (ii) that is equipment, or equipment of that kind, connected to the network with the agreement in writing of the carrier; or,
- (c) if it is connected to a carrier's telecommunications network; and
 - (i) it complies with the cabling requirements of TS 024 to the satisfaction of the carrier; and
 - (ii) the carrier agrees in writing to the connection of the cabling, or cabling of that kind.

Note

To avoid doubt, nothing in this Notice limits the application of any other provision of the Telecommunications Act 1991 and in particular the provisions requiring in effect, that:

- (a) customer cabling of the kind not specified in the Schedule to this Notice comply with relevant AUSTEL technical standards; and
- (b) customer equipment and customer cabling within broadcaster facilities, other than the *broadcaster equipment* and *broadcaster cabling* defined above, shall meet the requirements of AUSTEL's technical standards, and, for customer equipment, have a permit; and
- (c) customer cabling other than broadcaster cabling defined above shall be installed and maintained by an AUSTEL licensed cabler.



The material will be packaged into bags and sealed within shipping containers, and transported by road to be loaded onto a ship at Newcastle, to be off-loaded at Porto Marghera, after which it would be transported by road to SELCA.

The export would take place in five shipments between 1 April 1997 and 31 March 1998.

The Australian Customs Service (Customs) has received a request lodged by Tate Access Floors Australia Pty Ltd on behalf of the Australian industry. The request seeks that Customs make a determination that hollow steel access floor panels are "like goods" to cementitious-filled access floor panels.

In considering this request, Customs has decided to seek input from interested parties on the question of whether hollow steel access floor panels, cementitious-filled access floor panels and wood-filled access floor panels are "like goods", within the meaning of Section 269T(1) of the Customs Act.


Section 269T(1) of the Customs Act defines "like goods" to mean goods that are identical in all respects to the goods under consideration or that, although not alike in all respects to the goods under consideration, have characteristics closely resembling those of the goods under consideration.

Should Customs determine that hollow steel access floor panels are "like goods" to cementitious-filled access floor panels, this would result in an extension of the measures currently in place against dumped cementitious-filled access floor panels exported from the Republic of South Africa to also cover hollow steel access floor panels exported from that country.

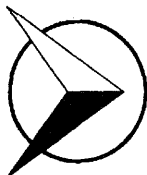
