OPINION ON CATEGORY OF BROADCASTING SERVICE

We have considered the information provided by Festival City Broadcasters Ltd in an application made under section 21 of the *Broadcasting Services Act 1992* ("the Act") for an opinion to be formed by the Australian Broadcasting Authority ("ABA") in relation to the category of the *TABRADIO* service including the addition of a live to air breakfast show, the purpose of which is to provide information, including interviews, in respect of opportunities for sports betting on the day or forthcoming days.

It is our opinion that the service falls within the open narrowcasting category. This opinion is given having regard to the criteria set down in sections 18 and 22 of the Act. Matters considered by the ABA in reaching this opinion include:

- that reception of the service will be limited by being targeted to a special interest group, that is, those interested in betting on sport, especially horse/ greyhound racing;
- that reception of the service will be limited by providing programs of limited appeal

Under subsection 21(5)(a) of the Act, this opinion is binding for five years while the circumstances relating to the broadcasting service remain substantially the same as those advised to the ABA in relation to the application for the opinion.



Citation

1. This Declaration may be cited as the Telecommunications (Public Mobile Licences) Declaration No. 1 of 1997.

NOTE

This Declaration takes effect at the end of the day on which the Minister complies with paragraphs 66 (1) (a) and 66 (1) (b) of the *Telecommunications Act 1991*: see subsection 66 (2) of that Act.

Conditions

2. All public mobile licences are subject to the conditions specified in this Declaration.

2 **Telecommunications (Public Mobile Licences) Declaration**
No. 1 of 1997

Interpretation

3. In this Declaration:

“Act” means the *Telecommunications Act 1991*;

“network facilities” *see* section 137 of the Act;

“site” means:

- (a) land; or
- (b) a building on land; or
- (c) a structure on land;

“technically feasible” *see* clause 4;

“telecommunications transmission tower” means any of the following objects used to supply a telecommunications service by means of radiocommunications:

- (a) a tower;
- (b) a pole;
- (c) a mast;
- (d) a similar structure.

Technical feasibility

4. (1) For subclauses 5 (3) and 6 (3), compliance with a requirement relating to access to a telecommunications transmission tower, or to a site that includes a telecommunications transmission tower, is not technically feasible if:

- (a) compliance with the requirement:
 - (i) would result in significant difficulties of a technical or engineering nature; or
 - (ii) would give rise to a significant risk to the health or safety of employees of a carrier who require access to the tower or the site; and
- (b) there is no practical means of overcoming the difficulties, or removing the risk, including (but not limited to):
 - (i) changing the physical configuration or operating parameters of the facilities on the tower; or
 - (ii) making structural changes to the tower; or
 - (iii) replacing the existing tower with another tower on the same site.

(2) Without limiting subparagraph (1) (a) (i), the following are examples of difficulties of the kind mentioned in that subparagraph:

- (a) compliance would result in electromagnetic interference between the telecommunications signals that would be emitted from, or received by, the facilities of the carriers sharing the tower, at levels that would be likely to impair the efficient operation of services offered by any of the carriers; and

- (b) the facilities of the carrier requesting the access cannot adequately be physically accommodated on the tower.

NOTE

For clauses 5 and 6, the "second carrier" mentioned in those clauses would be obliged to meet the reasonable costs involved in overcoming a difficulty or concern of the kind mentioned in clause 4.

Access to telecommunications transmission towers

5. (1) A carrier (the "first carrier") must, if requested to do so by another carrier (the "second carrier"), give the second carrier access to a telecommunications transmission tower that is network facilities of the first carrier as soon as practicable after receiving the request.

- (2) The first carrier is not required to comply with subclause (1) unless:
- (a) the access is provided for the sole purpose of enabling the second carrier to install network facilities used, or for use, in connection with the supply of a public mobile telecommunications service; and
 - (b) the second carrier gives the first carrier reasonable notice that the second carrier requires the access.

(3) The first carrier is not required to comply with subclause (1) in relation to a particular telecommunications transmission tower if there is in force:

- (a) a written certificate issued by AUSTEL stating that, in AUSTEL's opinion, compliance with subclause (1) in relation to the tower is not technically feasible; or
- (b) an access agreement, made after the commencement of this Declaration, registered with AUSTEL under Part 8 of the Act:
 - (i) between the first and second carriers; and
 - (ii) specifying procedures to be followed by both carriers in relation to co-location of mobile towers and sites.

Access to sites of telecommunications transmission towers

6. (1) A carrier (the "first carrier") must, if requested to do so by another carrier (the "second carrier"), give the second carrier access to a site as soon as practicable after receiving the request if:

- (a) either:
 - (i) the site is owned, occupied or controlled by the first carrier; or
 - (ii) the first carrier has a right (whether conditional or unconditional) to use the site; and
- (b) there is situated on the site a telecommunications transmission tower that is network facilities of the first carrier.

4 **Telecommunications (Public Mobile Licences) Declaration
No. 1 of 1997**

- (2) The first carrier is not required to comply with subclause (1) unless:
- (a) the access is provided for the sole purpose of enabling the second carrier to install network facilities used, or for use, in connection with the supply of a public mobile telecommunications service; and
 - (b) the second carrier gives the first carrier reasonable notice that the second carrier requires the access.
- (3) The first carrier is not required to comply with subclause (1) in relation to a particular site if there is in force:
- (a) a written certificate issued by AUSTEL stating that, in AUSTEL's opinion, compliance with subclause (1) in relation to the site is not technically feasible; or
 - (b) an access agreement, made after the commencement of this Declaration, registered with AUSTEL under Part 8 of the Act:
 - (i) between the first and second carriers; and
 - (ii) specifying procedures to be followed by both carriers in relation to co-location of mobile towers and sites.

NOTES

1. Concurrently with the making of this Declaration a direction will be given to AUSTEL under s. 50 of the *Telecommunications Act 1991* to use its best endeavours to make a decision on a request for the issue of a certificate under subclause 5 (3) or 6 (3) within 10 business days after the making of the request.
2. The conditions imposed by this Declaration are supplementary access conditions within the meaning of s. 138 of the *Telecommunications Act 1991*.
3. Telecommunications (Interconnection and Related Charging Principles) Determination (No. 1) of 1991 made on 25 November 1991 provides for charges (called supplementary access charges) for access given under supplementary access conditions.
4. Under s. 154 of the *Telecommunications Act 1991*, if 2 or more carriers cannot agree on terms and conditions of a supplementary access condition of a licence held by one of them, any or all of them may submit the matter to AUSTEL for arbitration.

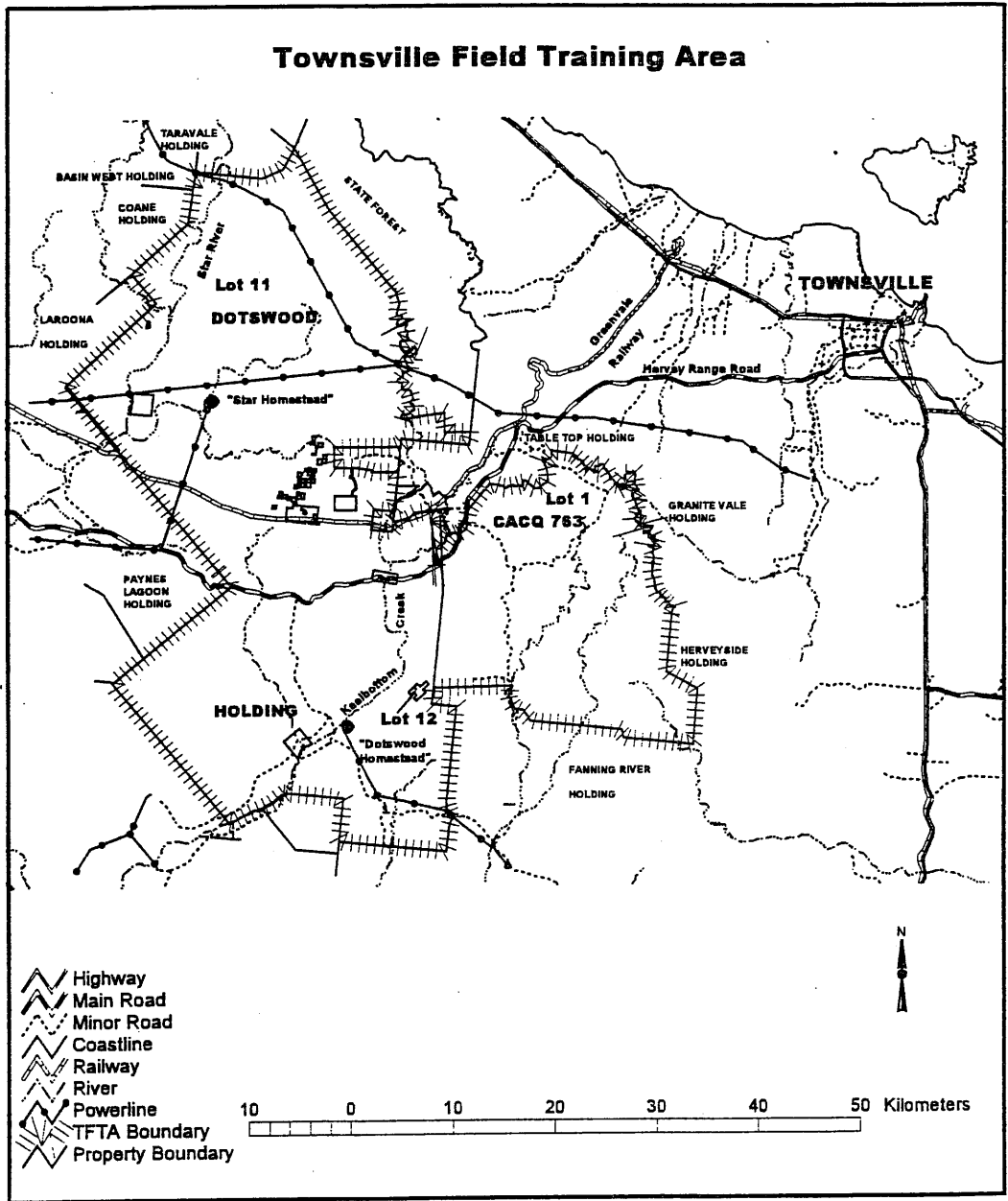





ANTI-DUMPING AUTHORITY**FINAL FINDING ON POLYVINYL CHLORIDE HOMOPOLYMER FROM
BELGIUM AND THE REPUBLIC OF KOREA**

The Anti-Dumping Authority has completed its inquiry into the export of polyvinyl chloride homopolymer resin (PVC) from Belgium and Korea.

The Authority concluded that:

- exports of PVC by Solvay SA in Belgium, and by Hanwha Chemical Corporation and LG International in Korea have been at dumped prices;
- the Australian industry producing PVC is suffering material injury from some cause or causes;
- dumped imports from Belgium and Korea have not caused material injury to the Australian industry; and
- there is not a threat of material injury from dumping of PVC from Belgium and Korea.

In the light of the above, the Authority has recommended that the Minister for Small Business and Consumer Affairs not take anti-dumping action against the exporters of PVC from Belgium and Korea.

The Minister has accepted the Authority's recommendation.

CONTINUATION INQUIRY: CANNED PEACHES FROM GREECE, SPAIN AND THE PEOPLE'S REPUBLIC OF CHINA

The Anti-Dumping Authority has completed its inquiry into whether the countervailing duties currently applying to imports of canned peaches from Greece and Spain and the dumping duties currently applying to imports of canned peaches from Greece and the People's Republic of China should be continued until 2002.

The Authority is satisfied that:

- a production aid, which is a countervailable subsidy, is payable on canned peaches produced in Greece and Spain; and
- the expiration of the countervailing duty against that subsidy currently applying to exports of canned peaches from Greece to Australia would be likely to lead to a recurrence of the material injury which the duty is intended to prevent.

The Authority therefore recommended that the Minister take steps to secure the continuation of the countervailing duty against the production aid currently applying to imports of canned peaches from Greece for a further five years beyond the current expiry date of 19 February 1997.

The Authority is not satisfied that:

- Greek canners now receive a sugar rebate subsidy on their exports of canned peaches;
- the expiry of the countervailing duty is likely to lead to the recurrence of material injury caused by the subsidisation of canned peaches exported from Spain; and
- the expiry of dumping duties are likely to lead to the recurrence of material injury caused by the dumping of canned peaches exported from Greece and China.

The Authority has therefore recommended that:

- the countervailing duty against the sugar rebate currently applying to imports of canned peaches from Greece;
- the countervailing duty currently applying to imports of canned peaches from Spain; and
- the dumping duties currently applying to imports of canned peaches from Greece and China,

should be allowed to expire on 19 February 1997.

The Minister has accepted the Authority's recommendations.

S. van der Laan B.V. of the Netherlands should be continued until 2002.

The Authority was not satisfied that:

- the expiry of the countervailing duty was likely to lead to the recurrence of material injury caused by the subsidisation of canned ham exported from Denmark, Ireland and the Netherlands; and

ANTI-DUMPING AUTHORITY**REVIEW OF THE AUSTRALIAN CUSTOMS SERVICE'S NEGATIVE
PRELIMINARY FINDING ON LAMINATED GLASS FROM THE PEOPLE'S
REPUBLIC OF CHINA, ISRAEL, TAIWAN AND THAILAND**

The Anti-Dumping Authority has completed its review of the Australian Customs Service negative preliminary finding in respect of the alleged dumping of laminated glass from the People's Republic of China, Israel, Taiwan and Thailand.

After examining the information available to Customs at the time of its inquiry, the Authority concludes that:

- laminated glass has not been exported at dumped prices to Australia from China or Taiwan;
- laminated glass has been exported at dumped prices to Australia from Thai Glass;
- there has been negligible dumping of laminated glass into Australia from Israel; and
- the Australian industry producing laminated glass suffered material injury from some cause or causes in 1995.

The Authority, however, is not satisfied:

- that dumping of laminated glass by Thai Glass, of itself, has caused material injury to the Australian industry; nor
- that there is a threat of material injury to Australian industry by future dumping of laminated glass from Thailand.

The Authority, therefore, confirms the negative preliminary finding made by Customs.



Section 20.18 of the Civil Aviation Orders has effect in relation to the Australian aircraft bearing the nationality and registration marks VH-AJV only in so far as set out in these directions.

These directions commence on 6 February 1997 and remain in force until the end of 27 February 1997.

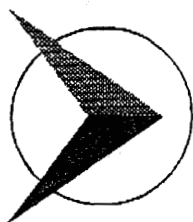

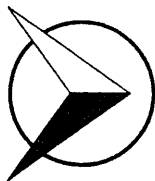


