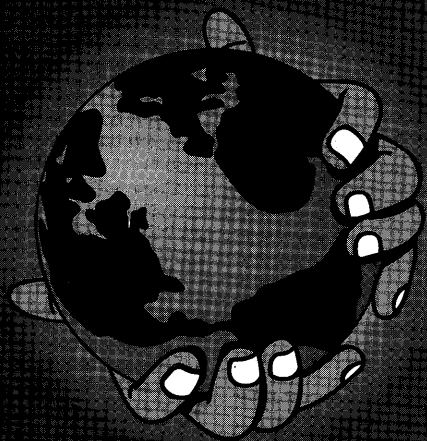

The ABA is required to renew these licences unless it decides that an applicant is no longer a suitable licensee. A company is a suitable licensee if the ABA does not decide that sub-section 41(2)(for commercial) or 83(2)(for community) of the Act applies to the company.

The ABA may decide that either section 41(2) or 83(2) of the Act applies to a licensee if it is satisfied that allowing the licensee to provide or continue to provide either a commercial or a community broadcasting service under a licence would lead to a significant risk of:

- (a) an offence against the Act or the regulations being committed; or
- (b) a breach of the conditions of the licence occurring.

In deciding whether these sub-sections apply, the ABA is required by sections 41(3)(commercial) and 83(3)(community) of the Act, to take into account:

- (a) the business record of the company; and
- (b) the company's record in situations requiring trust and candour; and
- (c) (commercial) the business record of each person who is, or would be, if a licence were allocated to the applicant, in a position to control the licence; or (community) the business record of the chief executive and each director and secretary of the applicant; and
- (d) the record in situations requiring trust and candour of each such person; and
- (e) whether the company, or a person referred to in paragraph (c) or (d), has been convicted of an offence against this Act or the regulations.

Nothing in the provisions of the Act requires the ABA to hold an investigation or a hearing into whether a licence should be renewed.

*Wildlife Protection (Regulation of Exports and Imports) Act 1982***DECLARATION OF CONTROLLED SPECIMENS**

I, ROBERT MURRAY HILL, Minister for the Environment, having considered comments as required by subsection 9B (3) of the *Wildlife Protection (Regulation of Exports and Imports) Act 1982* (the Act) and having taken into account advice from the Designated Authority on those matters specified in Regulation 5A(1) for the purposes of subsection 10A (5) of the Act, hereby declare beach-cast *Posidonia australis*, *P. angustifolia* and *P. coriacea* harvested from Lacepede Bay, South Australia, to be "controlled specimens" for the purposes of subsection 10A(2) of the Act, subject to the following conditions:

1. this declaration is limited to specimens harvested by Seaweed Sales Australia from three kilometres of shoreland situated between the mean high water tide mark and the mean low water tide mark in the Kingston area of Lacepede Bay, south-east South Australia (adjacent to Section 601 and part of section 604 between Long Beach Road and Blackford Drain);
2. the operation is to be carried out in accordance with appropriate permit or licences required under the *Fisheries Act 1982* and such licences/permits are to remain current during the harvesting period;
3. the operation is to be carried out in accordance with the document entitled "Proposal for harvest and export of native wildlife under the *Wildlife Protection (Regulation of Exports and Imports) Act 1982 - Posidonia australis* submitted by Seaweed Sales Australia";
4. the following reports will be submitted to Environment Australia:
 - a six monthly report on total harvest, including monthly harvests for the domestic and export markets, for the period up to 31 October 1997 will be submitted by 30 November 1997; and,
 - an annual report will be submitted by 20 February 1998 incorporating harvest data by month (including export and domestic market sales) and the outcomes of the research and monitoring undertaken; and
5. this declaration is valid until 31 January 1998.

The 190th (1997/2) Meeting of the Australian Drug Evaluation Committee (ADEC) (10-11 April 1997) resolved to advise the Parliamentary Secretary to the Minister for Health and Family Services, and the Secretary, Department of Health and Family Services, on the following safety related issue.

RESOLUTION NO 7173

THE ADEC HAS CONSIDERED THE ISSUE RAISED BY THE ADVERSE DRUG REACTIONS ADVISORY COMMITTEE (ADRAC), IN THE REPORT OF ITS 219TH MEETING, CONCERNING TERFENADINE.


THE ADEC NOTES:

- **THE REGISTRATION OF FEXOFENADINE, A SAFER ALTERNATIVE DRUG TO TERFENADINE, WHICH IS TO BE SCHEDULED S3 ALLOWING SUPPLY WITHOUT PRESCRIPTION; AND**
- **THE ONGOING CONCERNS ABOUT POTENTIALLY LIFE THREATENING SIDE EFFECTS AND DRUG INTERACTIONS WITH TERFENADINE.**

THE ADEC CONSIDERS THAT THE RISK/BENEFIT RATIO HAS NOW MOVED IN FAVOUR OF RESTRICTION OF THE SUPPLY OF TERFENADINE TO PRESCRIPTION ONLY. THIS CHANGE WILL ALLOW BETTER ASSESSMENT OF INDIVIDUAL RISKS AND COMMUNICATION OF THE RISKS TO THE PATIENT.

A RECOMMENDATION SHOULD BE FORWARDED TO THE NATIONAL DRUGS AND POISONS SCHEDULING COMMITTEE THAT TERFENADINE BE CONSIDERED FOR RESCHEDULING TO S4.

THIS RESOLUTION IS TO BE GAZETTED AS QUICKLY AS POSSIBLE AND THE ADRAC SHOULD BE REQUESTED TO EXPEDITE THE URGENT SAFETY REVIEW OF ASTEMIZOLE PRIOR TO THE NEXT ADEC MEETING.



**ADOPTED NATIONAL EXPOSURE STANDARDS FOR ATMOSPHERIC
CONTAMINANTS IN THE OCCUPATIONAL ENVIRONMENT**

Pursuant to sub-section 38(1) of *the National Occupational Health and Safety Commission Act 1985* (Cwlth), the National Occupational Health and Safety Commission hereby gives notice that it has declared revised or additional national exposure standards for atmospheric contaminants (triethanolamine, methylene chloride and methyl n-butyl ketone) in the occupational environment.

To ensure compliance with the *National Occupational Health and Safety Commission Act 1985* (Cwlth), the adopted *National Exposure Standards for Atmospheric Contaminants in the Occupational Environment*, as declared, are printed here in the prescribed form.

TITLE

These national exposure standards may be cited as *Adopted National Exposure Standards for Atmospheric Contaminants in the Occupational Environment* [NOHSC:1003].

OBJECTIVE

Regulation 12(1) of the *National Model Regulations for the Control of Workplace Hazardous Substances* [NOHSC:1005(1994)]⁽²⁾, requires employers to take action to prevent exposure of persons in the workplace to hazardous substances at work, or if that is not practicable, to ensure that exposure is adequately controlled so as to minimise risks to health.

As per Regulation 12(4), without limiting the requirements of Regulation 12(1), the employer shall ensure that no employee is exposed to hazardous substances at levels above the appropriate exposure standards for the relevant period of time as listed in the *Adopted National Exposure Standards for Atmospheric Contaminants in the Occupational Environment* [NOHSC:1003(1995)]⁽³⁾.

The exposure standards represent airborne concentrations of individual substances which, according to current knowledge, should neither impair the health of, nor cause undue discomfort to, nearly all workers. Except for short-term exposure limits, or where a peak value has been assigned, the exposure standards for airborne contaminants are expressed as a Time-Weighted Average (TWA) concentration of that substance over an eight-hour working day, for a five day working week.

**DECLARED CHANGES AND ADDITIONS TO THE NATIONAL
OCCUPATIONAL EXPOSURE STANDARDS.**

Changes and additions to the national standards (triethanolamine - addition of exposure standard; methylene chloride and methyl n-butyl ketone - addition of a skin notation) are reproduced on page 3 of this notice, (Table 1).

A consolidated list of declared standards since the May 1995 edition of the *Adopted National Exposure Standards for Atmospheric Contaminants in the Occupational Environment* [NOHSC:1003(1995)]⁽³⁾ is provided on page 4 of this notice (Table 2).

DOCUMENTATION

Copies of the exposure standard documentation (*Documentation of the Exposure Standards* [NOHSC 10003])⁽³⁾ for the declared standards are available from Commonwealth Government Bookshops. * Crystalline silica

The legislation relating to the control of crystalline silica exposure includes specific and general provisions and varies for each State and Territory. Separate legislation usually applies for metal mines, coal mines both underground and open cut, construction and excavation work, factories and other industrial activities.

Some jurisdictions, in their legislation that relates to the control of crystalline silica exposure, cite the gravimetric exposure standards contained in the *Adopted National Exposure Standards for Atmospheric Contaminants in the Occupational Environment* [NOHSC:1003]⁽²⁾. In view of the absence of exposure standard values for crystalline silica in this standard and therefore a lack of an enforceable exposure standard for some jurisdictions, the National Commission declared on 2 April 1996, gravimetric exposure standards for quartz, tridymite and cristobalite.

The National Commission recommends that in those jurisdictions where legislation exists that deals with the control of crystalline silica and specifies lower exposure standard values for quartz, cristobalite and tridymite than those listed in Table 2, page 4, then compliance with those exposure standards must be maintained.

Pursuant to sub-section 38(1) of the *National Occupational Health and Safety Commission Act 1985* (Cwlth), the National Occupational Health and Safety Commission hereby gives notice that it has endorsed,

- amendments to Chapter 17 - Fumes and Gases from Welding and Cutting Processes, and
- the addition of a new chapter - Mineral Oil Additives,

to the *Guidance Note on the Interpretation of Exposure Standards for Atmospheric Contaminants in the Occupational Environment* [NOHSC:3008(1995)]⁽¹⁾.

Title

The guidance note may be cited as *Guidance Note on the Interpretation of Exposure Standards for Atmospheric Contaminants in the Occupational Environment* [NOHSC:3008].

Objective

Regulation 12(1) of the *National Model Regulations for the Control of Workplace Hazardous Substances* [NOHSC:1005(1994)]⁽²⁾, requires employers to take action to prevent exposure of persons in the workplace to hazardous substances at work, or if that is not practicable, to ensure that exposure is adequately controlled so as to minimise risks to health.

As per Regulation 12(4), without limiting the requirements of Regulation 12(1), the employer shall ensure that no employee is exposed to hazardous substances at levels above the appropriate exposure standards for the relevant period of time as listed in the *Adopted National Exposure Standards for Atmospheric Contaminants in the Occupational Environment* [NOHSC:1003(1995)]⁽³⁾.

The exposure standards represent airborne concentrations of individual substances which, according to current knowledge, should neither impair the health of, nor cause undue discomfort to, nearly all workers. Except for short-term exposure limits, or where a peak value has been assigned, the exposure standards for airborne contaminants are expressed as a Time-Weighted Average (TWA) concentration of that substance over an eight-hour working day, for a five day working week.

The guidance note provides complementary information on the interpretation and application of the exposure standards.

Amendments to the Guidance Note since May 1995

The third edition of the *Guidance Note on the Interpretation of Exposure Standards for Atmospheric Contaminants in the Occupational Environment* [NOHSC:3008] (Guidance Note) was published in May 1995. Since then Chapter 5 (Exposure Duration) of the Guidance Note has been amended to include formula for adjusting 8-hour TWA exposure standards for altered workshifts. The guidance material on altered workshifts was endorsed by the National Commission in April 1996 and published in the June 1996 Commonwealth of Australia *Chemical Gazette*.

NEW CHAPTER FOR

GUIDANCE NOTE ON THE INTERPRETATION OF EXPOSURE STANDARDS FOR ATMOSPHERIC CONTAMINANTS IN THE OCCUPATIONAL ENVIRONMENT [NOHSC:3008]

MINERAL OIL ADDITIVES

1. The 8-hour time weighted average exposure standard for oil mist of 5 mg/m^3 applies to oil mists from highly refined mineral oils. Most formulated products in use are based on highly refined mineral oils plus additives for the purpose of enhancing their properties in specific processes and preventing decomposition. Additives could include; antioxidants, bearing protectors, wear resistors, dispersants, detergents, emulsifiers, viscosity-index improvers, pour-point depressors and antifoaming and rust-resisting agents.
2. Cutting fluids are one of the main mineral oil products which produce mists during their usage. These compounds are usually a combination of mineral oil with emulsifiers along with a complex additive package including many of the above additives and biocides.
3. The composition of these oils can also change in the process of use. They can become contaminated or breakdown. Processes involving cutting of metals, plastics, etc, causes the mineral oil to become contaminated by fine swarf. Contamination may also occur via metabolic by-products from bacteria or fungi. Heating can cause chemical changes to the oil and produce toxic thermal degradation products such as carbon monoxide as in overheating compressors.
4. Where oils contain significant quantities of these contaminants or additives, the mixtures formula may need to be used to derive an exposure standard more suited to the application, or at the very least the exposures to these additives/contaminants should be determined separately and taken into account in assessing exposures.
5. The chapter on Oil Mist, Refined Mineral, in the National Occupational Health and Safety Commission's *Documentation of the Exposure Standards* [NOHSC:10003]⁽¹⁾ describes the effects of workplace exposure to mineral oils. Skin contact with mineral oil products should be recognised as an additional route of exposure.

GUIDANCE NOTE ON THE INTERPRETATION OF EXPOSURE STANDARDS FOR ATMOSPHERIC CONTAMINANTS IN THE OCCUPATIONAL ENVIRONMENT [NOHSC:3008(1995)]

CHAPTER 17 - FUMES AND GASES FROM WELDING AND CUTTING PROCESSES

17.1 The fumes and gases arising from welding and cutting processes may contain a number of contaminants.

17.2 The composition of the fume depends upon:

- consumables: electrodes or filler metals, heating or shielding gases and fluxes;
- material: chemical composition of material being cut or welded and of any protective coating (eg galvanising) or primer paint, (eg lead-based paints); and
- operating conditions, for example, temperature, current.

17.3 The amount of fume generated depends on:

- process and thermal conditions, for example, amperage, voltage, gas and arc temperatures and heat input which may also vary with the welding position and degree of enclosure and the degree of skill of the welder;
- consumables;
- materials; and
- duration of welding or cutting.

17.4 Fume from gas welding and cutting is generally lower than fume from electric welding and cutting. Exceptions to this include processes involving heavy cutting and gouging. In addition, the welding/cutting arc may cause reactions which produce oxides of nitrogen, carbon monoxide and other gaseous contaminants. The intense ultraviolet radiation emitted from some arcs may also give rise to significant quantities of ozone.

17.5 Technical Note 7⁽¹⁾ produced by the Welding Technology Institute of Australia should be consulted for detailed information on fume generation and control.

17.6 When assessing a particular welding or cutting process, consideration should be given not only to airborne concentration of toxic metals, such as chromium and nickel, which may arise from the parent metal or electrode, but also to the concentration of toxic gases which may be generated by the process. In addition to complying with the individual exposure standards for specific contaminants, the fume concentration in the breathing zone (which is inside a welders helmet when a helmet is worn) should not exceed 5 mg/m^3 TWA. Sampling for welding fume should be carried out in accordance with the appropriate Australian Standard⁽²⁾.

I, STEPHEN PANTELIDIS, Manager, Technical Services Section, Bureau of Air Safety Investigation, Department of Transport and Regional Development, a delegate of the Civil Aviation Safety Authority:

- (1) under subregulation 207 (2) of the Civil Regulations, direct that:

Section 20.18 of the Civil Aviation Orders has effect in relation to the Australian aircraft bearing the nationality and registration marks VH-UZS only in so far as set out in these directions.
