The application fee may be waived if the AAT is satisfied that the applicant is in financial hardship.

- Attendance of hearings may be necessary depending on the nature of the case and the discretion of the AAT.



Phillips Petroleum Company through its subsidiary, Phillips Oil Company Australia (Phillips), proposes to construct a subsea natural gas pipeline from the central Timor Sea and a 3 million tonnes per annum liquefied natural gas (LNG) plant located near Darwin, NT. The proposed LNG plant would be constructed at Wickham Point on the Middle Arm Peninsula in Darwin Harbour. The subsea pipeline would extend from the LNG plant to the Bayu/Undan gas discovery located in Area A of the Zone of Cooperation in the Timor Sea.

In accordance with the provisions of the Commonwealth *Environment Protection (Impact of Proposals) Act 1974* and the Northern Territory *Environmental Assessment Act 1982*, a draft Environmental Impact Statement (EIS) which describes the LNG plant and subsea pipeline proposal and its potential environmental effects has been prepared by Phillips. This document will be available for public review from 2 August 1997 to the close of business on 29 September 1997. 





ANTI-DUMPING AUTHORITY

Anti-dumping duties to lapse on high density polyethylene from the Republic of Korea, Saudi Arabia and Singapore

The Anti-Dumping Authority has completed its inquiry into whether the dumping duties on imports of high density polyethylene (HDPE) from the Republic of Korea, Saudi Arabia and Singapore should be continued for another five years.

The Authority was **not** satisfied that the expiry of the duties would lead, or be likely to lead, to a recurrence of the material injury which the duties were intended to prevent.

The Authority recommended to the Minister that he take no action to continue the dumping duties currently applying to imports of HDPE.

The Minister has accepted the Authority's recommendations and, as a consequence, the dumping duties will expire on 2 September 1997.

FOREST PRODUCTS—NOTICE OF IMPORT CHARGE RATES

The Primary Industries Levies and Charges Collection (Forest and Wood Products) Regulations (Amendment) (S.R. 1997 No. 202) amends the rate of levy payable on certain forest products from 1 August 1997. As a consequence the rate of levy payable under the *Forest Industries Research Import Charge Act 1993* on certain forest products imported into Australia is also changed. The following table sets out the rates of charge, calculated in accordance with paragraph 6 (1) (b) of the Act, that are payable from 1 August 1997.
