The ABA is required to renew these licences unless it decides that an applicant is no longer a suitable licensee. A company is a suitable licensee if the ABA does not decide that sub-section 41(2) (for commercial) or 83(2) (for community) of the Act applies to the company.

The ABA may decide that either section 41(2) or 83(2) of the Act applies to a licensee if it is satisfied that allowing the licensee to provide or continue to provide either a commercial or a community broadcasting service under a licence would lead to a significant risk of:

- (a) an offence against the Act or the regulations being committed; or
- (b) a breach of the conditions of the licence occurring.

In deciding whether these sub-sections apply, the ABA is required by sections 41(3) (commercial) and 83(3) (community) of the Act, to take into account:

- (a) the business record of the company; and
- (b) the company's record in situations requiring trust and candour; and
- (c) (commercial) the business record of each person who is, or would be, if a licence were allocated to the applicant, in a position to control the licence; or (community) the business record of the chief executive and each director and secretary of the applicant; and
- (d) the record in situations requiring trust and candour of each such person; and
- (e) whether the company, or a person referred to in paragraph (c) or (d), has been convicted of an offence against this Act or the regulations.

The Act does not require the ABA to hold an investigation or a hearing into whether a licence should be renewed.



**COMMONWEALTH OF AUSTRALIA***Wildlife Protection (Regulation of Exports and Imports) Act 1982***DECLARATION OF CONTROLLED SPECIMENS**

I, ROBERT MURRAY HILL, Minister for the Environment, having considered comments as required by subsection 9B(3) of the *Wildlife Protection (Regulation of Exports and Imports) Act 1982* (the Act) and having taken into account advice from the Designated Authority on those matters specified in subsection 10A(5) of the Act, hereby declare products derived from the Nile crocodile *Crocodylus niloticus* to be "controlled specimens" for the purposes of subsection 10A(3) of the Act, subject to the following conditions:

1. The products have been taken under the "Policy and Plan for Crocodile Management in Zimbabwe" dated 20 May 1997.
2. Importation is subject to the issue of a permit by Environment Australia for each shipment, and the provision of a Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) export permit issued by the Zimbabwe CITES Management Authority.
3. This declaration is valid until 31 December 2002.



## Notice by the Auditor-General Setting Auditing Standards

The auditing standards in this notice are set pursuant to section 24 of the Auditor-General Act 1997, and replace those notified in the Commonwealth Gazette No.GN22, issued on 5 June 1996.

### Preface

The ANAO Auditing Standards prescribe the minimum standards of professional audit work performed by:

- the Auditor-General;
- staff of the Australian National Audit Office; and
- contractors appointed to assist in the performance of an Auditor-General function.

ANAO Auditing Standards are formulated having regard to the auditing standards issued by the Australian Accounting Research Foundation (AARF) on behalf of the Australian Society of Certified Practising Accountants and The Institute of Chartered Accountants in Australia.

I have determined the ANAO Auditing Standards should incorporate the codified Auditing Standards and Auditing Guidance Statements. Accordingly, I have adopted the Statement APS 1.1 *Conformity with Auditing Standards* as the *Statement of Conformity with ANAO Auditing Standards*, with references to "members" in APS 1.1 being read as reference to "auditors to whom the ANAO Standards apply". These ANAO Auditing Standards are effective for all audits reported after they are published in the Commonwealth of Australia Gazette. They replace the ANAO Auditing Standards published in the *Gazette* of 5 June, 1996.

In addition to these pronouncements, additional directions or instructions to auditors to whom these Standards apply may be issued where it is considered necessary to expand on or modify the Auditing Standards or Auditing Guidance Statements in particular circumstances.

Members of professional accounting bodies are bound by rules relating to ethical conduct. While recognising these rules, it is important to note that public servants, or those working for the Commonwealth, are expected to adhere to the highest standards of ethical behaviour. Some of the Commonwealth's rules can be found in legislation (eg. *Public Service Act 1922*, *Crimes Act 1914*), other rules or guidance will be found in statements issued by individual Commonwealth entities. It is important all auditors performing audits functions under the authority of the *Auditor-General Act 1997* make themselves aware of these expectations.

## **PART 1 - INTRODUCTION**

### **Mandate of the Auditor-General of the Commonwealth**

The Office of Auditor-General is a statutory office created by the *Auditor-General Act 1997*. The Auditor-General is appointed to audit, and report to the Parliament of the Commonwealth of Australia on, the activities and performance of Commonwealth Agencies, authorities, companies and their subsidiaries.

The Auditor-General Act sets the terms and conditions of the Office of the Auditor-General and states the functions and powers of the Auditor-General. Those functions and powers include those contained in relevant provisions in the enabling legislation of some individual Commonwealth authorities.

The Act creates the Australian National Audit Office (ANAO) which consists of the Auditor-General and staff appointed under the *Public Service Act 1922*. The function of the ANAO is to assist the Auditor-General in performing Auditor-General functions which are specified in legislation. The Auditor-General may also engage people under contract to assist in the performance of any Auditor-General function.

### **Establishment and application of the ANAO Auditing Standards**

Section 24 of the Auditor-General Act requires the Auditor-General to set auditing standards to be complied with by auditors performing:

- financial statements audits of Commonwealth Agencies, authorities, companies and their subsidiaries;
- performance audits of Commonwealth Agencies, authorities, companies and their subsidiaries, including general performance audits
- financial statement and performance audits of the Australian National Audit Office
- the audit of the Finance Minister's annual financial statements.

These Standards, which may be referred to as the ANAO Auditing Standards, are set by the Auditor-General and express the minimum standard of audit work expected of auditors conducting audits on behalf of the Auditor-General.

The Auditor-General may delegate and authorise auditors to conduct audits on his or her behalf and provide auditors with the necessary powers to conduct such audits. In making delegations and authorisations, the Auditor-General is able to issue directions regarding the manner in which any audit is conducted under these appointments.

These Standards apply to all audits performed under the authority of the Auditor-General and to audit-related services provided under an arrangement under section 20 of the Auditor-General Act.

## **PART 2 - THE ANAO AUDITING STANDARDS**

### **The Auditor-General and relationships with other professional audit bodies**

The Auditor-General recognises the Australian Society of Certified Practising Accountants (ASCPA) and The Institute of Chartered Accountants in Australia (ICAA) as the professional bodies responsible for setting and maintaining auditing standards and practices for their members.

These bodies have issued codified Auditing Standards (AUS) and Auditing Guidance Statements (AGSs) which provide guidance on the performance standards expected on individual components of an audit.

The Auditor-General recognises there is commonality in the auditing standards expected of the private and public sector auditing professions and wishes to conform to the greatest extent possible with the Auditing Standards promulgated by the ASCPA and ICAA. The Auditing Standards and Auditing Guidance Statements are equally applicable as an expression of the minimum standard of audit work expected of auditors in the public sector as they are in the private sector.

The ANAO is a member of the International Organization of Supreme Audit Institutions (INTOSAI). Members of INTOSAI are encouraged to publish auditing standards consistent with the INTOSAI Auditing Standards. The codified Auditing Standards and Auditing Guidance Statements are consistent with the principles expressed in the INTOSAI Auditing Standards.

### **ANAO Auditing Standards**

The ANAO adopts, as the ANAO Auditing Standards, the codified auditing pronouncements issued by the Australian Accounting Research Foundation on behalf of the ASCPA and the ICAA, known as the Auditing Standards (AUSs) and Auditing Guidance Statements (AGSs). It should be noted that the requirement in AUS806 paragraph 15 for terms of engagement to be agreed between the auditor and the entity is satisfied in the ANAO's performance audit context by the entity's acknowledgment of the legislative mandate of the Auditor-General.

The ANAO adopts as the *Statement of Conformity with ANAO Auditing Standards*, the Statement APS 1.1 *Conformity with Auditing Standards* with references to "members" in APS 1.1 being read as references to "auditors to whom the ANAO Auditing Standards apply".

The ANAO Auditing Standards and Statement of Conformity with ANAO Auditing Standards incorporate all amendments issued from time to time by the ASCPA and ICAA. Additionally, Statements of Auditing Practice (AUPs) issued by the ASCPA and ICAA which are not incorporated in the codified Auditing Standards (AUSs) and Auditing Guidance Statements are adopted as though they are Auditing Guidance Statements as part of the ANAO Auditing Standards until they are codified.

The ANAO Auditing Standards and Statement of Conformity with ANAO Auditing Standards must be complied with for all audits reported after the Standards are published in the *Commonwealth of Australia Gazette*. They replace the ANAO Auditing Standards published in the *Gazette* of 5 June, 1996.

The Auditor-General may issue additional directions or instructions to auditors to whom these Standards apply which expand on, or modify, the Auditing Standards (AUSs) or Auditing Guidance Statements (AGSs) where it is appropriate.

## Appendix A

### Extracts from Relevant Legislation

#### Auditor-General Act 1997

#### PART 4 - MAIN FUNCTIONS AND POWERS OF THE AUDITOR-GENERAL

##### Division 1- Statement audits

###### Agencies

11. The Auditor-General's functions include auditing financial statements of Agencies in accordance with the *Financial Management and Accountability Act 1997*.

###### Commonwealth authorities and subsidiaries

12. The Auditor-General's functions include auditing financial statements of Commonwealth authorities and their subsidiaries in accordance with the *Commonwealth Authorities and Companies Act 1997*.

###### Commonwealth companies and subsidiaries

13. The Auditor-General's functions include auditing financial statements of Commonwealth companies and their subsidiaries in accordance with the *Commonwealth Authorities and Companies Act 1997*.

##### Division 2 - Performance audits

###### Agencies

15.(1) The Auditor-General may at any time conduct a performance audit of an Agency.

(2) As soon as practicable after completing the report on the audit, the Auditor-General must:

- (a) cause a copy to be tabled in each House of the Parliament; and
- (b) give a copy to the responsible Minister.

(3) For the purposes of this section, an Agency is taken not to include any persons who are employed or engaged under the *Members of Parliament (Staff) Act 1984* and who are allocated to the Agency by regulations for the purposes of the definition of Agency in section 5 of the *Financial Management and Accountability Act 1997*.

###### Commonwealth authorities and subsidiaries

16.(1) The Auditor-General may at any time conduct a performance audit of a Commonwealth authority (other than a GBE), or of any of its subsidiaries.

(2) The Auditor-General may conduct a performance audit of a Commonwealth authority that is a GBE, or of any of its subsidiaries, if the responsible Minister, the Finance Minister or the Joint Committee of Public Accounts and Audit requests the audit. The Finance Minister is to consult with the responsible Minister before making a request.

(3) Nothing prevents the Auditor-General from asking a responsible Minister, the Finance Minister or the Joint Committee of Public Accounts and Audit to make a particular request under subsection(2).

(4) As soon as practicable after completing the report on an audit under this section, the Auditor-General must:

- (a) cause a copy to be tabled in each House of the Parliament; and
- (b) give a copy to the responsible Minister.

**Commonwealth companies and subsidiaries**

17.(1) The Auditor-General may at any time conduct a performance audit of a Commonwealth company (other than a GBE), or of any of its subsidiaries.

(2) The Auditor-General may conduct a performance audit of a wholly owned Commonwealth company that is a GBE, or of any of its subsidiaries, if the responsible Minister, the Finance Minister or the Joint Committee of Public Accounts and Audit requests the audit. The Finance Minister is to consult with the responsible Minister before making a request.

(3) Nothing prevents the Auditor-General from asking a responsible Minister, the Finance Minister or the Joint Committee of Public Accounts and Audit to make a particular request under subsection(2).

(4) As soon as practicable after completing the report on an audit under this section, the Auditor-General must:

- (a) cause a copy to be tabled in each House of the Parliament; and
- (b) give a copy to the responsible Minister.

(5) In this section:

*wholly-owned Commonwealth company* has the same meaning as in the *Commonwealth Authorities and Companies Act 1997*.

**General performance audit**

18.(1) The Auditor-General may at any time conduct a review or examination of a particular aspect of the operations of the whole or part of the Commonwealth public sector, being a review or examination that is not limited to the operations of only one Agency, body or person.

(2) As soon as practicable after completing the report on an audit under this section, the Auditor-General must:

- (a) cause a copy to be tabled in each House of the Parliament; and
- (b) give a copy to the Finance Minister.

(3) The Auditor-General may give a copy of the report to any other Minister who, in the Auditor-General's opinion, has a special interest in the report.

(4) In this section:

*Commonwealth public sector* means Agencies, Commonwealth authorities (other than GBEs) and their subsidiaries and Commonwealth companies (other than GBEs) and their subsidiaries.

**Division 4****Auditing standards**

24. The Auditor-General must, by notice in the *Gazette*, set auditing standards that are to be complied with by persons performing any of the following functions:

- (a) an audit referred to in Division 1 or 2;
- (b) an audit under Division 2 of Part 7;
- (c) an audit under section 56 of the *Financial Management and Accountability Act 1997*.

**PART 7 - AUDIT OF THE AUSTRALIAN NATIONAL AUDIT OFFICE****Division 2 of Part 7****Audit of annual financial statements**

44.(1) After preparing the annual financial statements for the Audit Office under section 49 of the *Financial Management and Accountability Act 1997*, the Auditor-General must give the statements to the Independent Auditor.

(2) The Independent Auditor must audit the statements in accordance with section 57 of the *Financial Management and Accountability Act 1997*. For this purpose, references in that section to the Auditor-General are to be read as references to the Independent Auditor.

#### **Performance audit**

45.(1) The Independent Auditor may at any time conduct a performance audit of the Audit Office.

(2) After preparing a proposed report on an audit, the Independent Auditor must give a copy of the proposed report to the Auditor-General. If the Auditor-General gives written comments to the Independent Auditor within 28 days after receiving the proposed report, the Independent Auditor must consider those comments before preparing a final report.

(3) As soon as practicable after completing the report on the audit, the Independent Auditor must:

- (a) cause a copy to be tabled in each House of the Parliament; and
- (b) give a copy to the responsible Minister.

#### **Financial Management and Accountability Act 1997**

##### **Audit of annual financial statements of Agency**

57.(1) As soon as practicable after receiving financial statements under subsection 49(1) for an Agency, the Auditor-General must examine the statements and report in accordance with this section to the Minister responsible for the Agency.

(2) In the report, the Auditor-General must state whether, in the Auditor-General's opinion, the financial statements:

- (a) have been prepared in accordance with the Finance Minister's Orders; and
- (b) give a true and fair view of the matters required by those Orders.

If the Auditor-General is not of that opinion, the Auditor-General must state the reasons.

(3) If the Auditor-General is of the opinion that failing to prepare the financial statements in accordance with the Finance Minister's Orders has a quantifiable financial effect, the Auditor-General must quantify that financial effect and state the amount.

(4) If the Auditor-General is of the opinion that the Chief Executive has contravened section 48, the Auditor-General must state particulars of the contravention.

(5) If the Auditor-General is of the opinion that the Auditor-General did not obtain all necessary information and explanations, the Auditor-General must state particulars of the shortcomings.

(6) Instead of preparing a single report, the Auditor-General may prepare an initial report and one or more later supplementary reports.

(7) A copy of the financial statements and the Auditor-General's report or reports must be included in the Agency's annual report that is tabled in the Parliament.







- (1) the company appoint as auditor for the purposes of section 327 of the *Corporations Law* a person who is a member (or associate member) of either the Institute of Chartered Accountants, the National Institute of Accountants or the Australian Society of Certified Practising Accountants, or a person who holds the educational qualifications to be a member or associate member of one of the foregoing institutions;
- (2) apart from the foregoing, the provisions of s 324 of the *Corporations Law* continue to apply to the company;
- (3) the Annual General Meeting of the company each year this relief remains in force passes an ordinary resolution that the company not appoint a registered company auditor as auditor for that year;
- (4) for each year this relief remains in force there is a statement in the following form in the Directors' Report of the company:

The Australian Securities Commission has granted relief from the audit requirements of the *Corporations Law* for the Bread of Life Ministries Limited to appoint an auditor who is not a registered company auditor. The Australian Securities Commission will withdraw this relief on reasonable cause put to it by a member or members of the company. The Australian Securities Commission can be contacted at:







- any organisation representing veterans, Australian mariners, members of the Forces, members of the Peacekeeping Forces or their dependants;
- the Repatriation Commission; and
- any person having expertise in a field relevant to the investigation.

The Repatriation Medical Authority will hold its first meeting for the purposes of the investigation on **29 May 1998**.

Under the *Veterans' Entitlements Act 1986*, the RMA is required to find out whether there is a new body of sound medical-scientific evidence about varicose veins, particularly in relation to prolonged standing and straining while standing. Therefore, persons and organisations wishing to make a submission should obtain from the RMA Secretariat (at the address and phone number below) a copy of the *RMA Submission Guidelines*.

All submissions must be in writing and received by the Authority at the address below no later than **1 May 1998**.

### Citation

1. This Declaration may be cited as the Spectrum Re-allocation Declaration No.1 of 1998.

[NOTE: This Declaration commences on gazettal: see *Acts Interpretation Act 1901*, ss.46A and 48.]

### Interpretation

2. In this Declaration:

*the Act* means the Radiocommunications Act 1992.

### Spectrum Re-allocation

3. (1) The part of the spectrum from 31 GHz to 31.3 GHz is subject to re-allocation under Part 3.6 of the Act in relation to the re-allocation period:



(2) For the part of the spectrum mentioned in subsection (1), this Declaration applies for the whole of Australia.

(3) For subsection (1), the re-allocation period:

- (a) begins on 2 February 1998 ; and
- (b) ends on 2 February 2003.

(4) For subsection 153B (5) of the Act, the re-allocation deadline for this Declaration is 31 December 2000.

(5) The part of the spectrum mentioned in subsection 91) may be re-allocated only by issuing spectrum licences under Subdivision B of Division 1 of Part 3.2 of the Act.

(6) The frequency band mentioned in subsection (1) includes the higher number but does not include the lower number.

I, WILLIAM PATRICK DEANE, Governor-General of the Commonwealth of Australia, acting on the recommendation of the Prime Minister and under regulation 5 of the Civilian Service Medal 1939-1945 Regulations:

- (a) revoke the nominations made by the Instrument of Nomination dated 25 March 1997; and
- (b) nominate, as civilian organisations service in or with which is service in relation to which the Civilian Service Medal 1939-1945 may be awarded, the civilian organisations specified in Schedule 1; and
- (c) subject to paragraph (d), nominate, as civilian organisations service in or with which is service in relation to which the Civilian Service Medal 1939-1945 may be awarded, the civilian organisations specified in Schedule 2; and
- (d) specify, as members of an organisation nominated in paragraph (c) who are to be regarded as being excluded from its membership for the purpose of determining who served in or with the organisation for the purposes of regulation 6, persons whose service in or with that organisation did not include service, for a period, or periods, of service meeting the requirements of regulation 6, that is of a kind, or of kinds, specified in Schedule 2 as qualifying service in relation to that organisation; and
- (e) declare that a reference in Schedule 2 to "the Darwin area" is a reference to the area of the Northern Territory north of latitude 14 degrees, 30 minutes south.
