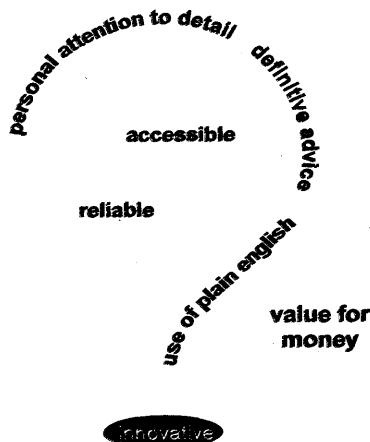

Pursuant to Clause 13.4 of the Great Barrier Reef Marine Park—Cairns Section Zoning Plan, Clause 14A.4 of the Great Barrier Reef Marine Park—Central Section Zoning Plan and Clause 15A.4 of the Great Barrier Reef Marine Park—Mackay/Capricorn Section Zoning Plan, the Great Barrier Reef Marine Park Authority hereby:

- a) designates the application of special management provisions to the Fisheries Experimental Areas described in Schedule 1;
- b) states that the special management provision as specified in Schedule 2 applies to the Fisheries Experimental Areas in Schedule 1; and
- c) states that the special management provision applies from and including 29 March 1998 to and including 28 March 2003.

- (b) the area enclosed by the 500 metre line encircling Liff Reef (reef 20–296) located at, or about, latitude 20°31.1' south, longitude 150°14.4' east;

**Great Barrier Reef Marine Park—Mackay/Capricorn Section:**

- (a) the area enclosed by the 500 metre line encircling the unnamed reef (reef 21–124) located at, or about, latitude 21°15.6' south, longitude 151°07.8' east;

**SCHEDULE 2**  
**(PROVISION FOR THE USE OF AND ENTRY TO THE FISHERIES EXPERIMENTAL AREAS)**

Despite any other use or entry allowed under the zoning plans for the Great Barrier Reef Marine Park Cairns, Central and Mackay/Capricorn Sections, the Fisheries Experimental Areas described in Schedule 1 may not be used or entered for fishing (except trolling for pelagic species).

**Strict penalties apply for fishing in the areas described in Schedule 1 during the specified period.**



NOTIFICATION pursuant to subsection 73(7) of the *National Health Act 1953* of registration as a registered health benefits organisation.

- a. Name of Organisation: MEDIBANK LIMITED
- b. Date of Registration: 1 March 1998
- c. This Registration is subject to Conditions set out in PART VI of the *National Health Act 1953*
- d. This Registration is also subject to other Conditions as determined pursuant to paragraph 73BA(1) of the *National Health Act 1953* as follows:
  - (i) the organization will not enter into a refund agreement as defined as Part VII of the National Health Act or become an agent of a party to a refund agreement for the purposes of the refund agreement;
  - (ii) the organization will keep a record, in a form approved by the Secretary, of the names and addresses, being addresses last known by the organization of all members of the organization who were and have continued to be parties to refund agreements with registered organizations;
  - (iii) the organization will ensure that members can readily ascertain all details of their entitlements to benefits and that new members are automatically provided with such information;
  - (iv) the organization will not, without prior approval of the Secretary, enter into an agency or re-insurance arrangement with a person or a body conducting health insurance business but not registered under the National Health Act;
  - (v) the organization will not, in determining, in relation to any contributor included in a class or kind of contributors -
    - (a) whether or not benefits are payable in accordance with any table not being part of an applicable benefits arrangement;
    - (b) if benefits are payable in accordance with such a table of the organization - the amount of benefits so payable;
    - (c) the amount of benefits payable in respect of such a table of the organization,have regard to any of the following matters:
    - (e) the suffering by the contributor, or a dependent of the contributor, from a chronic disease, illness or medical condition of a particular kind;

- (f) the age of the contributor or of a dependent of the contributor;
  - (g) the frequency of the rendering of professional services to the contributor or to a dependent of the contributor;
  - (h) the amount, or extent, of the benefits to which the contributor becomes, or has become, entitled during a period.
- (vi) the organization will permit any contributor to contribute for benefits in accordance with any table or product, subject to any other requirements contained in its rules or the National Health Act
- (vii) the organization will include on a State by State basis details of all tables of benefits or products in a brochure. The brochure will also advise the existence of and contact details for the Private Health Insurance Complaints Commissioner. Such a brochure shall be freely available and on display at any of its offices or outlets to any contributor or to any member of the public who is eligible to become a contributor.
- (viii) the organization's rules relating to the payment of an ancillary health benefit, in respect of services of the kind referred to in the definition of "relevant health services" in subsection 67(4) of the National Health Act 1953, will not require a contributor or a dependant of a contributor to obtain a referral from a medical practitioner, or for a medical practitioner to order such services.
- (ix) for each table the organization will:
- (a) charge all memberships consisting of the contributor, and two or more other persons, where two or more of the persons covered by the policy are not dependent children, the same premium.
  - (b) charge all memberships consisting of the contributor and one or more dependent children, the same premium.
  - (c) charge all memberships consisting solely of the contributor, the same premium.
  - (d) charge all memberships consisting of the contributor and one other person who is not a dependent child of the contributor, the same premium.

"Dependent child" in relation to this condition means a person:

- (a) who is covered by the policy; and
- (b) whom the health fund that issued the policy accepts as a dependent child for the purposes of the policy;

but does not include:

- (c) a person who is the spouse or partner of another person; or
- (d) a person (other than a full-time student) who is 18 years of age or older; or
- (e) a full-time student who is 25 years of age or older.

- (x) whenever the organization amends its rules such that a detrimental material change is made to the scope, level or amount of benefits payable to members, or such that the premiums payable by members are increased, the fund will advise the affected contributors in writing and will send a copy of such advice to the Secretary.

### SUNGLASSES AND FASHION SPECTACLES

### CONSUMER PRODUCT SAFETY STANDARD

I, WARREN ERROL TRUSS, Minister for Customs and Consumer Affairs, pursuant to section 65E (1) of the *Trade Practices Act 1974*, hereby:

- a) REVOKE the consumer product safety standard in respect of sunglasses and fashion spectacles published in Gazette Notice No. GN 31 of 11 August 1993;
- b) REVOKE the amendment to the consumer product safety standard in respect of sunglasses and fashion spectacles published in Gazette Notice No. GN 8 of 26 February 1997; and
- c) DECLARE that:
  - I. In respect of each of the goods specified in Division 1 of the Schedule to this Notice, the standard approved by the Standards Association of Australia specified in Division 2 of the Schedule, as varied by the variations specified in Division 3 of the Schedule, is a consumer product safety standard for the purposes of section 65C of the *Trade Practices Act 1974*.
  - II. This standard will expire on 31 December 2002.

### THE SCHEDULE

#### **Division 1: Particulars of Goods**

Sunglasses and fashion spectacles having lenses of nominally zero refractive power, including sunglasses and fashion spectacles of the one-piece or visor type, and clip-on sunglasses, but not including -

- (1) glasses for special use, including glasses for use while target shooting, which do not primarily provide protection against sunglare or radiation from natural sunlight in the circumstances specified in clauses 1.3.7.2 and 1.3.7.3 of Australian Standard 1067.1-1990;
- (2) goggles which are held in position by means of a strap passing around the rear of the head;
- (3) glasses which, in industrial environments, provide protection from radiation other than solar radiation or from physical impact; and
- (4) glasses for use as toys and clearly and legibly labelled as toys.



## Division 2: The Standard

Australian Standard 1067.1-1990 "Sunglasses and fashion spectacles Part 1: Safety requirements" as amended by Amendment 1 of December 1990, and Amendment 2 of July 1993.

## Division 3: Variations


Australian Standard 1067.1-1990 as referred to in Division 2 is varied as follows:

- (1) Deleting clause 1.1 entirely;
- (2) Modifying clause 2.2.1 (b) by deleting the full stop and adding the words:  

"except in the case of children's sunglasses. Children's sunglasses with frames too small for measurement from 32mm from the centreline of the frame shall be measured at six selected points within a circle of 30mm diameter around the datum centre of each lens.";
- (3) Modifying clause 2.2.1 (c) by deleting the full stop and adding the words:  

"except in the case of children's sunglasses. Children's sunglasses with frames too small for measurement from 32mm from the centreline of the sunglass shall be measured from a point 25% of the width of the lens measured on either side of the centreline which lies in the horizontal plane that would bisect the eyes when the visor is worn and at six selected points within a circle of 30mm diameter centred on these points";
- (4) Modifying clause 4.2.1 by deleting from the second sentence the words "classification of the eyewear and other relevant";
- (5) Modifying clause 4.2.2 by deleting the box around the markings specified for fashion spectacles;
- (6) Modifying clause 4.2.3 by deleting the words "the marking for general purpose sunglasses shall be as follows" and deleting the box and the words contained in the box;
- (7) Modifying clause 4.2.4 by deleting the boxes around the markings specified for type (a) and type (b) specific purpose sunglasses.

### **PR-95: Field test of pineapple plants modified to control flowering and ripening**

**Organisation proposing release:** The University of Queensland  
Brisbane QLD 4072

**Organism to be released:** Pineapple (*Ananas comosus* (L.) Merrill) cultivar Smooth Cayenne

**Purpose of the release:** The aim of the trial is to study the propensity of genetically modified pineapple plants to produce natural flowering and to ascertain the speed of ripening of the fruit. Ultimately, the proponent's aim is to develop pineapple plants with improved flowering and ripening characteristics that would allow a reduction in harvesting costs.

**Brief description of the nature and effect of the genetic modification:** The modified pineapple plants have two internal genes suppressed. These genes encode two different forms of the enzyme S-adenosyl-L-methionine methylthioadenosine-lyase (ACC synthase), which is responsible for the time of flowering and the speed of ripening. This has been achieved by cloning the appropriate genes from pineapple and then reintroducing these genes into the plant. The transgenic pineapple plants, therefore, have extra copies of these genes.

The transgenic plants also contain a selectable marker gene conferring resistance to the herbicide chlorsulfuron.

**Location and size of trial:** A total of 2,200 plants in an area of 0.1 hectare at Redlands Horticultural Research Station, Cleveland, Queensland.

**PR-96: Field evaluation of transgenic lines of field pea (*Pisum sativum* L.)  
for resistance to Ascochyta blight**

**Organisation proposing release:** CSIRO Division of Plant Industry

**Organism to be released:** Field pea (*Pisum sativum* L.)

**Purpose of the release:** The aim of the trial is to determine if two new varieties of transgenic field pea offer any resistance to attack from the fungal disease Ascochyta blight (also known as 'black spot'). Currently there are no commercial pea lines resistant to this disease.

**Brief description of the nature and effect of the genetic modification:** Two lines of transgenic field pea will be trialled. The first contains a gene from radish (*Raphanus sativus*) encoding a protein (RsAFP2) normally found in radish seeds. The second line contains a gene from grape (*Vitis vinifera*) encoding the stilbene synthase enzyme. This enzyme causes a compound called resveratrol, which is normally found in grapes and wine, to be produced in the leaves of the transgenic field peas. Both of these compounds have been shown in test tube experiments to prevent the growth of the fungus that causes Ascochyta blight.

Both transgenic field pea lines also contain a selectable marker gene encoding resistance to the herbicide Basta.

**Location and size of trial:** Up to 100 plants of each line at the Agricultural Research Station, Medina, Western Australia.

**PR-97: Genetically enhanced subterranean clover expressing sunflower seed albumin**

This feeding trial will determine the potential of the high-sulfur clover to support more efficient wool growth in sheep.

**Brief description of the nature and effect of the genetic modification:** Three genes have been inserted into a commercial cultivar of subterranean clover. Two of the genes encode a protein, sunflower seed albumin, which is rich in sulfur-containing amino acids, and is resistant to breakdown in the rumen of sheep. It is expected that this protein will improve the nutritional quality of subterranean clover, particularly with regard to wool growth in sheep.

The third gene is a selectable marker gene conferring resistance to the antibiotics kanamycin and neomycin.

**Location and size of trial:** A total of 9,000 plants in an area of 100 square metres at the Agriculture Western Australia Research Station, Medina, Western Australia.

#### **PR-49X(2): Production of genetically engineered lupin seeds expressing sunflower seed albumin**

**Organisation proposing release:** CSIRO Division of Plant Industry

**Organism to be released:** Narrow leaf lupin (*Lupinus angustifolius*)

**Purpose of the extension to the release:** The purpose of the trial is to produce enough transgenic, high methionine lupin seed to use in a sheep-feeding trial. The sheep-feeding trial aims to test the prediction that sheep fed the high methionine lupins will produce more wool than sheep fed the parental lupin variety.

**Brief description of the nature and effect of the genetic modification:** Three genes have been inserted into narrow leaf lupin plants. The first gene encodes a sunflower seed protein that is rich in sulfur-containing amino acids, and is resistant to breakdown in the rumen of sheep. It is expected that this protein will improve the nutritional quality of the lupin seeds, particularly with regard to wool growth in sheep.

The other two genes are marker genes that enable identification and selection of the transgenic plants. One of the genes encodes resistance to the herbicide Basta, and the other gene encodes an enzyme,  $\beta$ -glucuronidase, which enables visual identification of transgenic plant tissues.

**Location and size of trial:** Approximately 800,000 plants in an area of approximately 2 hectares at the Agriculture Western Australia field station at Wongan Hills, Western Australia.

**PR-51X(3): Bt agronomic selection and yield trials 1998-1999**

**Organisation proposing release:** Deltapine Australia Pty Ltd

**Organism to be released:** Cotton (*Gossypium hirsutum*)

**Purpose of the extension to the release:** The aim of this extension is to continue the agronomic evaluation of breeding lines of transgenic cotton modified for resistance to insect pests, including the evaluation of yield and fibre characteristics of advanced crossbred selections. The cotton plants in this trial are derived from backcrossing donor parent cotton lines which contain the introduced genes with elite cotton varieties using traditional plant breeding methods. The use of insect-resistant cotton plants has the potential to reduce the use of chemical pesticides on cotton crops.

**Brief description of the nature and effect of the genetic modification:** The genes introduced into the cotton plants are the CryIA(c) and CryIIA genes from the bacterium *Bacillus thuringiensis*. The plants contain one or both of the genes. These genes produce proteins that are toxic to certain caterpillars (and mosquitoes in the case of the CryIIA protein), including the major caterpillar pests that attack cotton. The presence of more than one insecticidal gene in a single plant is part of a long-term strategy for management of insect resistance to the insecticidal proteins.

In addition to the insecticidal genes, the plants contain a selectable marker gene that confers resistance to the antibiotics kanamycin and neomycin.

**Location and size of trial:** 8 hectares at each of 10 sites in the Emerald Irrigation Region, Theodore/Biloela Irrigation Area, Darling Downs, St George Irrigation Area, Gwydir Valley, Namoi Valley, Liverpool Plains, Macquarie Valley, Bourke Irrigation Area and Lake Tandou. There will also be 20 hectares at a site in the MacIntyre Valley.

**Organism to be released:** Cotton (*Gossypium hirsutum*)

**Purpose of the extension to the release:** This extension to the original proposal will continue the agronomic evaluation of cotton lines which have been modified for tolerance to the herbicide glyphosate (Roundup®). The cotton plants in this trial are derived from backcrossing donor parent cotton lines which contain the introduced genes with elite cotton varieties using traditional plant breeding methods. Commercial cotton cropping requires the application of large amounts of herbicide for weed control. It is intended that the incorporation of Roundup® tolerance into cotton plants will allow direct application of Roundup® over growing crops, thus providing more effective weed control.

**Brief description of the nature and effect of the genetic modification:** The cotton plants have been modified to contain the 5-enolpyruvyl shikimate-3-phosphate synthase (EPSPS) gene from *Agrobacterium*. This gene confers tolerance to the herbicide glyphosate, the active ingredient of Roundup®. In addition, the plants contain a selectable marker gene that confers resistance to the antibiotics kanamycin and neomycin.

**Location and size of trial:** 50 hectares at each of 11 sites in the Emerald Irrigation Region, Theodore/Biloela Irrigation Area, Darling Downs, St George Irrigation Area, Gwydir Valley, Namoi Valley, Liverpool Plains, Macquarie Valley, Bourke Irrigation Area, Lake Tandou and Murrumbidgee Irrigation Area. There will also be 62 hectares at a site in the MacIntyre Valley.

**PR-59X: Field evaluation of a transgenic line of field pea (*Pisum sativum* L.)  
with enhanced grain sulfur levels**

**Organisation proposing release:** CSIRO Division of Plant Industry

**Organism to be released:** Field pea (*Pisum sativum* L.) cultivar Bohatyr

**Purpose of the extension to the release:** The aim of this extension is to evaluate the agronomic performance of a new cultivar of transgenic pea in the field, to measure the level of the sulfur-rich sunflower protein in its seeds, and to generate sufficient seeds for animal feeding trials. The transgenic field peas have been modified for improved nutritional quality by raising the level of sulfur-containing amino acids in their seeds using a sulfur-rich sunflower seed protein. Although pea seeds are an important component of stockfeed mix, they are not a good source of essential sulfur-containing amino acids.

**Brief description of the nature and effect of the genetic modification:** A gene encoding a sunflower (*Helianthus annuus*) seed protein that is rich in sulfur-containing amino acids has been introduced into field pea. The genetically modified peas produce this new protein in their seeds. In addition, the transgenic field peas contain a selectable marker gene from the bacterium *Streptomyces hygroscopicus* encoding phosphinothricin acetyl transferase, which confers resistance to the herbicide Basta.

**Location and size of trial:** 4,500 plants in an area of 150 square metres at the Agricultural Research Institute, Wagga Wagga, NSW.

been modified for tolerance to the herbicide glyphosate (Roundup<sup>®</sup>), as well as lines expressing the Roundup<sup>®</sup>-tolerance gene in combination with a gene conferring resistance to insect attack. The cotton plants in this trial are derived from backcrossing donor parent cotton lines which contain the introduced genes with elite cotton varieties using traditional plant breeding methods. The long-term goal of the work is to develop new commercial cotton cultivars which are resistant to Roundup<sup>®</sup> and/or insect damage. It is intended that use of the herbicide-tolerant cotton will permit more effective control of weeds in cotton crops, while the insect-resistance trait has the potential to reduce the amount of insecticide applied to cotton crops.

**Brief description of the nature and effect of the genetic modification:** The cotton plants have been modified to contain the 5-enolpyruvyl shikimate-3-phosphate synthase (EPSPS) gene from *Agrobacterium*. This gene confers tolerance to the herbicide glyphosate, the active ingredient of Roundup<sup>®</sup>. Some cotton lines will also contain a gene encoding CryIA(c), an insecticidal protein from the bacterium *Bacillus thuringiensis*, which confers tolerance to the major insect pests of cotton. In addition, the plants contain a selectable marker gene that confers resistance to the antibiotics kanamycin and neomycin.

**Location and size of trial:** 46 hectares at each of 11 sites in the Emerald Irrigation Region, Theodore/Biloela Irrigation Area, Darling Downs, St George Irrigation Area, Gwydir Valley, Namoi Valley, Liverpool Plains, Macquarie Valley, Bourke Irrigation Area, Lake Tandou and Murrumbidgee Irrigation Area. There will also be 52 hectares at a site in the MacIntyre Valley.

#### **GR-6: Field evaluation of transgenic lines of peas with resistance to pea weevil**

**Organisation proposing release:** CSIRO Division of Plant Industry  
GPO Box 1600

**Organism to be released:** Field pea (*Pisum sativum* L.)

**Brief description of the nature and effect of the genetic modification:** Pea weevil is one of two major insect pests in peas that cause major losses in pea production each year. The modified peas which are proposed for release contain a gene that confers resistance to attack by pea weevil (*Bruchus pisorum*). The gene codes for a protein (an  $\alpha$ -amylase inhibitor) found in the seeds of the common bean (*Phaseolus vulgaris*). In addition, the peas also contain a selectable marker gene, which codes for phosphinothricin acetyltransferase from the soil bacterium *Streptomyces hygroscopicus*, and which confers resistance to the herbicide Basta.

## **GR-7: Field evaluation of bromoxynil-tolerant subterranean clover**

**Organism to be released:** Subterranean clover (*Trifolium subterraneum*)

**Brief description of the nature and effect of the genetic modification:**

Subterranean clover has a moderate level of natural tolerance to the broadleaf herbicide bromoxynil. However, the tolerance of the clover to the herbicide is limited and the concentrations of bromoxynil required for weed control also cause significant yield losses in the subterranean clover.

The genetically modified subterranean clover which is proposed for release contains a gene from a soil bacterium encoding a nitrilase enzyme that breaks down bromoxynil. These transgenic plants, therefore, have an increased tolerance to bromoxynil. A selectable marker gene encoding resistance to the antibiotic spectinomycin is also present in the transgenic plants.



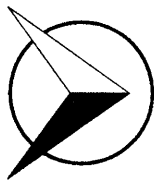



"**banana season**" means the period commencing at 2200 UTC on 31 March in a year and ending at 0230 UTC on 15 June in the same year;

"**distinguishing mark**" in relation to a form of logbook, means the marking by which the logbook can be distinguished from AFMA's other forms of logbook;

"**NP10 Trawl Log**" means the form of logbook published by AFMA in February 1997 which provides for 16 daily entries per page and for which:

- (a) the title is "Northern and Torres Strait Prawn Fisheries Confidential Daily Fishing Log"; and

- (b) the distinguishing mark is "NP10";

"**NP10A Trawl Log**" means the form of logbook published by AFMA in February 1997 which provides for 7 daily entries per page and for which:

- (a) the title is "Northern and Torres Strait Prawn Fisheries Confidential Daily Fishing Log"; and

- (b) the distinguishing mark is "NP10A";

"**NP11 Trawl Log**" means the form of logbook published by AFMA in March 1998 which provides for 16 daily entries per page and for which:

- (a) the title is "Northern and Torres Strait Prawn Fisheries Confidential Daily Fishing Log"; and

- (b) the distinguishing mark is "NP11";

**"NP11A Trawl Log"** means the form of logbook published by AFMA in March 1998 which provides for 7 daily entries per page and for which:

- (a) the title is "Northern and Torres Strait Prawn Fisheries Confidential Daily Fishing Log"; and
- (b) the distinguishing mark is "NP11A";

**"Northern Prawn Fishery area"** has the same meaning as it has in the Northern Prawn Fishery Management Plan 1995;

**"NWS02 Trawl Log"** means the form of logbook published by AFMA in February 1997, for which the title is "Australian North-West Slope Confidential Daily Fishing Log" and the distinguishing mark is "NWS02";

**"SLR01 Return"** means the form of logbook published by AFMA in February 1997, for which the title is "Seasonal Recording of Landings - Banana Season" and the distinguishing mark is "SLR01";

**"SLR02 Return"** means the form of logbook published by AFMA in February 1997, for which the title is "Seasonal Recording of Landings - Tiger Season" and the distinguishing mark is "SLR02";

**"tiger season"** means the period commencing at 0800 UTC on 1 August in a year and ending at 2230 UTC on 30 November in the same year; and

**"UTC"** means Coordinated Universal Time, the time scale based on the second (SI), maintained by the International Bureau of Weights and Measures. For the purposes of this direction UTC is equivalent to mean solar time at the prime meridian (0 degrees longitude), formerly expressed in Greenwich Mean Time (GMT).

[Note: Terms defined in the *Fisheries Management Act 1991* and the Fisheries Management Regulations have the same meanings in this determination.]

### Which logbooks must be used?

4.1 If any kind of fish, including prawns, bugs, scallops and squid but excluding scampi, are taken by any method of trawling using an Australian boat in the Northern Prawn Fishery area the following forms of logbook must be used to record information about the taking of the fish:

- (a) from 1 April 1998 - in respect of the banana season, the SLR01 Return and in respect of the tiger season, the SLR02 Return;
- (b) from 1 April 1998 until the end of 31 December 1998 - any of the NP10 Trawl Log, the NP10A Trawl Log, the NP11 Trawl Log or the NP11A Trawl Log; and
- (c) from 1 January 1999 - either of the NP11 Trawl Log or the NP11A Trawl Log.

[Note: The NP11 Trawl Log replaces the NP10 Trawl Log. The NP11A Trawl Log replaces the NP10A Trawl Log. The period from 1 April 1998 until the end of 31 December 1998 is the changeover period when either form of each logbook can be used.]

4.2 If scampi is taken by any method of trawling using an Australian boat in the Northern Prawn Fishery area, the NWS02 Trawl Log must be used to record information about the taking of the scampi.

4.3 If any kind of fish is taken by a boat using any method of trawling in the North West Slope Trawl Fishery, the NWS02 Trawl Log must be used to record information about the taking of the fish.

**When must the logbooks be used?**

5. Subregulations 33(1), 33(2) and 33(3) of the Fisheries Management Regulations apply in respect of:

- (a) the NP10 Trawl Log and the NP10A Trawl Log during the period beginning on 1 April 1998 and ending at the end of 31 December 1998; and
- (b) the NP11 Trawl Log, the NP11A Trawl Log, the SLR01 Return, the SLR02 Return and the NWS02 Trawl Log during the period beginning on 1 April 1998 and ending at the end of 1 April 2000.

6. Copies of the NP11 Trawl Log, the NP11A Trawl Log and the NWS02 Trawl Log can be obtained from the Australian Fisheries Management Authority at either:

- (b) 64-66 Tingira Street, Portsmith, CAIRNS QLD 4870 - during ordinary business hours on Mondays, Tuesdays and Fridays.
