Section 1

1 Name of order

This order is the *Acts Interpretation (Substituted References) Order 1998*.

2 Commencement

This order commences on 12 November 1998.

3 Definition

In this order:

provision means a provision in an Act or in an instrument under an Act.


I, ROBERT MURRAY HILL, Minister for the Environment and Heritage, having considered comments as required by subsection 9B(3) of the *Wildlife Protection (Regulation of Exports and Imports) Act 1982* (the Act) and having taken into account advice from the Designated Authority on those matters specified in subsection 10A(5) of the Act, hereby declare specimens of the Class Holothuroidea (beche-de-mer, trepang, sea cucumber) to be 'controlled specimens' for the purposes of subsection 10A(2) of the Act, subject to the following conditions:

1. Specimens are to be taken in waters adjacent to the Northern Territory only, in accordance with the provisions of the Northern Territory *Fisheries Act 1988* and associated regulations;
2. Except where the conditions of this declaration provide contrary requirements, operation of the fishery will be carried out in accordance with the document entitled "Commercial harvesting of species of Holothuroidea from waters adjacent to the Northern Territory" dated 28 July 1998 and produced by the Department of Primary Industry and Fisheries, Fisheries Division, Northern Territory;
3. The following species specific minimum sizes will apply:

for all other sea cucumber species will be as agreed between the Northern Territory Department of Primary Industry and Fisheries and the Designated Authority.

 - a six monthly report on total catch (number of specimens and wet weight) and catch per unit effort, by species, area and month for the half year ending December to be submitted by 31 March; and
 - an annual report to be submitted by 31 October 1999 and 30 September 2000 incorporating an overall assessment of the fishery including, but not limited to, compliance issues, research, market details, progress in development of conservation management models for the trepang fishery and amendments of trepang logsheets, and review of the progress in achieving the objectives of the management arrangements.
5. This declaration is valid from 1 October 1998 until 30 September 2000.

4.2 If:

- (a) during a period while a pelagic longline is set in the water from an Australian boat:
 - (i) in the Australian fishing zone - any kind of fish is taken by any method other than pelagic longlining using the boat; or
 - (ii) in the high seas zone - Southern Bluefin Tuna is taken by any method other than pelagic longlining using the boat; or
- (b) the fish referred to in paragraphs (a) (i) and (ii) above are disposed of;

the AL04 Daily Log must be used to record information about the taking and disposal of fish.

Purse Seining or Poling

5. When:

- (a) any kind of fish is taken by purse seining or poling from an Australian boat in the Australian fishing zone; or
- (b) Southern Bluefin Tuna is taken by purse seining or poling, using an Australian boat in the high seas zone; or
- (c) the fish referred to in paragraphs (a) and (b) above are disposed of;

the following forms of logbook must be used:

- (d) if the fish are taken by purse seining:

- (i) if they will not be transferred to a farm - the TPB02 Purse Seine & Pole Log must be used to record information about the taking and disposal of the fish; and
 - (ii) if they will be transferred to a tow cage and later to a farm - the TPB03 Purse Seine & Pole Log - Farm Only must be used to record information about the taking of the fish;
- (e) if the fish are taken by poling:
- (i) if they will not be transferred to a farm - either the OT03 Other Methods Log or the TPB02 Purse Seine & Pole Log must be used to record information about the taking and disposal of the fish; and
 - (ii) if they will be transferred to a tow cage and later to a farm - the TPB03 Purse Seine & Pole Log - Farm Only must be used to record information about the taking of the fish.

Handlining, trolling or other rod and reel fishing methods**6. When:**

- (a) any kind of fish is taken by handlining, trolling or other rod and reel fishing methods, using an Australian boat in the Australian fishing zone; or
- (b) Southern Bluefin Tuna is taken by handlining, trolling or other rod and reel fishing methods, using an Australian boat in the high seas zone; or
- (c) the fish referred to in paragraphs (a) and (b) above are disposed of;

the OT03 Other Methods Log must be used to record information about the taking and disposal of the fish.

Southern Bluefin Tuna - disposal and tow cages

7.1 When Southern Bluefin Tuna, taken by any method using an Australian boat in the Australian fishing zone or the high seas zone is disposed of, the following forms of logbook must be used:

- (a) if they will not be transferred to a tuna farm - the CR4 SBT Log must be used to record information about the sale or disposal of the fish; and
- (b) if more than one vehicle is used to carry the fish from the boat to the first person who receives them after they have been landed - the CR5 SBT Transit Form must be used to record information about the carrying of the fish from the boat to the first receiver of the fish; and
- (c) if they will be transferred to a tuna farm - the SBT04 Farm Catch Disposal Record must be used to record information about the sale or disposal of the fish.

7.2 When Southern Bluefin Tuna that has been taken with the use of an Australian boat is, in the Australian fishing zone:

- (a) placed in a tow cage towed by the boat; or
- (b) transhipped from the boat to a tow cage towed by another boat; or
- (c) a subsequent transfer of the tow of the tow cage to another boat occurs;

the SBT03 Farm Transit Log must be used to record information about the carrying of the fish or the transshipping and subsequent carrying of the fish, including in each case fish mortality.

Transshipment of Skipjack Tuna

8. When Skipjack Tuna is transhipped to or from an Australian boat in the Australian fishing zone, the SKT01 Transshipment Record must be used to record information about the transshipping of the fish.

**PART 3 - APPLICATION OF THE FISHERIES MANAGEMENT
REGULATIONS TO LOGBOOKS**

9. Subregulations 33(1), 33(2) and 33(3) of the Fisheries Management Regulations apply in respect of: the AL04 Daily Log, the CR4 SBT Log, CR5 SBT Transit Form, the OT03 Other Methods Log, the TPB02 Purse Seine & Pole Log, the TPB03 Purse Seine & Pole Log, the SBT03 Farm Transit Log, SBT04 Farm Catch Disposal Record and the SKT01 Transshipment Record during the period beginning on 1 December 1998 and ending at the end of 30 November 2001.

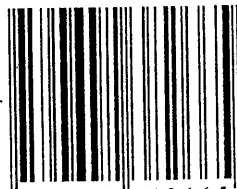

1 Name of determination

This determination is the *Social Security (Meaning of Seasonal Work) Determination 1998*.

2 Commencement

This determination commences on gazettal.

3 Definition

In this determination:

Act means the *Social Security Act 1991*.

4 Meaning of seasonal work

- (1) For the purposes of the Act, work performed by a person in any of the following major groups of occupations classified in the Australian Standard Classification of Occupations, Second Edition, published for the Australian Bureau of Statistics, when performed as intermittent work, is seasonal work:
 - (a) managers and administrators;
 - (b) professionals;
 - (c) associate professionals;
 - (d) tradespersons and related workers;
 - (e) clerical, sales and service workers;
 - (f) production and transport workers;
 - (g) labourers and related workers.
- (2) The work must be performed by a person who has been engaged:
 - (a) to do a specific project or task; or
 - (b) for a period the length of which was known with a reasonable degree of certainty when the person was engaged; or

Section 5

(c) to do work that is affected by regular shutdowns.

Example of regular shutdowns

Shutdowns for the Christmas season or for regular maintenance.

5 Exceptions

Section 4 does not apply to:

- (a) work performed by a person who gains entitlements, related to the number of days worked, to:
 - (i) leave; or
 - (ii) payment, at the end of the engagement, instead of leave; and
- (b) work mentioned in paragraph 4 (2) (a) or (b) that a person has performed for 12 months or longer.

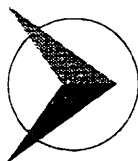

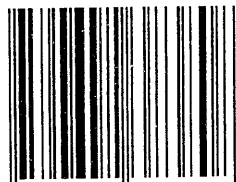
