NOTICE OF DECISION TO GRANT A PERMIT UNDER THE HAZARDOUS WASTE (REGULATION OF EXPORTS AND IMPORTS) ACT 1989

Pursuant to Section 33 of the Hazardous Waste (Regulation of Exports and Imports) Act 1989, notice is given that on 31 December 1999 a permit was granted to TREDI Australia Pty Limited, Level 6, 3 Smail Street, Broadway, New South Wales 2007 to export up to 100 tonnes of nickel-cadmium batteries for recycling/reclamation of metals and metal compounds at SNAM Viviez, BP4 Avenue Jean Jaurés, 12110 Viviez, France.

The batteries are to be loaded into containers to be transported to the ports of Melbourne or Sydney, then loaded onto a ship to be offloaded at Antwerp, Belgium and transported to the recovery facility in Viviez, France. The waste will transit through South Africa and Belgium.

The export would take place in up to four (4) shipments between 31 December 2000 and 31 May 2000.

A person or persons whose interests are affected by this decision may, within 28 days, make an application in writing to the Environment Protection Group of the Department of the Environment requesting the reasons for the decision.

An application for independent review of the decision may be made to the Administrative Appeals Tribunal on payment of the relevant fee by the applicant within 28 days of receipt of the reasons for the decision, or within 28 days of this notice if the reasons for the decision are not sought.
